The University of the Philippines Center for Integrative and Development Studies (UP CIDS) is the University of the Philippines System's policy research unit which aims to address problems of national significance by employing an integrative and collaborative approach in its policy research work. This is carried out by utilizing and maximizing the expertise and resources available to the University.

UP CIDS was founded by the late UP President Edgardo J. Angara in 1985 and has since then been guided by the following objectives and functions as stated in his Executive Order No. 9 dated September 24, 1985:

- Develop, organize, and manage research issues of national significance. Such issues, because of their importance and inherent complexity, require an integrative and collaborative approach and also more sophisticated research methodologies and skills;
- Encourage and support research and study on these issues by various units of the University and individual scholars;
- Secure funding from public and private persons and agencies; and

Ensure that the research outputs and recommendations of the Center are published and openly disseminated.

The UP Strategic Plan 2017–2023 provides further guidance to the Center's activities by stressing the University's role in (a) contributing to national development through knowledge creation and public service, and (b) promoting access and diversity through enhancing structures and policies for collaboration and undertaking internationalization efforts.

#### **Research Programs**

The UP CIDS adopts a programmatic structure wherein a sizeable network of scholars is brought together and maintained under a Research Program through which they can pursue a common research agenda and build their academic, industry, and policy networks relevant to their research work. By supporting several Research Programs, the UP CIDS is also able to provide opportunities for and encourages collaboration between and among them. Such an arrangement does not only enable the Center to address critical and long-standing national issues, it further allows the

UP CIDS to accommodate research on new and emerging international and national policy concerns.

carry out its role and provide guidance and assistance on various matters.



### Continuing Efforts During the COVID-19 Pandemic


The research and administrative activities of the UP CIDS has continued despite the persistence of the COVID-19 pandemic. While challenges with remote work arrangements continue and processes at the UP System remain unpredictable at times, internal efforts have made it possible for the Center to carry on with its work.

The UP CIDS Research Programs, after having earlier assessed and adjusted their research agenda in light of the pandemic, were able to hold meetings and even host forums and conferences online in lieu of face-to-face research activities. Online work and collaborative platforms facilitated new COVID-19 related research efforts of the Programs. The restrictions to mobility and prohibition of face-to-face activities also encouraged UP CIDS Programs to focus on finalizing outputs from previous research projects and activities. The Programs, in coordination with the Publications Unit, were thus able to publish research outputs during the pandemic.

The Core Staff was also key in setting up online platforms through which UP CIDS Research Programs can remotely communicate and carry out research activities. Efforts taken by the Core Staff include requesting for UP Mail accounts and coordinating with the UP Information Technology Development Center (UP ITDC) for access to webinar features in the online video conferencing platform Zoom. Aside from these, the standardization of internal administrative, finance, and publications processes was also pursued in response to changes of procedures and practices at the level of the UP System.

The Education Research Program (ERP) aims to contribute to the deeper understanding of education delivery and implementation in the Philippines. In addition, the Program seeks to understand the influence of educational reforms in the last decade on student learning and teacher competencies. Finally, it seeks to nurture a community of scholars who conduct research on education.

In the second half of 2020, the ERP's studies focused on literacy and multiliteracy development. Areas of research that were started in the first half of 2020, such as impact studies of the Senior High School Program, were continued. Additionally, a research partnership with the University of Oxford and the University of the Philippines on supporting oral language development among early learners was commenced and formally recognized through a signing ceremony.

The content of the ERP's intended research was modified to include issues that have arisen and emerged in the education sector due to the COVID-19 pandemic. Areas of curriculum, assessment, learning delivery, teacher development, school leadership, and governance concerns have adapted to the present conditions that are characterized by the enforcement of health protocols

such as quarantine, social distancing, and avoidance of mass gatherings. To adjust to the pandemic, the ERP revised some of its research projects and has focused on the development of publications, while exploring alternative platforms for its other activities.

during the second half of 2020, data gathered from the field trials with Kindergarten to Grade 3 learners were analyzed using the classical test theory and Rasch modelling.

#### K to 12 and Senior High School (SHS) Studies

The SHS studies aim to investigate questions related to the four (4) components of the SHS program: learners; curriculum implementation; financing and partnerships; and teacher/continuing professional development.

#### TalkTogether: A UK Research and Innovation Global Challenges Research Fund (UKRI GCRF) Project

This three-year research project in collaboration with the University of Oxford focuses on supporting oral language development among early learners. It is divided into several studies, namely the Corpus Study, Age of Acquisition Study, Assessment Study, Co-Production Study, Intervention Study, Mapping Study, and Classroom Ethnography Study. Research team leads and members for each study were organized to work on their own review of related studies and research protocols, which take into consideration the challenges imposed by the COVID-19 pandemic.

### Indigenous Peoples (IP) Voices and Multilingual Education

The ERP's research strand on Indigenous Peoples (IP) Voices and Multilingual Education aims to study language use and appreciation in indigenous peoples communities. Research under this strand was based on the data gathered from focus group discussions with elders and interactive activities with learners from the Agta-Dumagat community of Gen. Nakar, Quezon; Iraya Mangyan community of San Teodoro, Oriental Mindoro; and Ayta Mag-indi community of Porac, Pampanga.

#### **Teacher Professional Development**

Supported by the Human Capital and Education for Asian Development (HEAD) Foundation, the project on the use of Learning Action Cell (LAC) to improve the teaching-learning process in science, technology, engineering, and mathematics (STEM) has produced data on teachers' content knowledge in several Grade 6 Science topics and their experiences in handling LAC in their respective schools. Research papers are currently being written by partners from the UP Integrated School (UPIS) and the UP National Institute for Science and Mathematics Education Development (UP NISMED) based on the gathered data.

#### Bayanihan E-Skwela

August 16, 2020

The Office of the Vice President of the Philippines launched a project called Bayanihan E-Skwela, which aims to support teachers and parents for remote and distance learning during the COVID-19 pandemic. One of the video learning materials for the project, titled "What to Expect: Education in the New Normal," was developed by the ERP together with Prof. Margaret Mary Rosary Carmel Fua and Dr. Joel Javiniar of the UP College of Education and Brigitte Anne Limbo of De La Salle Philippines.

#### **Words in the World International Conference**

October 16 to 18, 2020

Prof. Portia Padilla of the UP College of Education presented the paper titled "English Loan Words in Filipino Children's Literature: Implications for Cross-Linguistic Literacy Development" at the virtual edition of Words in the World (WoW) International

Conference held in October 2020. The paper was co-authored with Dr. Dina Ocampo and Kathrina Lorraine Lucasan of the ERP and Dr. Sonali Nag of the University of Oxford. The data for the presentation were harvested from the corpus study done for the TalkTogether project. The conference was organized by the Social Sciences and Humanities Research Council of Canada.

#### **VALIDATION AND FINALIZATION**

### UKRI GCRF TalkTogether Corpus Study: Filipino Parts-of-Speech Tags

November to December 2020

The Corpus Study group of the TalkTogether project conducted the validation and finalization of the parts-of-speech (POS) tags generated by the Stanford POS Tagger for Filipino developed by Matthew Phillip Go and Nicco Nocon of De La Salle University. Junette Fatima Gonzales of the ERP, Prof. April Perez of the UP Departamento ng Filipino at Panitikan ng Pilipinas, Prof. Francisco Rosario, Jr. of the UP Department of Linguistics, and Prof. Crizel Sicat-de Laza of the UP College of Education served as first-round validators, while Dr. Mary Ann Bacolod of the UP Department of Linguistics served as second-level validator.

# Upcoming Activities and Outputs for 2021

For the first half of 2021, studies slated for 2020 that were delayed due to the COVID-19 pandemic will be continued. Possible partnerships with the UP College of Education and the UP Integrated School for policy research on topics based on the ERP research agenda are also being considered.

#### **UKRI GCRF TalkTogether Project**

The international partnership for the TalkTogether project will also continue with studies on age of acquisition, coproduction, and assessment commencing within the first half of the year.

In addition, the Philippines will host the project's annual international meeting in January 2021. The virtual meeting will be attended by partners and stakeholders of the project from the University of Oxford (United Kingdom), The Promise Foundation (India), Georgia University (United States), the UP College of Education, and the ERP (Philippines). Moreover, partnerships with the Reading Association of the Philippines (RAP), Asian Regional Network on Early Childhood (ARNEC), and the Early Childhood Care and Development (ECCD) Council

of the Philippines will be forged for the study. The preparation and submission of documents for ethics review of the assessment and feasibility studies will also be done during the first half of the year, in coordination with the Ethics Research Committee of the University of Oxford.

#### **Conferences and Fora**

ERP Research Fellow Prof. Margaret Mary Rosary Carmel Fua, will present the paper "Assessing Filipino and English Literacy Skills of Kindergarten to Grade 3 Filipino Children" at the Association for Reading and Writing in Asia (ARWA) Conference in March 2021. Dr. Dina Ocampo, Kathrina Lorraine Lucasan, Donna Pamella Romero, and Joesal Jan Marabe will serve as co-presenters. The paper utilizes data from the field trials of the assessment tools from the Multi-Literacy Assessments for Filipino Children which have been conducted from November 2019 until March 2020.

Another edition of the ERP's Sipat Edukasyon research dissemination forum and a webinar featuring the UP CIDS Education and Capacity Building Cluster is scheduled in 2021.

#### **New Research Projects**

A research project on disinformation studies in education will be conducted with Dr. Lorina Calingasan and Dr. Sharehann Lucman of the UP College of Education's Social Studies Education Department in 2021. This aims to understand and explain disinformation and

its effects on education outcomes. Moreover, surveys on the experiences of teachers and students about remote learning during the COVID-19 pandemic will be conducted as an extension to the ERP's studies on flexible learning options (FLOs) and use of information and communications technology (ICT).

# Activities from July to December 2020

#### CONSULTATION

Virtual Roadshow with the Philippine Association of Colleges and Universities

August 6, 2020

The HERPR held an online consultation with Philippine Association of Colleges and Universities (PACU) President Dr. Carol Marian S. Enriquez, wherein plans for

a compendium from the PACU's webinars on web and internet protocol (IP) security and a manual for HEIs on responding to the COVID-19 pandemic were discussed. Dr. Enriquez also suggested to discuss the practicality of internships in the current times and explore further the complementarity of public and private higher education.

Dr. Sobrevega-Chan shared Ateneo's public and system-wide research database and committed to sharing the HERPR's presentation at a university meeting and with other members of the AdDU Research Council.

Issues that were discussed include the dire situation of private HEIs, the realignment of budget for scholarships to make way for funds for COVID-19 response, the danger of contractual HEI workers losing their jobs, and concerns on the coverage of the Tertiary Education Subsidy (TES) Program. Ms. Mauricio likewise expressed interest in submitting manuscripts to the Program.

#### CALL FOR PAPERS

### Higher Education Interventions for the Better Normal

September 24 to December 1, 2020

The HERPR called for policy papers on interventions made by HEIs to deliver a better normal for their constituencies during and beyond the COVID-19 pandemic. The papers will become part of a pioneering collection that documents how HEIs are making sense of and moving forward against the unprecedented complexities and consequences to higher education operations brought about by the pandemic. The volume also seeks to document the context and content of pandemic-related higher education policies, as well as current and future initiatives and innovations by HEIs.

#### Virtual Roadshow with the Office of Senator Sherwin Gatchalian

November 11, 2020

The HERPR also held an online consultation session with the Office of Senator Sherwin Gatchalian through Education Policy Team Head Ms. Kat Adiente and Policy Analyst Mr. Adnan Ahmad. They discussed how research and writing lead to the drafting and filing of bills to the Senate. They also committed to submitting a policy brief on the thinking that goes into process of crafting HElrelated Senate bills in early 2021.



The Assessment, Curriculum, and Technology Research Program (ACTRP) is a joint research program of the Assessment Research Centre (ARC) of the University of Melbourne (UoM) and the University of the Philippines (through the UP CIDS). The ACTRP advises and informs the Philippine education system as major curricular reforms are being rolled out by the Department of Education (DepEd).

The ACTRP has remained true to its mandate of advising and informing the Philippine system of education through curriculum, teaching, and assessment research that is based on empirical studies of curriculum innovation and implementation. The Program has provided research and technical assistance not only to the DepEd, but also to the Senate and House Committees on Basic Education, the Commission on Higher Education, and the Basic Education Forum, a multi-sectoral body supporting the DepEd's efforts of providing quality and relevant basic education for all. While the conduct of the Program's research activities had become challenging due to mobility restrictions brought about by the pandemic, new ways of engaging stakeholders through online platforms and more research areas and opportunities have emerged.

Most of the activities for the second half of 2020 focused on the completion of the review of the K to 12 curriculum, as well as providing support to the DepEd through teacher training on basic video production and enhancing formative assessment in self-learning modules and through building the assessment competence of school supervisors. Other projects conducted during this period include a feasibility study on micro-certification for the Alternative Learning System (ALS) and a baseline study on language match and teacher assignment in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

# Activities from July to December 2020

#### **TRAINING**

### **Basic Video Production Training for Teachers** July 15 to 31, 2020

In collaboration with the DepEd Bureau of Learning Delivery (BLD) and Bureau of Learning Resources (BLR) and the UP College of Education, the ACTRP conducted online training on basic video production as part of the preparation for DepEd's distance learning modality. There were 82 participants in the online training, composed of 65 teachers from sixteen regions and 17 personnel from the DepEd Central Office.

#### **TRAINING**

#### Professional Development Modules on Building Assessment Competence for Regional, Division, and District Supervisors

September 2020

Six professional development modules were developed and delivered by the ACTRP to support the DepEd National Capital Region (NCR) in improving the assessment competence of their supervisors. The modules were meant to build the supervisors' capacity

to shift assessment from simply giving tests and grades to a process that would help learners and allow teachers to use assessment to improve learning. The professional development activity was completed in three weeks, with more than 300 participants attending every session. This initiative was conducted in partnership with the Philippine Business for Social Progress (PBSP).

#### **MEETINGS**

#### Stakeholders' Consultation Meetings for the Feasibility Study on Micro-certification for the ALS

September to October 2020

The ACTRP, in collaboration with the United Nations International Children's Emergency Fund (UNICEF), the DepEd-ALS Task Force, and the ARC of the University of Melbourne, held ten virtual consultation meetings with various stakeholders, agencies, and organizations to explore the applicability and feasibility of microcertification for the Alternative Learning System in the Philippines. Through these meetings, the project team was able to gather ideas for the pilot study, including a proposal to certify life skills of ALS learners and identification of potential challenges in implementing a micro-certification system for the ALS.

#### **FORUM**

#### Stakeholder Forum for the Baseline Study on Language Match and Teacher Assignment in the BARMM

November 9, 2020

The ACTRP held an online stakeholder forum to present the initial results of and gather expert advice for its Baseline Study on Language Match and Teacher Assignment in the BARMM. The study investigates the language match and teacher assignment aspects of the Mother Tongue-Based Multilingual Education (MTB-MLE) as implemented in the nine schools division offices of the BARMM. Language education and research experts from various organizations offered their comments and suggestions to improve the study. National, regional, and division officials from the DepEd and BARMM's Ministry of Basic, Higher, and Technical Education also shared their thoughts on and realizations from the study.

#### **ORIENTATION**

#### Developing Support Materials for Self-Learning Module Writers

December 16, 2020

The ACTRP has started developing a guide for selflearning module (SLM) writers that will be released in parts to assist the DepEd in enhancing teachers' ability to write formative assessment items and tasks. The learning resource produced by the ACTRP, titled "How to Enhance Formative Assessment in Self-Learning Modules: A Guide for Writers" has three parts: Fundamentals, Formative Assessment Basics, and Advanced Formative Assessment. The orientation for the first part (Fundamentals) was conducted for 8,047 DepEd participants, 720 of which are SLM writers.

# Upcoming Activities and Outputs for 2021

### Feasibility Study on Micro-certification for the ALS

Three (3) workshops will be conducted from February to March 2021 for the development of the assessment framework to measure two capabilities of ALS learners, namely communication skills and teamwork and cooperation. Orientation and training sessions, scheduled in March, will inform ALS focal persons, district supervisors, and mobile teachers about the objectives and methodology of the pilot study. They will

also be trained on how to use the assessment materials related to the two capabilities that will be assessed.

Pilot study data will be collected from four regions (NCR, Region IV-A, Region XI, and Region XII) in April 2021, while post-pilot consultation meetings with different stakeholder groups will be held in June 2021.

#### **Technical Assistance to the DepEd**

Based on the review of the intended, implemented, tested, and attained K to 12 curriculum, the ACTRP will submit the recommendations for the enhancement of the curriculum and provide technical assistance to the DepEd.

#### COVID-19 Response Project on Enhancing Formative Assessment in Self-Learning Modules

The training modules and workshops on Formative Assessment Basics and Advanced Formative Assessment will be offered in April and May of 2021.

#### Baseline Study on Language Match and Teacher Assignment in the BARMM

With the finalization and acceptance of the Baseline Study on Language Match and Teacher Assignment in the BARMM, the researchers will present the detailed findings and recommendations for the implementation of the MTB-MLE in the region to officials of the BARMM Ministry of Basic, Higher, and Technical Education.

#### Assessment Professional Development for DepEd Junior High School Teachers and Supervisors

Based on its research on formative assessment, the ACTRP will conduct training on building assessment competence for junior high school teachers and supervisors as part of the DepEd's interventions in view of the Programme for International Student Assessment (PISA) 2022.



#### The Program on Data Science for Public Policy (DSPP)

has three objectives. The first is to build the capacity of University of the Philippines (UP) faculty in data science towards application in public policy and governance. The second is to engage a community of researchers within the university and encourage the pursuit of interdisciplinary problem-oriented research using high-level quantitative analyses. The final objective is to convene multidisciplinary teams of social scientists, humanists, and natural scientists to conduct research on issues in the public sector.

Despite the continuing effects of the COVID-19 pandemic, the Program was able to continue its research activities and pursue opportunities for capacity building. The DSPP continued its engagement with the UP Data Science Working Group which proceeded with its review of data science degree program proposals from various UP constituent universities (CUs). Executive-level meetings were also held in order to map all the University's data science activities. The working group also serves as an avenue for updates on recent advancements in technology and on the various COVID-19-related efforts of the UP CUs. The Program likewise continued its involvement in the Data Science Para sa Bayan (DSPB) initiative.



#### **TRAINING**

#### **Digital Citizen Science Training Program**

November to December 2020

The pilot of the Digital Citizen Science Training Program was conducted in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) from November to December 2020. This program is a joint initiative of the

UP Mindanao Department of Mathematics, Physics, and Computer Science, the UP CIDS DSPP and EMIT C4C, the Institute of Peace and Development in Mindanao of the Mindanao State University-Iligan Institute of Technology (MSU-IIT), the DSPB Initiative, the Community Wireless and Power Corporation, and the Partnership Resource Center of the Rotterdam School of Management. An online workshop was conducted to identify the skills gap and other needs of students and provide an overview of the current landscape of digital technology and of the labor market from the perspective of industry players.

#### **MEETING**

### Executive-Level UP Data Science Working Group Meeting

November 24, 2020

UP President Danilo L. Concepcion called for a meeting with academic heads and executive-level stakeholders of the UP Data Science Working Group to map the University's future plans in boosting its information infrastructure for the big data computing needs of its researchers and scientists. This meeting laid out the plans to integrate efforts towards strengthening data science capabilities and setting up of facilities and supercomputers to cater to fields of data science such as big data analytics and cloud computing.

#### Rethinking the Transformations in Public Policy and Governance in the Next Normal

November 27, 2020

This webinar series is organized by the Philippine Public Policy Network (PPPN), with the DSPP providing logistical support for the first webinar. 



The broad objective of the Digital Citizen Science Training Program is to stimulate the partnership of various societal actors—policymakers, business, the academe, and communities—in order to jointly address the complex and systemic challenges facing our world today. It aims to build the skills of young citizen scientists, both to catalyze positive change in

their respective communities, and to prepare them for productive employment.

The Program on Escaping the Middle-Income Trap: Chains for Change (EMIT C4C) examines inclusiveness and competitiveness in its research and societal efforts. It undertakes three projects through *inclusive science*: big data analytics on manufacturing and exports, action research on agriculture and fisheries value chains, and action research on business for peace. Inclusive science provides learning and partnering spaces for the academe, government, civil society, and the private sector to share lessons from development efforts.

From July to December 2020, the EMIT C4C recalibrated its research projects given restrictions due the C0VID-19 pandemic. In consultation with its key partners, the Program refocused its efforts mainly to the creation of a data lake for evidence-based decision-making and to the writing of policy blogs on various development issues that were surfaced by the pandemic.



# Upcoming Activities and Outputs for 2021

The EMIT C4C will continue its efforts to publish the findings from its past and ongoing research projects and to work with its partners in the development of knowledge products. Efforts will also be made to put into place organizational structures for the data lake initiative and to engage with other partners on potential action research initiatives.

The Program intends to finalize its case study on Kapunungan sa Gagmay'ng Mangingisda sa Concepcion (KGMC) and to present the findings to KGMC and the Peace and Equity Foundation (PEF) in March 2021. It also intends to hold an online discussion and presentation of new action research findings to various partners including farmers and fisherfolks organizations, local governments, and private foundations by May 2021. The EMIT C4C also plans to hold a forum on manufacturing, decent work, and disruptions brought about by the pandemic which is tentatively scheduled in June 2021.

Moreover, the Program intends to submit two articles to the *Philippine Journal of Public Policy* (PJPP) and a monograph based on the KGMC case study.



The Political Economy Program (PEP) seeks to advance innovation-driven and equitable development through the conduct of problem-solving research on development policies and practice; the promotion of collaboration among the academe, government, industry, and other stakeholders in pursuit of inclusive technology and sustainable industrial policy; and the popularization of the political economy framework in the national conversation on policy options.

In order to gain a deeper understanding of the COVID-19 pandemic's impact on Philippine economy and society, the PEP launched four research projects focusing on vulnerable sectors. These projects offer policy recommendations for both short- and long-term recovery.

In addition to its research projects, the PEP continued its engagement with the United Nations Conference on Trade and Development (UNCTAD), the Department of Foreign Affairs (DFA), and other stakeholders for the Fifteenth Session of the UNCTAD (UNCTAD XV), which was rescheduled to October 2021. It also participated in a preparatory forum that tackled the pandemic's impact to global trade and development and to the reframing of the UNCTAD negotiations.

#### **Research Projects**

#### Rebuilding Micro, Small, and Medium Enterprises (MSMEs) in the Time of the Pandemic and Beyond

Led by Prof. Rolando Ramon Diaz of the UP Institute for Small-Scale Industries (UP ISSI), this project focuses on the impact of the pandemic on micro, small, and medium enterprises, which compose 99.5% of all business establishments in the country and were among the most affected sectors. It looks into the disruptions to the sector, including financial losses

and operational challenges, and measures for both immediate assistance and long-term recovery. These include improvements to existing financial assistance initiatives and regulatory frameworks and the creation of an enabling environment for innovation of business models.

### Policy Reforms in Social Protection and Labor Market Systems Beyond COVID-19

This project led by Dr. Emily Christi Cabegin of the UP School of Labor and Industrial Relations (UP SOLAIR) focuses on the impact of the COVID-19 pandemic on informal sector workers. It examines and identifies gaps in existing social protection programs, which are largely limited to regular employment in the formal sector, and proposes more inclusive long-term measures. These cover improvements on programs on social assistance and insurance, capacity building, and the labor market.

### Enabling Philippine Agriculture to Address Pandemics

Led by Darlene Dolly Alegado-Cruz, this project focuses on the impact of the pandemic on Philippine agriculture. It also examines measures undertaken by other similarly-impacted developing countries. The study's recommendations cover improvements to the movement of agricultural commodities, support for small producers and agro-enterprises, and development of the sector to become more resilient to disruptions.

#### Waste Heat as a Clean Thermal Renewable Energy for Distributed Energy Production and Local Development in the Philippines

This project led by Dr. Menandro Berana of the UP Department of Mechanical Engineering reviews existing policies on the utilization of waste heat from industrial processes. It gives recommendations on using waste heat as a renewable energy resource for local communities.

### **Rebuilding MSMEs in the Time of the Pandemic** November 19, 2020

The PEP, in collaboration with the UP ISSI, held an online roundtable discussion on existing and proposed initiatives to assist MSMEs in recovering from the COVID-19 pandemic. Officials from government agencies such as the Department of Trade and Industry's Bureau of Small and Medium Enterprise Development, the Department of Science and Technology, and the Land Bank of the Philippines discussed the services that aim to help MSMEs. Small business owners also shared their issues and concerns. The working paper on a proposed recovery plan for the MSME sector by PEP Project Leader Prof. Rolando Ramon C. Diaz was also presented in order to solicit feedback from the study's stakeholders.

The **Program on Alternative Development (AltDev)** seeks to look at paradigms, policies, practices, and projects that are largely marginalized and excluded from the mainstream. As these challenge dominant modes, they do not figure prominently in national and international discourse. Moreover, the Program aims to bring these alternatives from the margins into the mainstream and level the playing field so that these may be regarded on equal footing with dominant discourses and thus offer alternatives to the existing system.

Despite constraints and limitations brought about by the COVID-19 pandemic, the AltDev remained steadfast in documenting and mainstreaming alternative development practices into the forefront of development discourse and policymaking. In response to the pandemic, the Program shifted its main activities online and recalibrated its targets.

Participatory research and engagement with AltDev's grassroots and community partners were conducted through remote means of communication, such as video and phone calls, online chat groups, and email. *Kumustahan* or catch-up sessions were also conducted to check both on the situation of partners and to track the progress of the participatory

documentation projects. Moreover, the AltDev's initiative on documenting alternative practices during the time of the COVID-19 pandemic has received support from international institutions and civil society organizations.

#### **Research Projects**

### Project on Alternative Practices in Southeast Asia

Due to the COVID-19 pandemic, the documentation of additional case studies of alternative practices in Southeast Asia has been limited to virtual engagement with partner organizations. The third annual conference on alternative regionalism scheduled in 2020 was cancelled. Nevertheless, AltDev researchers were able to focus their energies on completing their case studies

leading to major headways in publication. International solidarity across grassroots communities in Southeast Asia continues and even intensifies as the AltDev became the core organizer of the Convergence Space on Alternative Regionalism in the ASEAN Peoples' Forum (APF) 2020 that was hosted by the Vietnam National Organizing Committee.

# Knowledge Mobilization and Intercultural Dialogue Promoting Gender Equality and Women Empowerment in Pastolan and Magbukun Ayta Villages in Bataan, Philippines

This project aims to identify appropriate interventions in Pastolan and Magbukun Ayta communities towards the realization of sustainable, inclusive, and equitable development. In particular, the project seeks to document experiences and practices of partner communities through intercultural dialogue, leading to the institutionalization of good practices and the crafting of appropriate policies and programs that promote gender equality and empowerment of the community. Despite bureaucratic difficulties in transferring funds to project partners and the limited mobility of project implementers due to the community quarantine, this project has been completed within the year.

# Upcoming Activities and Outputs for 2021

## Data Gathering on the Labor Movement in the Philippines

In addition to the rich collection of alternative practices, the AltDev will continue its analysis of the issues confronting the labor movement in the Philippines. The Program will be conducting in-depth interviews with key informants on their various struggles. A case to be studied in the project are the experiences of workers in export processing zones in Cebu and Cavite in combining unionism with engagements with global brands in Southeast Asia. The Program will also document the responses of the labor movement to the perennial problem of contractualization and to the impact of the COVID-19 crisis. The case studies will be presented in a webinar and in an online conference.

### **Lawan 2021 Social Media Project**

With the enthusiasm and warm reception of AltDev's social media project in 2020, the Program hopes to continue using digital platforms via Lawan: Alternative Grassroots Narratives in Southeast Asia to disseminate information and raise awareness on its activities, projects, and outputs. The generation and production of content will still be through a community-led participatory approach where partner communities themselves conceptualize and co-produce audiovisual materials in the form of photo essays and vlogs. While Facebook, Twitter, and Youtube will remain as the primary platforms for Lawan, possible expansion to other platforms will be explored.

### 3rd Southeast Asian Conference on Alternatives

Due to the pandemic, the 3rd Southeast Asian Conference on Alternatives scheduled in 2020 was cancelled. This 2021, the AltDev plans to conduct the conference virtually. The online conference will

present new case studies of alternative practices in the Philippines and in Southeast Asia. It will also have breakout sessions aimed at crafting plans for strengthening linkages among partner communities and for establishing a regional network as anchor of the envisioned alternative model of peoples' integration.

### The Program on Health Systems Development (PHSD)

houses work that investigates problems and innovates solutions for health systems in the country. While this mission inevitably applies scientific rigor to the *parts* of health systems, the goal is to improve the *whole* in terms of overall performance and outcomes. Its flagship project is the Philippine Primary Care Studies (PPCS), which aims to strengthen primary care systems and monitor the impact of health system reform in urban/corporate, rural, and remote settings.

Due to the increasing cases of COVID-19 in the country, the PPCS continued its employment of teletriage and telemedicine in all of its study sites in Samal (Bataan), Bulusan (Sorsogon), and the UP Health Service (UP Diliman). Trainings for site staff are continuously being conducted via video conferencing; however, connectivity issues affect the promotion of telemedicine in the Bulusan site in general.

The Samal site ended their service delivery network (SDN) private partner engagements last December 2020 as their funding from the Philippine Health Insurance Corporation (PhilHealth) was already consumed. Meetings with local health officials on possible funding for 2021 are currently being conducted.



The PHSD/PPCS's plans for the next six months include (1) the continuous monitoring of the eight outcome areas in the three study sites; (2) the preparation for the Year 2 surveys scheduled on the second quarter of 2021; (3) submission of progress reports to stakeholders; (4) writing workshops and dissemination of the results from the Year 1 surveys; (5) publication of the completed papers; (6) improvement of the EMR in all three sites;

and (7) community engagements and information dissemination on primary care through different platforms.

Due to the continuing pandemic, site monitoring is still limited to telephone and online meetings. The Year 2 surveys on patient satisfaction, EMR utilization, healthcare worker satisfaction, and community utilization will be conducted mostly through telephone or online survey forms for UPHS. If possible, face-toface surveys on the same topics will be done in the Samal and Bulusan sites on the second and third quarters of 2021, as long as strict health protocols are followed. Writing workshops will still be done online and electronic medical records are continuously being debugged and improved. Community engagements and information disseminations will be conducted through both traditional (e.g., posters, tarpaulins) and online (e.g., Facebook, YouTube) platforms in the three sites.

### The task of the **Program on Social and Political Change**

(PSPC) is to provide a platform for understanding the varied social and political challenges facing modern Philippine society and polity from a multidisciplinary perspective. The Program designs empirical studies which form the basis for policy input and discussions at the local, national, and international levels.

For the second half of 2020, the PSPC reshaped its focus and took on projects and activities examining the impact of the COVID-19 pandemic on Philippine society and polity, the new problems it introduced, and the existing issues it magnified. In achieving this, the Program collaborated with local and international partners, both old and new.

The PSPC and the International Institute for Democracy and Electoral Assistance (International IDEA) partnered again for an assessment on how the pandemic affected the performance of the 1987 Philippine Constitution. It was also able to generate bulletins that offer a comparative perspective on pandemic responses from around the world. Aside from the COVID-19 crisis, the Program also tackled in its activities local issues such as the problems confronting the peoples of Mindanao and the role of the youth in democracy.



# Upcoming Activities and Outputs for 2021

### **Projects and Activities**

As the effects of the pandemic will continue to be felt by Filipinos, the PSPC's work on understanding the social and political challenges it has brought will likewise proceed in the first half of 2021. As such, the PSPC and International IDEA will be updating the findings of the Constitutional Performance Assessment of the 1987 Philippine Constitution and the Constitutional Performance Assessment in the Time of a Pandemic projects.

The PSPC also plans to organize webinars which will expand discussion on topics including as the State of the

Nation Address (SONA), the Local Government Code of 1991, the war on drugs, and labor migration. The Program also plans to conduct two (2) roundtable discussion series for the same period.

From January to June 2021, the PSPC will be partnering with the National Research Council of the Philippines (NRCP) to produce a compendium of research works and policy advisories generated by the NRCP since its inception in 1933 up to the present. This endeavor aims to document NRCP's scientific research outputs and the social and government policies that emanated from these.

### **Outputs**

The updated findings of the Constitutional Performance Assessments on the 1987 Philippine Constitution will be made available through a series of policy briefs to be co-published by the UP CIDS and International IDEA. Meanwhile, the papers from the joint project of the PSPC and the Department of the Interior and Local Government-National Capital Region (DILG-NCR) will be published as a peer-reviewed book titled Responsible Local Governance, Decentralization, and Equitable Development in the Philippines: Policy Research for Metro Manila.

Other prospective outputs from the Program include the report from the Democracy Talks in Manila webinar and three (3) discussion papers and/or forum proceedings.



The Islamic Studies Program (ISP) seeks to advance the critical and strategic role of Islam in nation-building to move communities toward a deeper understanding and appreciation of Islam and to establish appropriate responses to Islamophobia.

The Program's primary research components are the Historical and Islamic Knowledge for the Modern Age (HIKMA) project; research on Shari'ah courts and the Code of Muslim Personal Laws of the Philippines; and The Moro Story, which covers topics such as the Philippine madrasah system, Islamic art, countering violent extremism, and the transition to the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), among others.

In the second half of 2020, the ISP continued its research projects on Philippine Muslim arts and traditional crafts, peace building through history education, the BARMM transition, and preventing and countering violent extremism (PCVE) in the Philippines. It was also able to continue its book project on Islam in the Philippines.

As a response to the COVID-19 pandemic, the ISP explored institutional mechanisms for "the new normal" in Islamic education and for Halal institutions.

**FOCUS GROUP DISCUSSIONS** 

### Capacitating ASEAN to Address Security Issues in Southeast Asia

September 21 and 24, 2020

This research project explores the various ways that the Association of Southeast Asian Nations (ASEAN) could utilize in order to adapt to the consequences of great power competition in the region. It also aims to aid in the development of security-related policies and studies both at the national and regional level. The first phase of data gathering involved an initial investigation on minilateral arrangements through focus group discussions with Philippine government officials. The

tentative findings of the project were presented and discussed by principal researcher Rear Admiral Rommel Jude G. Ong (Ret.) at the 5th Katipunan Conference.

#### **CONFERENCE**

### **5th Katipunan Conference**

October 6, 12, 19, and 26, 2020

The Katipunan Conference is a forum where developments in the strategic environment of the Philippines and its immediate region are discussed and assessed. Carrying the theme "COVID-19 and the Strategic Environment: Change and Continuity," the fifth edition of the conference was conducted as a series of webinars focusing on regional transformations and how these impact both Philippine strategic interests, particularly questions of security, and the regional security architecture at the time of the COVID-19 pandemic. The discussions also tackled how the pandemic has accelerated the growing strategic competition between the United States and China and how a prolonged economic crisis due to COVID-19 could affect regional stability and exacerbate internal conflicts in Southeast Asia. The event was organized with the Philippine Office of Konrad-Adenauer-Stiftung in partnership with the UP Department of Political Science.

experts and academic researchers interested in strategic concerns within the University and on consolidating networks that will link this core group with government, the private sector, and international institutions. The Program will organize events that will engage issues on the strategic situation of the Philippines, research that look into the country's strategic options, and outreach activities that seek to gain wider insight on how to best institutionalize the network of stakeholders on strategic studies in the Philippines.

The 6th Katipunan Conference will move to a podcast format to enable a wider inclusion of insights from participants across the globe. Even with a new

format, the conference will continue to be a forum where developments in the strategic environment of the Philippines and the region are discussed and assessed by a roundtable of experts from multiple disciplines.

The second phase of the "Capacitating ASEAN to Address Security Issues in Southeast Asia" research project will focus on finding out if minilateralism will work in addressing issues on the South China Sea. Data gathering and analysis on the acceptability, suitability, and feasibility of a minilateral arrangement as a defense diplomact mechanism and a way to address security issues will be conducted from March to June 2021.



The **Decolonial Studies Program (DSP)** interrogates coloniality—a process that involves identifying aspects of Western modernity in postcolonial states and a critical engagement with colonial-era texts, collective memory, and the use of both colonial and local languages.

In its second year, the Program held exploratory workshops that focused on conceptualizing, planning, and doing ethical research with a decolonial frame. The intention was to strike a conversation with researchers who have done significant studies in their field to share best practices, challenges, and their vision for ethical decolonial research.

The Program planned to hold a webinar, an international conference, an academic workshop, and two (2) roundtable discussions (RTDs) in the latter half of 2020. However, due to the constraints of the pandemic and the recalibration of the Program's goals, it organized instead an exploratory workshop, a writeshop, a webinar, and an international conference. The DSP was also able to engage with more stakeholders through the Decolonial Studies Research Network (DSRN), which now has 2,000 members, and through partnerships with organizations such as PH Lab and the South South Cooperation Council and with scholars from academic institutions abroad.

Moving activities online has helped in having people who may otherwise be constrained by time, funding, or other concerns to participate in the events. The Program was also able to invite Filipino and other Asian scholars, advocates, and activists dedicated to the study of decoloniality to its workshops and more people were able to present and share knowledge in its international conference. In the future, the Program is considering hybrid (mix of online and face-to-face) events even if on-site activities becomes possible with the easing of restrictions on mobility and public gatherings.

The DSP will build on collaborations and learnings generated from the previous year in its projects and





The UP President Executive Order 9 of September 1985 includes as UP CIDS' objective the securing of funds from public and private persons and agencies in order to support its policy research activities. In line with this objective, the Education Research Program (ERP), Assessment, Curriculum, and Technology Research Program (ACTRP), the Program on Alternative Development (AltDev), the Program on Health Systems Development (PHSD), the Program on Social and Political Change (PSPC), and the Strategic Studies Program (SSP) were among the UP CIDS research programs which were able to secure and utilize external funding in 2020. For 2020, external funding actually made up more of the total research program funds compared to internal funding from the University.






### **Education Research Program (ERP)**

The ERP's external funding amounts to almost 31 percent of its total 2020 funds. The funding was provided by the UK Research and Innovation (UKRI)'s Economic and Social Research Council to support the ERP's activities for the Corpus Study and Age of Acquisition Study under the TalkTogether Global Challenges Research Fund Project.




## Assessment Curriculum and Technology Research Program (ACTRP)

In carrying out its research work for 2020, the operational expenses of the ACTRP were fully funded by (1) the University of Melbourne, through the Australian Department of Foreign Affairs and Trade; (2) the Australian Council for Education Research; and (3) Palladium Global Philippines.




### **Program on Alternative Development (AltDev)**

The AltDev sourced around 41 percent of its total 2020 funds externally. These funds were provided by (1) 11.11.11; (2) the United Nations Educational, Scientific, and Cultural Organization (UNESCO) Office in Jakarta; and (3) Rosa-Luxemburg-Stiftung (RLS) to support projects that include the documentation of alternative practices of grassroots communities in Southeast Asia; building grassroots linkages, partnerships, and solidarity; and conducting policy research in relation to the impact of the COVID-19 pandemic on grassroots organizations.




### **Program on Health Systems Development (PHSD)**

The cost to execute the main project of the PHSD, the Philippine Primary Care Studies, account for nearly 93 percent of its 2020 funding. This study was largely funded by the Philippine Health Insurance Corporation (PhilHealth), the Department of Science and Technology's Philippine Council for Health Research and Development (DOST-PCHRD), and the Department of Health (DOH)'s Advancing Health through Evidence-Assisted Decisions with Health Policy and Systems Research (AHEAD-HPSR) Program.



### **Program on Social and Political Change (PSPC)**

Forty-two percent of the 2020 funds of the PSPC were externally sourced. These were provided by (1) the International Institute for Democracy and Electoral Assistance (International IDEA) and (2) the Department of the Interior and Local Government–National Capital Region (DILG–NCR). Funds from International IDEA were utilized for the Constitutional Performance Assessment projects of PSPC. The DILG–NCR funding was used for PSPC's project on Federalism in the National Capital Region.



### **Strategic Studies Program (SSP)**

Twenty-five percent of the SSP's 2020 funds were provided by Konrad-Adenauer-Stiftung (KAS) Philippines to support (1) the development of the manuscript for the volume "Toward an Enhanced Strategic Policy in the Philippines," and (2) the 5th Katipunan Conference.
