NOTES ON THE CONTRIBUTORS

Belinda A Aquino holds a PhD (Political Science) from Cornell University, an MA (Political Science) from the University of Hawaii and a BA (English) from the University of the Philippines. An internationally recognized authority on Philippine affairs, she is a professor of political science and Asian studies at the University of Hawaii at Manoa where she is also director of the Center for Philippine Studies. She was vice-president for public affairs at the University of the Philippines in 1989-1991 and a visiting professor at the Tokyo University of Foreign Studies in 1997-1998. She hails from San Fernando, La Union.

Harold Crouch is a senior fellow of the Research School of Pacific and Asian Studies, Australian National University. He has taught at the University of Indonesia, National University of Malaysia and the University of the Philippines.

Jose Y Dalisay Jr holds a PhD in English (Creative Writing) from the University of Wisconsin-Milwaukee and teaches English at the University of the Philippines, where he is an associate professor. He has published nine books of fiction, drama, and essays, five of which have won National Book Awards from the Manila Critics Circle.
