Onofre D Corpuz is professor emeritus of economic history at the School of Economics, University of the Philippines. He holds a PhD in political economy and government from Harvard University. Dr Corpuz has written extensively on public issues and Philippine history, in addition to having held positions such as UP President and Secretary of Education.
