




### INTRODUCTION

Founded in 1985 by the late University of the Philippines (UP) President Edgardo J. Angara, the UP Center for Integrative and Development Studies (UP CIDS) is the University's policy research unit that aims to address problems of national significance by employing an integrative and collaborative approach in the conduct of studies on various aspects of public policy and harnessing the University's multidisciplinary expertise and expansive resources.

Based on then-UP President Angara's Executive Order No. 9 issued on September 24, 1985, UP CIDS has the following objectives and functions:

- Develop, organize, and manage research issues of national significance. Such issues, because of their importance and inherent complexity, require an integrative and collaborative approach and also more sophisticated research methodologies and skills:
- Encourage and support research and study on these issues by various units of the University and individual scholars;
- Secure funding from public and private persons and agencies; and
- Ensure that the research outputs and recommendations of the Center are published and openly disseminated.

UP CIDS is likewise guided by UP's Strategic Plan 2017-2023 and contributes to the University's thrust of (a) contributing to national development through knowledge creation and public service, and (b) promoting access and diversity through enhancing structures and policies for collaboration and undertaking internationalization efforts.


### RESEARCH PROGRAMS



### **Core Staff**

The Core Staff of the UP CIDS facilitates and supports the administration, finance, documentation, and dissemination of the projects and activities of theCenter's Research Programs. The UP CIDS Core Staff coordinates with UP System offices and the UP CIDS Research Programs to effectively carry out its role and provide guidance and assistance on various matters.

The Core Staff is headed by the UP CIDS Executive Director and is housed in the UP CIDS Administrative Office. They are functionally organized into (1) Administration, (2) Finance, (3) Publications, and (4) Library and Resources.

### POLICY RESEARCH AND NATION-BUILDING IN A TIME OF PANDEMIC

UP CIDS pursued its commitment to producing relevant policy research amid the pandemic. The examination of COVID-19-related issues and concerns continued to be undertaken in the Center's Program research endeavors and other activities. These studies were also embedded in previous policy research the Programs embarked on based on their respective mandates. In relation to this, the last installment of its "Philippine Public Policy in a Time of Pandemic: Confronting the COVID-19 Challenge" webinar series, "Making Our Way Back to the Classroom," was held last September 8, 2021. This was sponsored by the following UP CIDS Programs: Education Research Program (ERP), the Higher Education and Policy Reform Program (HERPRP), and the Assessment, Curriculum, and Technology Research Program (ACTRP).

Given the upcoming May 2022 elections. UP CIDS is a cosponsor of the initiative of the Office of the Chancellor, UP Diliman: the "#PILIpiLUNAS2022: Pabangon at Pagsulong Tungo sa Magandang Buhay Bukas" webinar series. The Center's Program on Political Economy (PEP) assisted in establishing the secretariat for its Task Force on a Blueprint for Building the Nation. This endeavor has two major activities: (1) agenda-building consisting of a series of roundtable discussions; and a (2) one-day policy dialogue with national political candidates, which will present a "Governance Agenda for a Sustainable, Inclusive, and Innovation-Driven Development" National emanating from the policy recommendations from the roundtable discussions (RTDs).1

In relation to this, these UP CIDS Programs organized the following #PILIpiLUNAS webinars in partnership with the UP Diliman's Office of the Chancellor, Task Force Nation-Building.

- "Balota at Pulitika sa 2022: May Bago Ba?"
   Co-organized by the Program on Social and Political Change (PSPC) (November 5, 2021);
- "Is More Power to Local Governments More Power to the People? Elections, Devolution, and the Local Government Code Three Decades After" – Co-organized by PSPC (November 26, 2021); and
- "Strategic Philippine Foreign Relations: Challenges and Prospects for 2022 and Beyond" – Co-organized by the Strategic Studies Program (SSP) (December 7, 2021)

UP CIDS also continued to pursue its digitization project. In partnership with the UP Diliman Main Library, the digitization of UP CIDS research collection began in the last quarter of 2021. This is targeted to be completed by 2022, coinciding with the launch of the Center's revamped website. Once done, this project will complete the full digitization of the Center's outputs since its establishment in 1985.

UP CIDS also continued to pursue its digitization project. In partnership with the UP Diliman Main Library, the digitization of UP CIDS research collection began in the last quarter of 2021. This is targeted to be completed by 2022, coinciding with the launch of the Center's revamped website. Once done, this project will complete

the full digitization of the Center's outputs since its establishment in 1985.

Alongside this, UP CIDS has also focused on other indexing and archiving matters of its publications. Last September 2021, the Center's in-house journal, the Philippine Journal of Public Policy: Interdisciplinary Development Perspectives (PJPP), has been given a digital object identifier (DOI). With this, all past, present, and forthcoming articles for PJPP are now more easily accessible online.

The Center also continued managing its administrative, financial, and legal records to comply with the proper records management practices in government offices. This was done by digitizing and archiving its office records. At present, UP CIDS has scanned and archived most of its inactive records, with some inactive records hailing from the 1990s and some semiactive records from 2013–2017. For 2022, UP CIDS aims to finish the remaining inactive and semiactive records and continue the archiving of the current active records from August 2017–present under the current UP CIDS Executive Director.



**ROUNDTABLE DISCUSSION** 

Child-Directed Print Corpora: Understanding the Resource

June 30-July 2, 2021

A virtual roundtable, organized by the TalkTogether team, was conducted from June 30 to July 2, 2021. ERP's convenor, Dr. Dina Ocampo, served as co-chair, together with Dr. Sonali Nag of the University of Oxford and Dr. Jelena Mirkovic of York St. John University. ERP Research Fellows Prof. Margaret Mary Rosary Carmel Fua and Dr. Portia Padilla and Research Associates Junette Fatima Gonzales and Kathrina Lorraine Lucasan also provided technical support for four studies shared during the three-day event. Prof. Fua, Dr. Padilla, and Ms. Lucasan were also among the presenters.

# UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

ERP will continue pursuing its research agenda for 2022. Ongoing projects will be continued either by continuing ongoing activities or initiating into the next phases of the research plans. The areas for continuation are in the following strands: language and literacy studies, disinformation studies, and ICT for education research

To commence are the language capture and ethnography research as well as the coproduction research which are both components of the UsapTavo extension/iteration of the TalkTogether project. Hopefully, there will be opportunities to cooperate with lower-income communities so that the research can be conducted collaboratively with select members. School Snapshots will be further conceptualized and articulated so that partner schools can participate in progressive and developmental research on school operations during the time of transition from remote learning to blended learning delivery/modalities. Another research that will require community engagement is collaborative research agenda-setting for selected IP communities. This is in response to the interest among IP leaders to sustain the partnership with ERP on education research, particularly in relation to Mother Tongue-Based Multilingual Education (MTB-MLE).

Finally, ERP will continue to produce scholarly publications based on data that are ready for analysis and writing up. These include teacher development, early literacy performance, and the assessment of literacy.

### **ACTIVITIES**

### 1. Language and Literacy Studies

a. SukatWika 2.0

The design for a study on text complexity assessment is being finalized. The study

aims to establish text parameters per grade level based not only on its textual properties but also on the reading comprehension of target readers. The parameters drawn from this step will then be used to analyze existing learner resources.

The current version of *SukatWika* will be used extensively in determining psycholinguistic properties of text per grade level. The experience gained from its use in the study will further inform the improvements and additional features slated for SukatWika 2.0.

### b. MLAF Continuation (Literacy Assessments)

In the hope of reaching more learners, the development of versions of the MLAF for remote administration (online and phone-based) will be explored and undertaken. This will prove to be useful even post-pandemic for learners in hard-to-reach areas with low technology. The current version will undergo further field-testing with a more diverse sample of learners (from private and public schools) once the health situation eases and protocols/guidelines are clearer. The development of tests for the next key stage (Grades 4 to 6) will also begin.

### c. UsapTayo

UsapTayo is the extension of the TalkTogether project. Work on oral language development as it supports literacy development among young learners will be the focus of this project. Specifically, for 2022, the development of programs for parent-teacher intervention on activities with young children will be done. The research design for the qualitative research to accompany this inquiry is also underway.

### 2. Disinformation Studies

As the production and distribution of false and malicious information online

have become more prevalent and sophisticated, ERP will conduct a free workshop for teachers titled, "Spotting Fake News Online." This will be held via Zoom on January 29, 2022. Based on the curriculum on civic reasoning formed by Stanford History Education Group, the workshop provides tools and activities to help teachers in spotting fake news online. Data gathered from this workshop will also serve as data for disinformation studies research.

### 3. Sipat Edukasyon 2022

The ERP will hold its 3rd *Sipat Edukasyon* forum in November 2022 via Zoom so that participants near and far can participate. Research papers from the various research strands of the ERP will be presented by the Research Fellows of the Program. The presentations intend to stimulate critical discussion and engage with fellow researchers on education.

### 4. ICT for Education (ICT4E) Studies

ERP aims to present ICT4E implementation in basic and higher education as reflected in UP System's research, and ways to develop ICT4E research frameworks that can lead to national policies. The journal article which examines multiple education research for directions and future legislation is being finalized.

### 5. School Snapshots: What's Going on in Schools Now

This area of research will focus on the transition from remote learning to blended learning delivery. There will be special emphasis on the assessment of learning.

### 6. Research Co-Production with IP Communities

Initial explorations on the possibility of collaborative research with select IP schools will be conducted. Research topic/s will stem from the community

with the objective of improving the quality of instruction in their schools. Once decided on the research questions, research protocols will be developed together with community members. It is because of the continuing effects of the COVID-19 pandemic and the remoteness of IP communities that activities for the next year are projected to be mainly exploratory in nature.

  - a. Teacher professional development on content knowledge
  - b. Oral language assessment in early childhood: Insights from a corpus of children's literature in two languages
  - c. Papers from the Age of Acquisition research
  - d. Papers from the MLAF Children research
- SukatWika Version 2.0 includes a user's manual and initial findings about its functions and uses
- 3. Educating Beyond Employability: The Case of Philippine Seafarers

UP CIDS, through HERPRP and ERP, will conduct an online webinar titled, "Educating Beyond Employability: The Case of Philippine Seafarers" via Zoom on March 30, 2022. Topics such as globalization, international labor, migration, and the regulation of Philippine maritime education will be presented and discussed by representatives from the academe, government, and private industry sectors.



The Higher Education Research and Policy Reform Program (HERPRP) aims to chart a research agenda, systematically build an evidence base for policy analysis, and create a network of experts and researchers conducting work in the higher rducation sector. The Program also serves as a convening body that seeks to build partnerships and working collaborative networks among key stakeholders.

**HERPRP** Research Consultants


August-December 2021

# ACTIVITIES FROM JULY TO DECEMBER 2021

With the completion of the K to 12 curriculum review, ACTRP's work during the second half of 2021 focused on disseminating curriculum review findings and providing technical assistance to the Department of Education (DepEd) for the development of learning area shaping papers. These learning areas shaping papers will guide the crafting of the 2022 K-12 curriculum.

July to December 2021 was also dedicated to the development of modules and videos for the Professional Development (PD) Program for Junior High School teachers entitled "Building basic assessment competence of teachers" and the conduct of the PD training for Science and Mathematics teachers via synchronous and asynchronous sessions on Qualtrics and YouTube Live.

The research on the feasibility study on the use of microcertification for the learners of the Alternative Learning System (ALS) was completed with recommendations on its potential for describing learners' knowledge and skills for employment.

### PILOT STUDY DATA COLLECTION

Feasibility Study on Microcertification for the ALS in the Philippines

May 28-September 24, 2021

Data collection for the pilot study consisted of the following process: registration of participants, production and distribution of pilot study materials, assessment period, and collection of pilot study materials. Registration and assessment forms were made available both online and in paper form. In July 2021, assessment forms and support materials were printed and sent to four DepEd divisions, namely, NCR-Manila, Region IV-Batangas Province, Region XI-Davao City, and Region XII-South Cotabato. Four weeks were given to participants for the assessment period, and another week was allotted for the collection of accomplished forms. Data collected were sorted, scanned, and cleaned by ACTRP.

### ADVISORY GROUP MEETINGS

Feasibility Study on Microcertification for the ALS in the Philippines

July 22, August 19, September 2 and 23, October 21, November 4, and December 1, 2021

Meetings with the advisory group were conducted to provide pilot study implementation updates to the panel, to seek advice on how to address issues encountered in the conduct of the pilot study, to solicit suggestions on the refinement of post-pilot study consultation questions for the research participants, to report preliminary data analyses results, and to consult about the costed road map and dissemination

### POST-PILOT STUDY CONSULTATIONS

Feasibility Study on Microcertification for ALS in the Philippines

September 30, October 1, 4, and 5, 2021


Focus group discussions were conducted with selected pilot study participants: (1) Division ALS Focal Persons and Education Program Specialists for ALS, (2) ALS teachers, (3) ALS learners, and (4) raters nominated by learners. The consultations aimed to get feedback from the participants about the implementation of the pilot study from registration up to the collection of the materials. Questions were asked about the perception of participants regarding microcertification and the possibility of implementing it on a larger scale. Challenges encountered by the participants in using the assessment forms and the usefulness of the instruction guides were also explored.

### MODULE DEVELOPMENT AND ONLINE TRAINING

COVID-19 Response Project on Enhancing Formative Assessment in Self-Learning Modules

July to December 2021

ACTRP attended meetings with the DepEd Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD) to finalize Parts 2 and 3 of the Self-Learning Module (SLM) Guides and Worksheets. The finalized materials were forwarded to DepEd and were used for the online training of SLM writers conducted in October 2021. The training aimed to enhance the teachers' ability to write formative assessment tasks and to improve the quality of formative assessment within the SLMs. This activity was facilitated by DepEd BLD-TLD.

### Assessment Professional Development on Building Basic Assessment Competence of Teachers

November 3–20, 2021(Grade 8 and 9 Science Teachers) November 29–December 18, 2021 (Grade 8 and 9 Math Teachers)

ACTRP is part of a consortium organized by the DepEd to deliver a PD Program on Assessment and Emerging Literacies with a focus on the Programme for International Student Assessment (PISA). The participants of the program are Math, Science, and English teachers in 9,344 Junior High Schools (JHS) nationwide. ACTRP delivered the module entitled "Building Basic Assessment Competence of Teachers," which includes the following topics: (a) Assessment Purposes, (b) Assessment Planning, (c) Evidence Collection, (d) Interpretation and Use of Student Data during Classroom Discussions (e) Interpretation and Use of Student Data Between Lessons, and (f) Evaluation of Assessment Processes. The module has asynchronous and synchronous sessions that run for a total of 18 hours over three weeks. The training for the Science and Math teachers was delivered in November to December 2021.

### **FORUM**

DepEd Education Forum

August 26, 2021

The K-12 Curriculum Review results were presented to education stakeholders at the Educ Forum. Presenters included DepEd Undersecretary for Curriculum and Instruction Diosdado San Antonio, Assistant Secretary Alma Ruby Torio, Bureau of Curriculum Development Director Jocelyn Andrada, Bureau of Learning Delivery Director Leila Areola and Bureau of Education Assessment Director Nelia Benito for DepEd, and Dr. Marie Therese A. P. Bustos and Dr. Pam Robertson for ACTRP. Dr.

Christopher Bernido, President of the Central Visayan Institute Foundation, and Dr. Bert Tuga, President of the Philippine Normal University, served as the reactors. DepEd Regional Director Ramir Uytico moderated the open forum.

### WORKSHOP

Workshop on DepEd's 21st Century Skills Framework: Review of the K-12 Curriculum and the Development of Learning Area Shaping Papers

September to November 2021

ACTRP collaborated with representatives from the DepEd's Bureau of Learning Delivery, Bureau of Curriculum Development, Bureau of Education Assessment, and Bureau of Learning Resources to develop the 21st Century Skills Framework. The drafted framework was presented to the department's Curriculum and Instruction Pillars for approval. This framework will be used by DepEd to guide all



### MEETING ON CURRICULAR FRAMEWORKS


Review of the K-12 Curriculum and the Development of Learning Area Shaping Papers

STEM Framework Workshop


of the workshop, representatives from the three learning areas were able to agree on a common cycle. The development of the STEM framework will follow by early January.

### **STUDY**

Learning Loss Study

August 20, 2021-ongoing

ACTRP has been tapped by the Bureau of Education Assessment (BEA) to assist in conducting DepEd's study on learning loss due to COVID-19. Particularly, ACTRP provided guidance on the research design and sample and in the review of test items to be included in the computer-based National Achievement Test (CBNAT). ACTRP analyzed previous NAT Grades 6 and 10 data to determine which items could be used as linking items for the CB-NAT 2021. The study will be completed by the end of the first guarter of 2022.

### Introduction to Rasch Analysis Training

October 28-December 16, 2021

To capacitate the BEA staff in conducting psychometric analysis of their assessment data, ACTRP organized a 10-session training on Introduction to Rasch Analysis. Dr. Margaret Wu, one of the experts in the field of psychometrics in Australia, served as the resource person for the entire training. This training was organized for the BEA staff to understand and appreciate the psychometric analysis that will be conducted in the learning loss study.

### **FIELD TRIAL**

Computer-based National Achievement Test Field Trial

December 1-13, 2021

ACTRP was invited by BEA to observe the CB-NAT 2021 field trial. Research officers of ACTRP observed the selected Grade 7 students from Cebu Province and Grade 11 students

from Caloocan City. The research officers also attended the debriefing sessions where several issues were raised by the examiners. ACTRP also submitted comments and recommendations to improve the implementation of CB-NAT 2021.

### ASSESSMENT PROFESSIONAL DEVELOPMENT

Building Basic Assessment Competence of Teachers

January 10–29, 2022 (Grade 8 and 9 English Teachers) March-June 2022 (SERG Schools)

ACTRP will train the last batch of participants, Grades 8 and 9 English teachers, in January 2022. Schools under the SERG project of the Department of Foreign Affairs and Trade (DFAT) will also receive training in assessment, involving elementary school teachers.

### **LEARNING LOSS STUDY**

Technical Assistance to Bureau of Education Assessment

First Ouarter of 2022

BEA will implement the CB-NAT 2021 during the first quarter of 2022. Once the assessment has been administered, ACTRP will assist them in analyzing both the previous NAT and CB-NAT 2021 for Grades 6 and 10 to measure learning loss due to COVID-19.

### Capacity Building for BEA Personnel January-May 2022

Training on the applications of item response theory (IRT) to international large-scale assessments (ILSAs) and the proper way to conduct secondary analysis of ILSA data will be conducted for BEA staff in the summer of 2022.

# Facilitation of K to 12 Curriculum Development Workshops

January-June 2022

ACTRP will provide technical input and facilitate curriculum development processes with DepEd curriculum specialists. Following the results of the curriculum review, DepEd will prepare learning area shaping papers and streamline curricular frameworks across subject areas and grade levels.

## Wider Dissemination of the Feasibility Study on Microcertification

January-June 2022

ACTRP will present the findings and recommendations of the Feasibility Study on Microcertification for ALS in the Philippines at the Educ Forum as well as in various forums for DepEd Officials, ALS Implementers, and external partners.

# ACTIVITIES FROM JULY TO DECEMBER 2021

### **CONSULTATIVE STAKEHOLDER MEETINGS**

Data Science Working Group

July 14-December 10, 2021 (recurring meetings)

DSPPP continued to convene the Data Science Working Group and participated in the continued review of the inter-constituent unit (inter-CU) program proposals in the field of data science, in particular:

- Ph.D. in Data Science (College of Science, School of Statistics, and College of Engineering; UP Diliman);
- BSc in Data Science (UP Mindanao);
- MSc in Data Science for Development (UP Open University); and
- MSc/Ph.D. in Bioinformatics (College of Science, UP Diliman; and the Philippine Genome Center)

The Working Group also serves as an avenue to discuss the efforts of different UP units in addressing the COVID-19 pandemic's impacts. Various academic heads are also part of the meeting to integrate all data science efforts and setting up a facility to cater to UP researchers' needs in terms of big data analytics (BDA) and cloud computing, among others (e.g., installment of supercomputers for researchers and the launch of UP Data Commons).

### **CONSULTATIVE STAKEHOLDERS MEETING**

Digital Public Pulse Project

October 2021

DSPPP and the Department of Communications Research from the College of Mass Communication (CMC), UP Diliman held a meeting to present and discuss the Digital Public Pulse, a media-monitoring project by UP CMC that traces maps, and analyzes public discourses in the Philippine digital public sphere. It investigates the intersection of the digital public, social networks, and media

### **CAPACITY-BUILDING ACTIVITY**

Text Mining in Career Studies: Generating Insights from Unstructured Textual Data July 23, 2021

The lecture explained the process of text mining as it is applied to the study of careers, starting with text preprocessing and ending with the application of analytical techniques.

Both conventional techniques, such as latent semantic and principal components analysis, and more novel text analytical techniques, such as word embeddings, are discussed. The lecture also hopes to inspire careers researchers to further embrace text analysis to answer novel research questions.

### RESEARCH ACTIVITY

Analysis of Education-to-Labor-Market and Job-to-Job Transitions

September 24, 2021-Present

The research project aims to visualize transitions and create a model that can predict probable job transitions in a person's career using historical data of education-to-labor market transitions and job-to-job transitions. The project will build a model using sequence prediction algorithms, such as recurrent neural network and conditional random fields, among others.

# UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

DSPP will continue pursuing activities related to its internal research agenda, particularly on the governance of information systems. It will also look into labor market analytics and health data science. The outputs of these research activities will be submitted to UP CIDS for publication. Different capacity-building programs will also be pursued as part of DSPP's two-pronged thrust—the proceedings of which shall be compiled and submitted for publication to the Center.


### **ACTIVITIES**

 Continuation of the labor analytics research activities

The project is conducting two labor analytics research activities. The first aims to use historical data of educationto-labor market transitions and iob-tojob transitions, to create a model that can predict probable job transitions in a person's career. The second research project will create an algorithm that automatically detects and sorts job type information in vacancies. These job information may include worker attributes (skills, competencies, education), job activities, description of the business organization, benefits, and compensation. Consequently, the project will create the first skill taxonomy of Filipino workers in the Philippines.

 Research activities related to the Innovations in the Operationalization of Whole-of-Society Approaches in Pandemic-Related Information Systems

The research project aims to look at the experience of select local government units (LGUs) in improving their information

system capacities in addressing the COVID-19 pandemic by gathering textual data from the discussions with LGUs and utilizing the data available from different social media pages of these LGUs to conduct quantitative analysis.

### Analyzing skill demand and taxonomies in the Mindanao region

Mindanao offers great potential in terms of manpower; however, many young workers cannot find suitable jobs because either they are not aware of the opportunities or there are mismatches in their education and available jobs in the labor market. The task is to develop profiles of skills and competencies required by companies operating in the Mindanao region. The result will be used to write a policy brief that makes recommendations on what skills education institutions should focus on developing for their students.

#### **REPORT LAUNCHING**

Exploring Opportunities for Economic Diversification and Productive Employment in the Philippines

August 5, 2021

The report, which discussed COVID-19-related challenges on employment and diversification in the Philippines, was authored by EMIT C4C convenor, Dr. Annette Balaoing-Pelkmans and Dr. Adrian Mendoza. In the report's launch, the International Labour Organization (ILO) shared the paper's main findings. Discussants who gave comments included Department of Trade and Industry (DTI) Undersecretary Rafaelita Aldaba, Philippine Chamber of Commerce and Industry Secretary-General Ruben Pascual, and World Bank Country Director for Philippines, Malaysia, Thailand, and Brunei, Dr. Ndiamé Diop.

#### **VALIDATION WORKSHOP**

Validation Workshop on the Islamic Community Plan

September 7, 2021

The validation workshop, held in Kura Kura, Lanao del Norte, is the second undertaken in the Business-for-Peace project to help key MILF communities build their own blueprint of a model Islamic community. The attendees include members of the MILF's Northwestern Mindanao Front (NWMF). EMIT C4C Convenor Dr. Annette Balaoing-Pelkmans helped organize and actively participated in the workshop.

#### **WORKSHOPS**

Capacity Enhancement Workshops November 22, 2021

The first workshop was for the officers of the Bangsamoro Islamic Women Auxiliary Brigade (BIWAB) in the six camps of Camp Bilal, whereas the second was for NMWF leaders, particularly those directly supporting the legislative work of member of parliament (MP)

Abdullah Macapaar. The workshops surfaced community members' needs, as well as the knowledge, skills, and technology needed to meet their needs. Among the workshops' outputs of the workshops include the emphasis on securing and managing livelihood opportunities.

#### FORUM

Industrial Policy Forum

December 9, 2021

EMIT C4C Convenor Dr. Annette Balaoing-Pelkmans served as one of the speakers in the forum organized by the International Trade Centre (ITC) of Genevam which was meant to discuss international experts' ideas and research findings on industrial policies. Other speakers included DTI Undersecretary and Board of Investments Governor Ceferino Rodolfo.

#### **PRESENTATION**

December 16, 2021

EMIT C4C presented its action research findings on *Kapunungan sa Gagmayng Mangingisda sa* Concepcion, which was headed by the 2021 Ramon Magsaysay Awardee, Roberto Baylon. # UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

Efforts will be undertaken to finish the action research case studies on Global Organic Wellness Corporation (GlowCorp), Hacienda Malaga Cuenca Agrarian Reform Cooperative (MACARBEN), and Laak Multipurpose Cooperative (LAMPCO), share these to Peace and Equity Foundation (PEF) for comments, and eventually submit knowledge products to UP CIDS. The research process also includes

validation sessions from leaders of GlowCorp, MACARBEN, and LAMPCO. If it is possible, some of these validation sessions will be held face-to-face to enable a richer discussion. By the second quarter of 2022, EMIT C4C intends to share these papers' findings in an online Anchor Themes Workshop in partnership with PEF.


The Program also intends to submit a systematic literature review on the middle-income trap to UP CIDS, particularly to the Philippine Journal of Public Policy (PJPP). In the first half of the year, Dr. Pelkmans-Balaoing will also undertake fieldwork in Mindanao to join EMIT C4C's partners in the face-to-face trainings and workshops with MILF's key leaders and members.

#### **ACTIVITIES**

Two field research studies in Mindanao, particularly in Lanao del Sur, will be undertaken by EMIT C4C. One will involve workshops with the NWMF on capacity enhancement. To

Presentation of EMIT C4C of its action research cases to the PEF board of trustees. | PHOTO BY: PEF


maximize the trip, discussions with Unifrutti and the Hineleban Foundation in Davao City and Bukidnon will also be conducted, which will center on the continuation of the action research on inclusive and competitive agriculture value chains and apply prior lessons to new enterprises.

Three validation workshops with key partners of PEF will be undertaken during the period. One workshop will discuss the findings of the draft action research reports on GlowCorp, MACARBEN, and LAMPCO with the board of trustees, management, and select members of farmers' cooperatives. After new drafts are formed from the validation sessions, a discussion with the management and PEF's

board of trustees will ensue. Toward the end of the period, an Anchor Themes Workshop will then discuss the reports with the wider public. This final workshop will be hosted by UP CIDS, in partnership with PEF.

#### **OUTPUTS**

- Three (3) monographs or discussion papers on the action research case studies with PEF. These will form part of the Going Against the Grain series that EMIT C4C is developing. The intention is to cull findings and eventually develop these into a book.
- One (1) PJPP manuscript showing the results of the systematic literature review on the middle-income trap



## ACTIVITIES FROM JULY TO DECEMBER 2021

#### **PRESENTATION**

University Council Meeting July 19, 2021

During the University Council Meeting held last July 19, 2021, PEP Convenor Dr. Antoinette Raquiza presented a proposed statement opposing the following Senate bills which seek to ease foreign ownership restrictions in vital industries, which were under deliberations at that time: (i) Senate Bill 2094, amending the Public Service Act; (ii) Senate Bill 1156, amending the Foreign Investments Act of 1991; and (iii) Senate Bill 1840, amending the Retail Trade Liberalization Act of 2000. The proposed statement, "Rebuild the Philippine Economy by Strengthening Filipino Capabilities," was put through a vote through a referendum in September 2021 and adopted by the UPD University Council and released on October 6, 2021.

Coorganized with the Office for the Advancement of Teaching, the *Kumustahin ang Bayan* webinar was the first in the series of discussions titled #PILIpiLUNAS2022: *Pagbangon at Pangsulong Tungo sa Magandang Buhay at Bukas*, conducted under the UP Diliman Office of the Chancellor. The webinar focused on where the country is in terms of the government's *Ambisyon* 2040 Program, as well as people's perceptions of their quality of life amid the pandemic and upcoming national elections. It featured presentations from the Social Weather Stations (SWS), Pulse Asia Research, Inc, and the National Economic and Development Authority (NEDA).

### Rebuild the Philippine Economy by Strengthening Filipino Capabilities

When the Philippine Congress convened its regular session in July, Congressional leaders vowed to fast–track the enactment of laws that will have a long–lasting and wide–ranging impact. Certified as urgent by President Rodrigo Duterte, these bills will now allow 100–percent foreign ownership and management of vital public services and small retail businesses.


Specifically, three Senate bills are on the table:

Senate Bill Number (SBN) 2094 will reclassify key strategic sectors, previously considered public utilities under Commonwealth Act of 146 (or the Public Service Law) as "public services," which may result in 100-percent foreign ownership in the country's telecommunications and transportation sectors.

SBN 1156 will do away with the Foreign Investments Act of 1991 provision that reserves small and medium enterprises (i.e., valued at less than USD 200,000) to Filipinos, as it will allow foreigners to set up and wholly own businesses with a minimum of USD 100,000 under some conditions.

SBN 1840, complementing SBN 1156, will amend the Retail Trade Liberalization Act of 2000 by

In this two-day conference, he presented the main findings of the AltDev report on the COVID-19 responses of the Nagkaisa Labor Coalition, the farm workers organizations Asosasyon sang mga Mamu mungon sa Nolan (AMANO) and Nakalang Padilla Farm Workers Association (NAFWA), the women social enterprise Igting, and the Ayta Mag-indi community in Pampanga. He also discussed how organized communities exercise agency in the face of the Duterte administration's failed authoritarian response.

#### **WEBINAR**

State of the People Address 2021: Kumperensya para sa Pagbangon ng Ekonomiya at ng Bayan

July 20, 2021

AltDev Convenor Dr. Eduardo Tadem discussed the need to legislate a wealth tax to counter massive inequality in the Philippines and fund the country's pandemic response. His lecture was part of the in-person and online State of the People Address yearly organized by the Freedom from Debt Coalition and its partners, parallel to the annual State of the Nation Address (SONA). Dr. Tadem also discussed the rise of wealth inequality at record levels during the pandemic, highlighting that wealth inequality has been a fundamental feature of capitalism with human costs, leading to social and economic instabilities.

Aban explained that the pandemic's regional context underscored the moral bankruptcy of governments and ASEAN as an intergovernmental body to effectively respond to a global health emergency. She added that the pandemic has also solidified many authoritarian regimes to consolidate their power over their citizens and bolster their neoliberal policies.

The webinar tackled the state of the economy during Martial Law, debunking claims that it was the country's Golden Age. AltDev Convenor Dr. Eduardo Tadem gave his lecture, "How Marcos Undermined Philippine Agriculture and Further Marginalized the Peasantry."

To facilitate knowledge sharing and discussions between grassroots partners, sessions on different themes crucial during the pandemic were held simultaneously: education/ pedagogy, local food movements, healthcare practices, forms of cross-border solidarity, and climate emergency responses. These allowed potential allies to deeper understand on-ground cross-cutting issues, emphasizing the necessity of solidarity among organizations and networks from different marginalized sectors in creating stronger movements.

November 26, 2021

This webinar is part of the "#PILIpiLUNAS 2022: Pagbangon at Pagsulong sa Magandang Buhay at Bukas" series, organized by the Office of the Chancellor, University of the Philippines Diliman, and in coordination with the UP CIDS Program on Social and Political Change to contribute to the discussion on policy issues relevant to the upcoming 2022 elections. It aims to review the 30 years under the Local Government Code and its impact on local politics and local service delivery. AltDev Convener Dr. Eduardo Tadem delivered a solidarity message extending his support for the endeavors of KLMPE toward rural development. His message stressed the "pandemics" experienced by the Filipino farmer, namely plummeting prices of their produce, intensified dumping of cheap imports, failed agrarian reform, continued incursion of big commercial companies in municipal waters, the threat of development aggression in ancestral lands, and the intensification of liberalization. AltDev Junior Research Analyst Honey Tabiola's presentation underscored the devastating impact of the pandemic on smallholder farmers, fishers, and upland dwellers.

#### **WEBINAR**

Demystifying ASEAN: Building Solidarity Among LGBTIQ Activists in Southeast Asia December 9, 2021

AltDev, represented by Project Leader Jose Monfred Sy, joined the ASC in its OutSummit 2021 panel session on "Demystifying ASEAN: Building Solidarity Among LGBTQ+ Activists in Southeast Asia." The overarching theme of the speeches involve a critique toward the global north organizing and development model and radical ideas on strengthening regional south-south solidarity. Sy presented numerous provocations on mainstream LGBTQ+ activism to surface an alternative based on solidarity instead of solely identity and human rights and

also critiqued the ASEAN Way and its neoliberal framework, which ensures that profit trumps queer experiences.

#### **MEETING**

Global Tapestry of Alternatives General Assembly

September 11, 2021; December 10, 2021

For the 1st and 2nd Global Tapestry of Alternatives (GTA) General Assembly, objectives and other issues about the group were discussed. One collaboration explored is the development of the "meta-maps of alternatives." AltDev Senior Research Analyst Ananeza Aban and Junior Research Analysts Honey Tabiola and Rafael Dimalanta represented AltDev in these meetings.

Southeast Asian Civil Society Engagement with the ASEAN Process: Challenges and Alternatives

December 11, 2021

# UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

One major task at the start of the year 2022 is for the Steering Committee to convene again, review the results of the 3rd Southeast Asian Conference and plan the succeeding tasks in building the movement for alternative regionalism. Activities within the frame of people-to-people exchanges will still have to adjust to the current COVID-19 setup. Unless mobility restriction will be relaxed in the succeeding months, there will still be limited face-to-face interactions depending on the research partners' respective countries. Nevertheless, the digital space's strength will continue to be maximized.

The hybrid type of grassroots participation will still be encouraged and supported during online conferences and webinars. The language translation component and other technical concerns must be thoroughly discussed for effective exchanges. As such, the role of the Communications Committee, managed mostly by young people, will have to be expanded as core support to the Steering Committee. AltDev will continue to maximize its existing social

media platforms (i.e., *Lawan* and Alternative Regionalism in Southeast Asia) to disseminate grassroots and community responses to COVID-19 and case studies of alternatives.

Online exchanges and linkages with other alternative practitioners will be possibly held in partnership with GTA. Within GTA, there is already an expression of interest to hold an online sharing of alternative cases of grassroots communities between Southeast Asia and South Asia, and Latin America.

If the situation already allows, AltDev will continue its field research and workshops in the Philippines and its pending case study development on the Alternatives in Southeast Asia monograph series. The Program's research writing and publication component will also prevail as this remains the backbone for the conduct of public lectures, online events, and people-to-people interactions related to the monograph series. The second volume of the Alternatives monograph series is intended to be published in 2022.

AltDev will also take opportunities to coorganize study conferences or lectures to highlight the Alternatives series through the academic track. Likewise, this can be a strategy to disseminate the published research's arguments and findings and expand linkages with other like-minded scholars.

#### **ACTIVITIES**

#### **Social Media Project 2022**

The Lawan social media platform remains a vital tool for dissemination and awareness-raising of community alternatives. For 2022, AltDev expects to expand its reach by collaborating with grassroots groups to produce content focusing on relevant issues in the region. The Program also aims to produce a research output detailing the methodology of community-led participatory action research using digital

platforms. Finally, AltDev is considering replicating *Lawan*'s success in its other digital platform, Alternative Regionalism in Southeast Asia, to extend the emerging movement's efforts in linking practitioners of alternative development in the region and beyond.

#### **Documentation of Alternatives**

For the past two years, AltDev has focused on researching COVID-19's impacts on vulnerable populations, as well as grassroots initiatives that started as a response to the pandemic. The Program did this to bring these to the attention of policymakers and the general public. This year, AltDev will resume its efforts to document different alternatives already being done in the grassroots that are not solely as pandemic responses but more so, initiatives to assert and defend their rights. The Program will also continue co-producing monographs covering the struggle and emergent alternative practices of people's organizations marginalized communities in the Philippines and Southeast Asia.

### Collaborative Project on Gender and Environment

AltDev and the Network for Transformative Social Protection (NTSP) are embarking on a collaborative research project on "Climate Justice and Adaptive Social Protection" for workers in the information technology and the informal sectors in the Philippines. This is funded by INSP!R Asia and the We Social Movements (WSM) of Indonesia under their "Gender and Environment Program." In addition, NTSP-AltDev will integrate the case studies from Bangladesh, Indonesia, India, and the Philippines and compile them in one project document output. The project timeline is from December 2021 to April 2022.

#### 4th Regional Conference on Alternatives

The fourth installment of the conference will build on the achievements of the previous ones and assess the strategic direction of building the regional movement of alternatives in Southeast Asia. It will be a forum to evaluate the conduct and impact of online and offline activities and campaigns jointly organized by the network in 2022, as well as a platform to present additional alternative cases. This installment will aim to sustain and fortify the concrete efforts of building the regional movement of alternatives in Southeast Asia as a challenge to the dominant model of regionalism.

### Movement Building for Southeast Asia Alternatives

After the formation of the movement for alternatives in Southeast Asia. AltDev will continue its engagement with its fellows and partners to harness and refine the results of the recent regional conference. It will also build on its past years of building the movement into concrete action steps toward creating stronger networks of solidarity and realizing the vision for an alternative regionalism. In 2022, the movement will design more structure and organization for the necessary mechanisms of alternative regionalism to be created. Further, collaborative undertakings centering on alternatives shall be jointly identified and undertaken by fellows and the movement's members.

## ACTIVITIES FROM JULY TO DECEMBER 2021

**WEBINAR** 

COVID-19 sa Hangin July 10, 2021

Convenor PHSD Dr. Antonio Dans. in coordination with the UP CIDS Decolonial Studies Program (DSP) and UP Center for Women and Gender Studies, gave a lecture on how COVID-19 can be transmitted. He shared important guidelines to follow to avoid contracting and tips to avoid spreading COVID-19 to one's household and community. Emphasis was placed on the basic rule "APAT DAPAT," which are the following: (1) proper air circulation; (2) physical distancing; (3) always wearing masks and face shields; and (4) 30 minutes of interaction or less. The webinar was attended by the UP CIDS personnel and program staff.

#### **WEBINAR**

Telemedicine and Digital Connectivity August 12, 2021

PPCS data were presented to the Department of Information and Communications Technology (DICT) headed by Secretary Gregorio Honasan. Other attendees were Senator Pia Cayetano and health professionals. Dr. Antonio Dans highlighted the importance of interconnectivity in achieving primary care in the Philippines. especially the in remote areas. With interconnectivity, people are able to access their primary care check-up even without going to the RHU. He pointed out how vital it is to have the whole country interconnected especially in this time of the pandemic.

#### **WEBINAR**

Philippines Data-Driven Development (PH3D) Online Learning Series

September 9, 2021

This webinar focused on the experiences of different local government units and how they successfully uplifted the healthcare system in their own province. PHSD Convenor Dr. Antonio Dans presented the PPCS data collected from the three study sites: urban (UP Health Service), rural (Samal, Bataan) and remote (Bulusan, Sorsogon). He emphasized the need for collaboration between the public and private sector in order for the government to succeed in achieving universal health are. This meeting was also attended by the Action for Economic Reform group and representatives of the European Council.

#### PPCS IN-HOUSE TRAINING (ONLINE)

Identifying Bugs in Electronic Health Record (EHR) and How to Report Them

September 10, 2021

This training was done as part of the online training series for the PPCS site staff. PHSD Information Officer Ms. Cara Galingana discussed the steps in troubleshooting the electronic health record (EHR) system currently being used by the three sites. She showed examples of the situations that were usually encountered by the staff when using the system. She gave the definition of a bug and discussed in detail the types of bugs that were seen in the program. Steps in proper documentation and reporting of the identified bugs in the system were also tackled.

#### PPCS IN-HOUSE TRAINING (ONLINE)

Community Engagement

September 16, 2021

Dr. Lei Camiling Alfonso gave a primer on community engagement. She discussed what community engagement means in medicine versus public health. She stressed the importance of understanding the principles of communication for development wherein there is a need to support two-way communication systems that allow dialogue and that allow communities to speak out, express their aspirations and concerns, and participate in the decisions that relate to their development.

#### **WEBINAR**

COVID-19 Proper Sanitation Guidelines September 18, 2021

PHSD Convenor Dr. Antonio Dans discussed the proper sanitation guidelines for the prevention of COVID-19. He emphasized the need to follow "APAT DAPAT," air circulation and ventilation, physical distancing and avoid crowding, always use face mask and time of interaction should be less as much as possible.

### ONLINE MEETING WITH SPONSOR/FUNDING AGENCY (PCHRD)

PCHRD Governing Council Meeting September 20, 2021

Year 2 results of PPCS were presented to the governing council of the Philippine Council of Health Research and Development (PCHRD). Dr. Antonio Dans highlighted the importance of connecting all the barangays to be able to access health care. He cited as an example

the utilization of consults in Samal, Bataan, which tripled since PPCS started. Even when the pandemic hit, they were able to recover because they have an internet connection. Because of connectivity, we were able to set up telemedicine within 4-8 weeks, which has proven useful during the pandemic. Year 3 plans were also presented for approval of the funding.

#### **ZOOM MEETING**

Meeting with Bulusan Mayor

11 October 2021

Dr. Antonio Dans discussed the importance of telemedicine, especially during the pandemic. The hiring of additional doctors was proposed since there is only 1 MD in the RHU who is also the Municipal Health Officer (MHO). At the end of the meeting the Mayor stated that he will look for a budget to hire another doctor for the RHU.



#### **ZOOM MEETING WITH PHILHEALTH AND DOH**

Linking Mechanisms for Financing Primary Health Care and Governing Policies of Community Outpatient Benefit

October 14, 2021

Dr. Antonio Dans discussed the importance of linking the Rural Health Units (RHUs) to the service delivery network (pharmacies, laboratories, and transportation system). This can only be done by having mobile and internet access in all areas of the Philippines to make primary care accessible to all. He stressed the important role that the government plays in making this possible. That without the policies governing the healthcare system, health system reforms would not be made possible.

#### **WEBINAR**

5th National Cardiovascular Summit—Digital Health Solutions for Universal Health Care— Philippine Primary Care Studies

October 14, 2021

Dr. Antonio Dans discussed UHC and the importance of the health information systems in making primary care accessible to all. He presented the PPCS results and enumerated the impact it has on the pilot sites. He pointed out the seven potential impacts, which are: increased utilization of primary care, increased pandemic resilience, increased spending capacity, reduced out-of-pocket expenses by the patients, increased patient satisfaction, and lastly detection of misuse, overuse, and fraud.

#### **WEBINAR**

Philippine Primary Care Studies for the Philippine Society of General Internal Medicine

October 18, 2021

Dr. Antonio Dans discussed the importance of inter-connectivity in the Philippines. He pointed out that better healthcare access up to the level of the barangay will only be possible if there is mobile and internet connection even in the farthest and most remote areas in the country. Connectivity will give the doctors the ability

to do telemedicine consults, thus more people will have access to health care. More access to health care will then improve the quality of care.

#### PPCS IN-HOUSE TRAINING (ONLINE)

PPCS Strategy Calibration Series (1–3)

October 21, 2021, October 28, 2021, and November 25, 2021

The strategy-calibration series was facilitated by Dr. Lei Camiling Alfonso. She discussed why we need to calibrate; the previous year was hard for everyone and many things did and did not happen. For PPCS, our goals may be outdated or ineffective. The activity was held to help us organize our plans and goals for PPCS for the coming year. PHSD discussed what impact it want to have for PPCS and what actions are necessary to support that. Assessment of our objectives and action planning were also done so that at the end of the day all that we do in this project is for the good of all Filipinos.

### VIRTUAL EHR TRAINING FOR ONE HOSPITAL COMMAND CENTER

Training Orientation on a Primary Care-Oriented EHR for Use in Hospital Coordination

October 22, 2021

Dr. Jose Rafael Marfori co-presented in a training session directed at end-users and managers of the One Hospital Command Center (OHCC). which was promptly set up after the pandemic began for coordinating inpatient demand across hospitals. That function is a core part of health provider network coordination, which is expected of primary care under the Universal Healthcare Act (UHC) Act. it is appropriate to maximize the clinical functionality that is already built into the e-Med Primary Care Health Information System, a PPCS research product now being codeveloped and deployed through a partnership between UP Manila and E-Med Healthcare Solutions, Inc. It was designed for UHC and is being marketed with a focus on local government implementation of health systems integration in pursuit of the UHC Act.

# ONLINE MEETING WITH SPONSOR/FUNDING AGENCY Presentation of PPCS Year 2 Technical Report

November 4, 2021

Year 2 results of PPCS were presented to the Health Policy Development & Planning Bureau of Department of Health (DOH). He discussed the interventions that were developed to strengthen primary care, the outcomes, and the recommendations. Recommendations given were the following: (1) increasing the workforce, training them, and retaining them; (2) involving the private sector in the healthcare provider network; (3) developing and finance a true comprehensive outpatient benefit package; (4) engaging the community; (5) addressing connectivity in all areas of the country; and (6) looking at performance measures. The most important of all the recommendations is workforce development.

#### **WEBINAR**

DOH Regional Research Forum: "Primary Health Care Resiliency Amidst Emerging and Reemerging Diseases"

November 5, 2021

PPCS data was presented to healthcare workers who attended the forum. Dr. Antonio Dans presented the results of Samal, Bataan and how they were able to continue primary care even during the pandemic. He highlighted the importance of connectivity in achieving primary health care in the Philippines especially in remote areas.

#### **WEBINAR**

Department of Science and Technology-PhilHealth (DOST-PHIC) Virtual Forum: "Reexamining Health Systems Towards a New Normal"

November 10, 2021

Dr. Antonio Dans discussed transforming primary healthcare and identifying the imperative steps for addressing inequities in healthcare access.

He described the interventions that were developed by PPCS to strengthen primary care at the three study sites (UPHS, Samal, and Bulusan). He pointed out the importance of having enough doctors, nurses, and midwives in all the RHUs around the country. He also discussed workforce development through motivation, training, continuing professional development through the use of UpToDate, and task shifting to the barangay health workers.

#### **ONLINE PRESENTATION**

Monthly Meeting of the Provincial Health Officers Association of the Philippines (PHOAP)

November 12, 2021

Dr. Jose Rafael Marfori copresented the e-Med Primary Care Health Information System, a PPCS research product now being co-developed by UP Manila in partnership with E-Med Healthcare Solutions, Inc. This system was designed for UHC and is being marketed with a focus on local government implementation of health systems integration in pursuit of the UHC Act. UP Manila Chancellor Dr. Carmencita D. Padilla also gave an informative message.

#### WEBINAR

Post-Graduate Medical Education: DOH/ Philippine Primary Care Studies Phase 1 and 2

November 23, 2021

PPCS survey results for Years 1 and 2 were presented during this activity. Dr. Antonio Dans pointed out the differences between the rural and remote sites, where primary care was more accessible for the rural site because there were more healthcare workers attending to the patients. Survey results also showed that patients at the rural site had better quality of care and, therefore, were more satisfied.

#### **PPCS IN HOUSE TRAINING (ONLINE)**

Submission Guidelines for Project Proposals & Filling up of Forms

December 9, 2021

Ms. Joy Sanchez discussed the guidelines in submitting proposals for ethical and technical review of the different institutional review boards. The different forms to be used and how to properly fill them out were also explained. A question-and-answer portion was held after the lecture where the PPCS staff were asked to answer a sample form for "submission". The different types of letters accompanying the forms were also enumerated.

#### WEBINAR

Alternative Class Learning Experience (ACLE) on Public Health & Community-Led Health Responses

Dr. Jose Rafael Marfori cofacilitated a meeting with health officials and health personnel endusers from Pasig City, where the e-Med Primary Care Health Information System was being piloted since July 2021. This system is a PPCS research product now being co-developed and deployed through a partnership between UP Manila and E-Med Healthcare Solutions, Inc. The system was designed for UHC and is being marketed with a focus on local government implementation of health systems integration in pursuit of the UHC Act.



# UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

The Program's plans for the next six months are to (1) continue monitoring the eight primary care outcome areas through quantitative and qualitative research methods across sites; (2) prepare for and conduct Year 3 assessment/ surveys; (3) clean up data and analyze Year 3 surveys 4) submit progress reports to stakeholders; (5) conduct in-house writing and research workshops; (6) continue developing manuscripts for journal publication; (7) improve the capacity of the existing electronic health record system; and (8) engage communities through evidence-based strategies.

Site monitoring will still be limited to telephone and online platforms to prevent COVID-19 transmission and ensure staff safety. Likewise, Year 3 assessment surveys and training sessions will be conducted primarily through telephone or online methods. The electronic health records will continuously be improved to facilitate usercentrism across sites. Community engagement strategies to promote health education, personcentered health policy, and risk-sharing will be further enhanced through print and digital media platforms (e.g., website development and social media engagement). Regular updating of the primary care website will be done to showcase the programs' achievements.

#### **ACTIVITIES**

- 1. Continuous monitoring of the primary care clinics at the three sites through telephone correspondence and online meetings. The Program will continue to facilitate weekly team meetings to discuss program updates, funding, manuscript development, site-specific issues, survey progress monitoring, and service utilization throughout sites.
- 2. Plan and train the site staff of the three sites to conduct the Year 3 survey. Surveys to be conducted include: UpToDate usage, patient satisfaction survey, EHR acceptance and use survey, health care worker satisfaction survey, and outpatient and inpatient service utilization. Planning and retraining of the site staff will be done from January

- to February 2022. The target start of the surveys will be this coming March 2022.
- 3. Submission of additional questions to be used in telemedicine to UP Manila Research Ethics Board. Once approved, focus group discussions will be done this January to February 2022 to assess telemedicine usage and access at the rural and remote sites.
- 4. Biweekly UpToDate Club for healthcare workers of the three sites. Topics to be discussed will be based on the cases that will be encountered by the healthcare workers in their respective barangay health stations. There will also be discussions on what they have researched about the case in UpToDate.

- 5. In-house training for PPCS site staff to be done at least once in every quarter. Proposed topics for the training are the following: social sensitivity in research, basics of research writing and appraising literature, how to comment on papers, how to write reports.
- 6. Retraining of the doctors on the use of EHR for telemedicine and face-to-face consults. This will be conducted by our IT staff Ms. Cara Galingana to train the current and incoming doctors on how to use the EHR system for UP Health Service, Samal, and Bulusan sites.
- 7. Launching of the community engagement material primarily through digital platforms (e.g., PPCS website). PHSD is planning to launch the PPCS website this January 2022 to showcase what primary care is all about. The Program also planning to put a link to the published papers on the website.

The fourth #PILIpiLUNAS2022 webinar, which was also co-organized with PSPC, reviewed the 1991 Local Government Code thirty years after its implementation. This webinar's speakers, including PSPC Co-Convenor Dr. Maria Ela Atienza, discussed the state of administration and delivery of public services at the local government level, the utilization of the internal revenue allotment (IRA) in local government financing, and the performance of local governments based on their constitutional and other legal mandates to promote democratization and development. Together with experts from civil society and government, participants also raised suggested reforms and courses of action to address challenges in promoting devolution, good local governance, and democratization.

# UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

The first half of 2022 will see two major events happen in the country's political landscape: the national elections in May and the end of President Rodrigo Duterte's term. In line with this, PSPC's planned activities and outputs will revolve around these events. First, the Program will be making new Ugnayang Migrante episodes but this time focusing on what the Duterte administration has done for overseas Filipino workers (OFWs) and how these impact on their lives. The Program also plans to convene the CIDS Programs for a webinar assessing the performance of the Duterte administration. This will follow the format of the "Mga Pahayag at Sabi-Sabi sa SONA 2019" forum which looked at the first three years of the Duterte administration. A webinar series called "Philippines AD (After Duterte)" is also being conceptualized which will have social science experts assess how the Duterte administration has changed the country and what this means for our country's future. In relation to the national elections, PSPC, with its continuing partnership with the Department of Political Science's UP sa Halalan, will hold webinars discussing election-related topics such as national candidates' campaign styles, platforms, local elections, and many more.

Between January and June of 2022, PSPC will be completing the National Research Council of the Philippines (NRCP) Compendium Project and the publication of the PSPAR and Constitutional Performance Assessment policy briefs. PSPC will also continue working with Palgrave Macmillan on the publication of the "A Better Metro Manila?" book.


#### **ACTIVITIES**

  - 2022 Elections. A series of webinars will be organized by PSPC together with the Department of Political Science's *UP sa Halalan* approaching the national elections this May. Possible topics to be discussed in these webinars are the campaign styles of national candidates, local elections, and more.

Specifically, the podcast episodes will talk about the creation of the Department of Migrant Workers, the OFW Bank, and the OFW Hospital. More than that, the podcast also seeks to examine these through a critical lens.



COLLECTION AND TRANSLATION OF JAWI MATERIALS FROM MINDANAO

Jawi Studies: Establishing the Intellectual Foundation of Philippine Muslim History July 26, 2021-present

The Jawi Studies project is part of the ISP's recommendation for deeper research on the intellectual foundation of Philippine Muslim History (PMH). It aims to discover more of PMH's established traditional knowledge system and its sources and place within classical thought. It will also examine how Muslims in Mindanao and Sulu have internalized, localized, maintained, and integrated the Islamic teachings into their everyday lives. ISP Senior Project Assistant, Asst. Prof. Darwin Absari, gathered Jawi materials from networks in Mindanao, which are translated and annotated by him and other scholars on Jawi studies.

#### **Continuing Research**

Philippine Muslim History

Since the conduct of face-to-face capacity building for PMH teachers is still not possible, continuing development of social networks to strengthen linkages among Islamic Studies institutions will be pursued. The UP Institute of Islamic Studies (UP IIS) shall take the lead to update and share references on PMH to other Islamic Studies institutions in the country.

Meanwhile, the study on Jawi and other literary traditions, which Dr. Samuel Tan has started, will be continued to further establish PMH's intellectual foundation.

#### **Book Project**

The Cesar Adib Majul Posthumous Book Project

The posthumous book project is intended to be a three-part project bringing forth unpublished writings of former IIS Dean Cesar Adib Majul. The original, unpublished manuscripts feature his scholarly research and ruminations on Islamic civilization and PMH book project shall convene a select group of academics to act as reviewers and/or editors of 5–7 unpublished papers of Dean Majul. The review involves curating each paper and thereafter producing a reviewer's introduction of the paper, noting key theses, context, and other significant details. The project deliverable is a book manuscript of 5–7 Majul papers.

#### **Field Research and Online Interviews**

Cases of Handling COVID-19-Related Deaths among Muslims in Metro Manila from March 2020 to March 2022

Among the many challenges the Muslim communities in the Philippines face this pandemic is handling COVID-19 related deaths under the existing pandemic response policies by the government's Inter-Agency Task Force (IATF). A case study aims to look into the challenges, limitations, and good practices in the handling of COVID-19-related deaths among the Muslim population in Metro Manila in the implementation of the IATF guidelines in line with the inherent Islamic rights of every Muslim individual. A minimum of ten replicated cases will be taken into consideration and data will be gathered from the mosques, hospitals, and Muslim burial sites in Metro Manila.







# UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

SSP will continue to promote discourse on significant changes in Philippine foreign policy and develop capacity building for strategic studies in the country. The program is putting effort into analyzing the effect of the COVID-19 pandemic and the repercussions of Philippine government's response to the strategic options for the country. In response to the fact that 2022 is an election year, the Program plans to development policy recommendations to strengthen the Philippine strategic position to the incoming presidential administration.

The program continues to view the country's engagement with the great powers and multilateral cooperation with other states in the Asia-Pacific as a catalyst for further

collaboration and multidisciplinary research between the intellectual communities in the region. For this purpose, the program plans to conduct on research on the effects of regional strategic competition between major and middle powers in the Indo-Pacific.

### ACTIVITIES FROM JULY TO DECEMBER 2021

#### **SPEAKING ENGAGEMENT**

Identities of Muslim Minorities in the Pre-Dominant Christian Philippines

(July 5-9, 2021)

DSP held a virtual talk about the identities of Muslim minorities in the pre-dominant Christian Philippines at the International ILEM Summer School (IISS) in Istanbul, Turkey. IISS is an avenue for academicians, researchers, intellectuals, and scholars globally to interact exchange knowledge pertaining and important issues in the Islamic world. This year's IISS event, formally titled "Muslim Identity in the Modern World: Facts, Threats, and Prospects," was held as a series of talks, lectures, and workshops. Some noteworthy speakers include Syed Farid al-Attas of the National University of Singapore, Imtiyaz Yusuf of the International Islamic University Malaysia, Azyumardi Arza of Syarif Hidayatullah State Islamic University of Jakarta, Fikret Karčić of the University of Sarajevo, Basma Adelgafar of Carleton University, and Dalia Fahmy of Long Island University.

#### **SPEAKING ENGAGEMENT**

Kashmir Issue: Time is Up!

(July 31, 2021)

DSP discussed the Kashmiris' plight along the borders between India and Pakistan at the Ankara Center for Crisis and Policy Studies (ANKASAM). The ANKASAM is a nongovernment organization (NGO) founded by Turkey's leading academics, experts, media professionals, and intellectuals. This event, "Kashmir Issue: Time is Up! International Conference," is free-for-all event for any interested person to participate. It features a series of sessions, each containing at least three speakers discussing a theme; for instance, the Kashmir issue's background and historical process. DSP also participated in the 7th session, which is themed "The Kashmir Issue Within the Scope of International Actors."

#### SPEAKING ENGAGEMENT

FSI Lecture on Science Diplomacy (September 9, 2021)

DSP held a lecture on the interrelatedness of diplomacy and developments of science in the conduct of foreign relations and their implications to Philippine national interests. This lecture was organized by the Foreign Service Institute (FSI)-Carlos P. Romulo School of Diplomacy and discussed "Science Diplomacy: Science Diplomacy in Islamic International Relations (IR)". The lecture was attended by those interested in the topic of or are in the practice of diplomacy. Alongside a lecture-discussion, DSP provided informative videos on the topic, related activities, exercises, and reading materials to supplement knowledge on the topic.

#### **SPEAKING ENGAGEMENT**

Afghanistan and Progressive Action (September 11, 2021)

DSP discussed the Taliban, Sharia law, and women's rights in an event titled "Afghanistan and Progressive Action: Opportunities for Solidarity Amidst the Afghan Crisis," which was

organized by Akbayan Youth in partnership with the Young Progressives Hub. The event tackled the issues surrounding the Afghanistan crisis and the Afghan people's plight related to the Sharia law and women's rights in the region. Alongside Lan Mercado, the regional director for Asia of Oxfam International, an organization aiming to end poverty and injustice for a sustainable world, the history of the occupation crisis in Afghanistan and the implications of the Taliban rule on women's rights and peace and stability in the region were also discussed.

#### SPEAKING ENGAGEMENT

OPAPP Peace Research Conference 2021 (September 21–23, 2021)

DSP presented a talk on decolonial Muslim governance at the Office of the Presidential Adviser on the Peace Process (OPAPP) Research Conference 2021. OPAPP is the official office mandated to oversee, coordinate, and integrate the implementation of the comprehensive peace process in the Philippines. The OPAPP Peace Research Conference is held via videoteleconference through Zoom, divided into a three-day event. Members of the public interested in the topics discussed were able to watch the proceedings, as the conference was broadcasted live on OPAPP's official Facebook page and is currently still archived on its website.

Halal, Culture, and Sustainability Issues in the Philippines

DSP provided a lecture at the 3rd International Conference on Halal, Policy, Culture, and Sustainability Issues, which was organized by the Universitas Muslim Indonesia. #### SPEAKING ENGAGEMENT

Championing Holistic Transformation of Media Practice

(October 16, 2021)

In "Championing Holistic Transformation of Media Practice," an intensive capacity project for media practitioners organized by the German Development Cooperation-Civil Peace Service (GIZ-CPS), DSP discussed the Bangsamoro government's developments and how the media can support its peace agenda. This project aims to develop capacities on holistic and practicable methods, concepts, and principles of conflict-sensitive journalism. It is composed of an eight-week training course, a two-month mentorship program, and a reflection of media practice. The session was focused on the Bangsamoro's social realities and the indigenous peoples (IPs)' displacement in the region.

#### **SPEAKING ENGAGEMENT**

Isang ASEAN: Testing Unity in an Uncertain Global Politics

(November 27, 2021)

DSP provided a virtual lecture, "The Decolonized Perspective of ASEAN: Can It Realize the ASEAN Identity?" in an event organized by the International Studies Society (UE ISSo) of the University of the East Manila. The main two-day event, "Isang ASEAN: Testing Unity in an Uncertain Global Politics," tackled globalization in the ASEAN context. The discussion also involved reimagining the concept of ASEAN's "strong regional community" by decolonizing its perspectives and its members' identities. The event was held online through Zoom and broadcasted live publicly through Facebook. An archived version of the live broadcast is available on the UE ISSo's official Facebook page.

## UPCOMING ACTIVITIES AND OUTPUTS FOR JANUARY TO JUNE 2022

For the first half of 2022, DSP will orient its focus on decolonial legislation and curricula.

First, for decolonial legislation, existing policies by and for IPs have been lacking in several areas. Disputes over ancestral lands versus corporations, issues on indigenous education being unrecognized by the state, and sanctioned silencing of news about IP issues are only some examples of these deficiencies or the results of these deficiencies. With firmer and more culturally cognizant legislation to protect and uplift IPs and their culture, the harmful influence of colonial structures could be supplanted.

Thus, DSP has decided to dedicate time and resources to aim for a Philippine legislative government arm that is sensitive to IP issues and is more knowledgeable about decolonial theory and practice in policy making.

Secondly, the Philippine education system relies heavily on a Western system, best seen with how most subjects are written and taught with English as the primary medium and with Western thinkers and pioneers in the spotlight. Relying on this system with mostly Western schools of thought has resulted in an academic environment not truly congruent with the plural cultures of the Philippines.

As such, knowledge from indigenous sources are routinely ignored, even by Philippine scholars, because of a colonial, and largely unconscious, bias. To help dismantle this bias, DSP aims to spark discussion again on decolonial education.

To fulfill these major directives and goals for the first half of 2022, DSP currently plans to hold

two major activities to facilitate these goals: (1) a two-day workshop on decolonial legislation with the BARMM Parliament and (2) a second roundtable discussion on a decolonial syllabus. The two-day workshop will tackle writing policies suitable for the Moro peoples, whereas the roundtable discussion with academics. professors, and/or workers collaborating on a decolonial syllabus will continue off from the previous roundtable and expound further on what has already been discussed. Discussion papers, proceedings, and policy briefs shall be produced after these activities. Furthermore, DSP also plans to begin establishing linkages with academics and academic institutions devoted to decolonizing their respective fields and partner with entities directly working for and with IPs in the Philippines.

Additionally, DSP also has a currently ongoing application for the VLIR-UOS Short Initiative for a project to research representations of Filipino Muslims in print media and social media. This project is related to digital archiving, multimedia literacies, and the tracing of coloniality in

these archived texts. It will also be linked to an ongoing project sponsored by the University of Antwerp, which investigates digitized newspapers from the Spanish, American, and post-World War II eras. Since archived texts such as these are linked to minority narratives and etic perspectives, it is pertinent to research these to rediscover and trace the representations of minority groups in the Philippines.

#### **ACTIVITIES**

### 1. Workshop on Decolonial Legislation (March 2022)

This workshop aims to explore, discuss, and elaborate on the usage of decolonial approaches in crafting legislative measures (i.e., bills, resolutions) in the Bangsamoro Parliament. It also strives to illustrate decoloniality's importance in the lived experiences and sociocultural realities of the Moro peoples vis-àvis the world of policy making and implementation. It shall be conducted in either an online webinar format or a twoday workshop for a comprehensive and appropriately aligned lecture on decolonial theory and practice and its legislative application concerning the BARMM and the IPs within its jurisdiction.

### 2. Roundtable on Decolonial Syllabi (May 2022)

In December 2019, an earlier roundtable discussion has already been held, providing an in-depth discussion on creating a decolonial syllabus in a holistic sense and tackling how decolonizing syllabi in more specific fields (i.e., social sciences and medicine and public health). A second roundtable, tentatively scheduled for May 2022, aims to further expound how a decolonial syllabus could be structured. Specifically, discussions

on the syllabus's goals, ideas, learning outcomes or developed skills, readings or other appropriate resources to be included, activities, potential design of a decolonial course pack in module format, and other details would be conducted. There can also be discussions on a holistic and comprehensive decolonial syllabus or a decolonized version of syllabi in more specific fields. Various scholars and academics working on decolonizing their own curricula and professionals and volunteers working for and with IPs shall be invited to this roundtable.






### **EXTERNAL FUNDING**

The UP President Executive Order 9 of September 1985 includes UP CIDS' objective of the securing funds from public and private persons and agencies to support its policy research activities. In line with this objective, Education Research Program Assessment, Curriculum, and Technology Research Program (ACTRP), the Program on Alternative Development (AltDev), the Program on Health Systems Development (PHSD), the Program on Social and Political Change (PSPC), the Islamic Studies Program (ISP), and the Strategic Studies Program (SSP) were among the UP CIDS research programs that secured and utilized external funding in 2021.

The combined external funding of the aforementioned Programs comprised 54% of the Center's funds for 2021, whereas the Center's internal funding allocated for the Research Programs amounted to 46%. For 2021, external funding actually made up more of the total research program funds compared to internal funding from the University.

#### **Education Research Program (ERP)**

The Education Research Program (ERP) used external funding, amounting to 33.0% of its entire Program budget for 2021. The external fund was used primarily for its TalkTogether Project. The United Kingdom Research and Innovation–Global Challenges Research Fund (UKRI–GCRF) financed the Project, which later on published technical reports and finalized open data archiving.



#### Assessment Technology (ACTRP)

#### Curriculum and Research Program


The Assessment Curriculum and Technology Research Program (ACTRP) is fully funded by the Assessment Research Centre (ARC) of the University of Melbourne (UoM) and the Australian Department of Foreign Affairs and Trade (DFAT).



### Program on Alternative Development (AltDev)

In 2021, the Program on Alternative Development (AltDev) was able to source external funds for its research activities. Its external funding comprised 58.9% of its total budget for 2021, whereas its internal UP CIDS funding made up the remaining 41.1%.


AltDev's external funding were sourced from the following: (1) Fostering Southeast Asian Peoples' Alternative Regionalism in Pandemic Times and Rising Authoritarianism Project (with 11.11.11 Coalition of the North-South Flemish Movement); and (2) the 2021 General Appropriations Act (GAA) for Comprehensive Release (FCR), which supported its "Policy Studies for Political and Administrative Reform" project.



### Program of Health Systems Development (PHSD)


For the Program of Health Systems Development (PHSD), majority of its funding came from external sources (90.7%). PHSD's external funding sources include the following: (1) Department of Health-Advancing Health through Evidence-Assisted Decisions (AHEAD); (2) Philippine Council for Health Research and Development; and (3) PhilHealth.

PHSD's external funding was used to support its research budget, in terms of personnel services and indirect costs, and to provide healthcare benefits for patients in rural and Geographically Isolated and Disadvantaged Areas (GIDA) sites.




### Program on Social and Political Change (PSPC)

In 2021, majority (63.8%) of the Program on Social and Political Change (PSPC)'s funding came from external sources, whereas 36.2% were from internal funds. Its two external funding sources are: (1) the 2021 General Appropriations Act (GAA) for Comprehensive Release (FCR), which supported its "Policy Studies for Political and Administrative Reform" project; and (2) the National Research Council of the Philippines (NRCP).



#### **Islamic Studies Program (ISP)**

Majority (57.1%) of the Islamic Studies Program's 2021 budget came from internal funding, but ISP was able to secure 42.9% in external funding from the Global Community Engagement and Resilience Fund (GCERF) through the Institute for Autonomy and Governance (IAG).



#### **Strategic Studies Program (SSP)**

Although majority (88.5%) of the Strategic Studies Program (SSP)'s funding came internally, SSP was also able to secure external funding (11.5%) from Konrad Adenauer Stiftung Philippines. SSP used this fund to finance speakers and moderators, transcribers, and documenters, among others for the podcasts/ webinars it conducted, as well as the expenses that were incurred in the publication production of these.
