VISION

The University of the Philippines Center for Integrative and Development Studies (UP CIDS) envisions itself as the premier hub of interdisciplinary and collaborative policy research on areas of local, national, regional, and global significance and the forefront link of the academe with stakeholders and policymakers.

MISSION

As stated in Executive Order No. 9 issued by former UP President Edgardo J. Angara on September 24, 1985, the objectives and functions of the Center are as follows:

- Develop, organize, and manage research issues of national significance. Such issues, because of their importance and inherent complexity, require an integrative and collaborative approach and also more sophisticated research methodologies and skills;
- Encourage and support research and study on these issues by various units of the University and individual scholars;
- Secure funding from public and private persons and agencies; and
- Ensure that the research outputs and recommendations of the Center are published and openly disseminated.



The Center

The University of the Philippines Center for Integrative and Development Studies (UP CIDS) was founded in 1985 by the late UP President Edgardo J. Angara. The UP President's Executive Order No. 9 on September 24, 1985 established UP CIDS as a policy research unit, harnessing the University's expertise and resources towards addressing problems of national significance through an integrative and collaborative approach and open dissemination.

Guided by the University's Strategic Plan 2017–2023, UP CIDS at present commits to fulfill its role as a policy research unit by (a) contributing to national development through knowledge creation and public service, and (b) promoting access and diversity through enhancing structures and policies for collaboration and undertaking internationalization efforts.

Research Programs

To more effectively carry out its research mandate, UP CIDS adopts a stable but highly adaptable programmatic structure where a sizeable network of scholars are brought together not only to address critical and long-standing national issues but to also accommodate research on new and emerging national policy concerns.

Presently carrying out the Center's policy research work are twelve (12) research programs that are clustered under the areas of (1) education and capacity building, (2) development, and (3) social, political, and cultural studies.

In addition to the twelve research programs, the UP CIDS, through its Local-Regional Studies Network (LRSN), has also supported projects of research centers in UP constituent universities, such as the Cordillera Studies Center (CSC) in UP Baguio and the Central Visayas Studies Center (CVSC) in UP Cebu.

The organization of scholars under research programs allows them to independently pursue their own research agenda and build their respective academic, industry, and policy networks. The constitution of multiple research programs under the UP CIDS, on the other hand, provides opportunities for and encourages collaboration.

The Core Staff

Housed in the UP CIDS Administrative Office and headed by the Executive Director, the UP CIDS Core Staff, which is in constant coordination with personnel from the UP CIDS research programs, provides administrative, finance, and publications support to all research initiatives of the Center. The Core Staff is functionally organized into (1) Administration, (2) Finance, (3) Publications, and (4) Library and Resources.

UP CIDS' COVID-19 Response

The COVID-19 pandemic has affected and influenced both the research and administrative activities of UP

CIDS as community lockdowns were implemented nationwide. The pandemic not only meant physical but also operational and financial restrictions to the activities of UP CIDS.

The Center's research programs, in response to the COVID-19 situation, needed to assess the feasibility of various components of their respective research agendas for 2020: (a) existing activities and projects which need to be postponed or cancelled; (b) those which may be linked with the COVID-19 emergency situation; and (c) new activities and projects which directly involve and address COVID-19 and its effects. These were all taken into consideration by early April. Corresponding adjustments to proposed outputs, budget details, and contractual arrangements were also made. Generally, major setbacks to earlier plans of the various UP CIDS research programs due to the pandemic were nevertheless accompanied by opportunities (a) to focus efforts into finalizing outputs from previously executed research activities and (b) for new policy research initiatives motivated by the programs' desire to contribute to efforts in addressing the pandemic.

Administratively, the UP CIDS Core Staff generally shifted to remote or online platforms for virtually all UP CIDS processes in order to accommodate the changing needs of the Programs as the COVID-19 situation progressed and as they modified their respective research agenda. Processes including those related to records management, office communication and collaboration, the renewal and granting of appointments, and the payment of salaries, goods, and services, among others were all carried out remotely. The UP CIDS Core staff has also consistently complied with and cascaded to all its concerned personnel issuances coming from the UP System Administration regarding official rules and instructions related to the University's and the government's COVID-19 response.

The UP CIDS Research Programs and Core Staff continue to take stock of developments in order to minimize setbacks and to more efficiently adapt existing systems and practices to the ever changing circumstances brought by the COVID-19 pandemic.

The Education Research Program (ERP) aims to contribute to the deeper understanding of education issues. In addition, the Program aims to understand the social issues that arise from reform through Filipino scholarship on education topics, current issues in the education landscape, and the nurturing, encouragement, and support of faculty researchers on education.

In 2020, the research themes of ERP studies will continue to focus on literacy and multiliteracy development and teacher professional development. New areas of research include impact studies of the Senior High School (SHS) Program and research partnerships on supporting oral language development among early learners. These studies can inform policies on how to foster schools that are also inclusive learning communities.

The content of the ERP's intended research was modified to include issues and concerns stemming from the implications of the COVID-19 pandemic to the education sector. The areas of curriculum, assessment, learning delivery, teacher development, school leadership, and governance concerns will most definitely be reevaluated as health protocols such as community quarantines, physical distancing, and prohibition of gatherings are being enforced.

To adjust to these changes in the education sector, the Program revised some of its project plans in

response to the present and future health behavior norms. Its focus has also shifted on the development of research articles, policy briefs, and monographs, while alternative platforms to conduct other activities are being explored.

Program Research Projects

The following are the research projects currently handled by the ERP, most of which involve the production of a research paper as its final output. They are in different stages of completion as of the first half of 2020.

Multiliteracy Assessments for Filipino Children

The study aims to develop sound and literacy assessments in different languages of the Philippines for learners of all ages. The present wave of test

development is for K to 3. Originally, two rounds of field trials for Filipino and English assessment tools will be conducted. However, due to the community quarantine, only half of the target cohort was reached. Adjustments on the protocols and the use of other platforms for the assessors training, meetings, and test administration will have to be created to continue with the field testing. Alternative data collection strategies will also be explored.

Senior High School (SHS) Studies

The Senior High School (SHS) Studies aim to build a research agenda on the SHS Program in collaboration with various institutions. Its objectives are (1) to investigate questions related to the following four components of the SHS program: learners, SHS curriculum, financing and partnerships, and teacher professional development/continuing professional development; and (2) to develop recommendations to improve SHS implementation. This 2020, the project prioritizes research questions in view of the COVID-19 pandemic. For instance, a paper on flexible learning options (FLOs) for SHS is currently being developed by the Program.

Partnership with Knowledge Channel Foundation, Inc. (KCFI)

ERP's partnership with the Knowledge Channel Foundation, Inc. (KCFI) through the Basa Bilang

Project, which aims to investigate the impact of technology-mediated learning on literacy development among primary grade learners in the schools division of Sta. Rosa Laguna, has been reconceptualized. The partnership shifts to supporting literacy learning in the early grades during the time of COVID-19.

Talk Together: A UK Research and Innovation-Global Challenges Research Fund (UKRI-GCRF) Project Study

In collaboration with the University of Oxford, this three-year research project that started in early 2020 focuses on supporting oral language development among early learners. It seeks to help crystalize ways of supporting child development, especially in low- to middle-income homes. Teacher professional development programs and interventions will also be designed, implemented, and evaluated in this project. The research procedures for this study include COVID-19 considerations.

IP Voices and Multilingual Education

In 2019, data were gathered from focus group discussions with elders and interactive activities with learners in the communities of the Iraya Mangyan of San Teodoro, Oriental Mindoro, and the Ayta Magindi of Porac, Pampanga on language appreciation.

Papers featuring language use of indigenous peoples (IP) and other related topics using data from three IP communities were produced during the first half of 2020.

Teacher Professional Development

The project with the HEAD Foundation on the use of Learning Action Cells (LACs) to improve the teaching learning process in STEM has produced data on teachers' content knowledge in several Grade 6 Science topics and their experiences in handling LACs in their respective schools. Research papers are currently being written by partners from the UP Integrated School (UPIS) and UP National Institute for Science and Mathematics Education Development (UP NISMED) based on the gathered data

Literacy Development Longitudinal Studies

Literacy development studies must continue even in the time of a pandemic to be able to advise education policy on how literacy competencies can be improved among learners. Research protocols will be revised in response to the changes which will have to be implemented during assessments. These studies seek to track how literacy competencies develop among learners in their mother tongues and in Filipino and English, as well as in sign language and Braille. These studies will also investigate how teachers can be helped to plan more effective literacy lessons for their students.

Basic Education COVID-19 Response

To examine and understand the issues affecting basic education during this COVID-19 pandemic, the following have been carried out: (1) collation and analysis of the Department of Education (DepEd) issuances and policies on remote learning as a response to the COVID-19 pandemic; (2) analysis of the DepEd assessment policies and how to adjust these for remote learning; (3) writing of a policy brief on examining learners' home context and its implications for remote learning; (4) production of a technical note on generating education resources during the COVID-19 pandemic; (5) translation into Filipino of resources on mental health and psychosocial support during pandemic; (6) translation of the UP College of Education COVID-19 Dictionary for Children into Sinugbuanong Binisaya; and (7) development of instructional videos for learners, teachers, and parents for remote learning.

Activities from January to June 2020

PAPER WRITING

Paper Writing from Results of Data Analysis on Learning Action Cells (LACs)

January 2020 to present

Data gathered from the workshops and school observations as part of the project on the use of LACs in improving the teacher learning process in science, technology, engineering and mathematics (STEM) was collated and analyzed together with project partners from UPIS, UP NISMED, and the UP College of Education (UPCEd). Individual analyses form part of the research papers on teachers' content knowledge of Science topics and their perceptions and experience about the LAC.

MEETING

Organizational Meeting with Partners for the Talk Together Project

13-17 January 2020

This meeting held at Oxford University was attended by project partners from the UP College of Education, Manipal Academy for Higher Education (India), and Oxford University (UK). It included a discussion on the specific details of the project, its project management structure, the first steps, and its impact strategy.

ENCODING

Encoding of Children's Language Word and Sentence Corpus for the Talk Together Project February 2020 to present

Encoding of a word and sentence corpus for children's language is being done now as the only research activity that can be done from home. Two research assistants are working on this part of the project from February 2020 to the present.

ORIENTATION AND TRAINING WORKSHOP

Assessors' Orientation and Training Workshop on Multiliteracy Assessments for Filipino Children

12-14 February 2020

For the second field trial of the Multiliteracy Assessments for Filipino Children, twenty-three (23) new and old assessors were oriented and trained on February 12–14, 2020 at the UP CIDS Conference Hall. Videos on how to use the assessment tools were shown to demonstrate proper administration. Assessors also helped in collating and preparing materials needed for the field trial.

FIELD TRIAL

Field Trial of the Multiliteracy Assessments for Filipino Children (Second Round)

17 February to 06 March 2020

A second field trial of the Multiliteracy Assessments for Filipino Children was conducted from February to March 2020 at Esteban Abada Elementary School, and at the Play, Learn, and Serve Center. The assessors administered the tools either individually or as a group to a total of 68 students. The data gathered by the assessors were encoded. Recordings were transcribed in preparation for data analysis. The field trial at the Play, Learn and Serve Center was discontinued, while the one at UPIS has been cancelled due to the COVID-19 pandemic.

ENCODING AND DATA PROCESSING

Processing of Field Trial Data

March to April 2020

Data gathered from the first round of field trials were processed to facilitate analyses on assessment item difficulty and discrimination. Data from the second round of field trials from Esteban Abada Elementary School are currently being encoded.

TRANSLATION

Translation into Filipino of Resources on Mental Health and Psychosocial Support during Pandemic

March to June 2020

Resources used by the Psychosocial Support and Children's Rights Resource Center (PST CRRC) on mental health during the health crisis were translated from English to Filipino. These resources include videos from Child Protection—Area of Responsibility (Global Protection Cluster), and posters and infographics from the Philippine Association for Child and Play Therapy and the World Health Organization. The translations were validated by an expert from PST CRRC and were used in webinar presentations with parents and caregivers. Selected translations will be printed and distributed to affected communities.

PAPER WRITING

Submission of Paper on IP Voices

25 March 2020

The paper from the ERP IP Voices Project entitled "Language Appreciation Among Elders and Learners from Indigenous Peoples Communities" was finalized and submitted for online publication to the British Council on March 25, 2020.

POLICY RESEARCH

Policy Research on Flexible Learning Options for Senior High School

April to June 2020

Research was conducted on existing policies on education in emergencies (EiE), use of information and communication technologies (ICTs) to deliver education to children affected by crises, and flexible learning options (FLOs) to map out possibilities in using alternative educational strategies to deliver SHS education in the Philippines in the time of COVID-19 and beyond.

DATA GATHERING AND ANALYSIS

Review of Studies on Literacy DevelopmentApril to June 2020

A review of literature on literacy domains, existing assessments, and online assessments vis-à-vis paperand-pen assessments was conducted. This will serve as basis for future outputs on literacy development.

DATA GATHERING AND ANALYSIS

Collation and Analysis of DepEd Issuances and Public Pronouncements on Remote Learning as a Response to the COVID-19 Pandemic

April to May 2020

DepEd's policy issuances and public pronouncements on remote learning as a response to COVID-19 were collated and analyzed through a matrix in order to identify gaps that need to be addressed.

DATA GATHERING AND ANALYSIS

Analysis of DepEd Assessment Policies and How to Adjust these for Remote Learning during the COVID-19 Pandemic

April to May 2020

DepEd's policies on various assessments were identified and analyzed to identify possible interventions and adjustments that can be made for remote learning during the COVID-19 pandemic.

TRANSLATION

Translation of the UPCEd COVID-19 Dictionary for Children into Sinugbuanong Binisaya

April to June 2020

In cooperation with a group of teachers from Visayas and Mindanao, a Sinugbuanong Binisaya translation of the UPCEd COVID-19 Dictionary for Children was drafted. The initial translations were then sent for

validation to at least 40 children and their parents in Cebu, Davao, Dipolog, Dumaguete, Iligan City, Southern Leyte, and South Cotabato. Revisions to account for regional differences and other validation findings were implemented. This version was then reviewed by a medical doctor, a market researcher, and a Visayan writer, who also served as proofreader.

MEETING

Virtual Meeting with Knowledge Channel Foundation, Inc.

24 April 2020

To define the partnership between the ERP and the Knowledge Channel Foundation, Inc., a virtual meeting was held on April 24, 2020. In this meeting, it was agreed upon that the focus of the partnership would be on research about supporting early literacy during the COVID-19 pandemic.

MEETING AND PAPER WRITING

Research on Examining Learners' Home Context and its Implications for Remote Learning

May 2020

Based on a review of literature and analysis of DepEd issuances, a presentation of the draft paper on the learners' context at home and possible learning interventions was conducted last May 21, 2020. In

this meeting, the outline of the research was refined and revisions were agreed upon.

MEETING

Meeting with Collaborators on Generating Education Resources in COVID-19 Pandemic June 2020

In collaboration with Mark Abinsay of UP Los Baños and Dr. Aser Javier of Nagoya University, research was conducted on education resources during this COVID-19 pandemic. A virtual meeting was held to discuss updates on its preliminary validation and to finalize content for the resulting technical note.

CONTENT DEVELOPMENT

Development of Instructional Videos for Learners, Parents, and Teachers for Remote Learning

June 2020

A face-to-face meeting with other volunteer individuals and organizations was held for the Office of the Vice President (OVP) of the Philippines' initiative to support the needs of teachers, parents, and learners on distance or remote learning during the pandemic. The participants identified instructional video topics and subject matter experts for the videos. A series of virtual meetings will be conducted with experts, production teams, and OVP focal persons to develop and finalize the video outputs.

Upcoming Activities and Outputs for July to December 2020

will be explored. The various projects will focus on literature reviews and paper writing until such time that restrictions are lifted. A communications plan will also be laid out in order to continue the dissemination of the Program's researches.

Sípat Edukasyon 2020

An online version of the Sípat Edukasyon forum will be organized and held in November 2020. It will focus on research activities conducted by ERP for 2020, as well as the measures done by schools to adjust to the demands of remote learning arrangements.

IP Voices and Multilingual Education

The data and results of the study on IP voices in MTB-MLE will be validated with the Ayta Magindi community in Porac, Pampanga via online conferencing. Additionally, interviews with teachers and learners will be conducted via landline or online voice/video call to supplement the information that were previously gathered from elders and learners.

Literacy Development Longitudinal Studies

Research protocols will be developed considering the information gathered from a review of related literature and pressing concerns in current contexts.

Professor, College of Mass Communication, University of the Philippines Diliman The Program on Higher Education Research and Policy Reform (HERPR) aims to chart a research agenda, systematically build an evidence base for policy analysis, and create a network of experts and researchers doing work in the higher dducation sector. The program also serves as a convening body which seeks to build partnerships and working collaborative networks among key stakeholders.

As part of a series of research agenda-setting workshops, the Program had an initial consultation with Director Nelson Cainghog of the Commission on Higher Education (CHED) regarding pressing issues in higher education management. However, the other scheduled workshops were postponed due to the COVID-19 health crisis. A virtual roadshow will be conducted in lieu of these workshops.

New collaborations were established in response to the pandemic, such as a partnership with the UP CIDS Education Research Program (ERP) and Assessment, Curriculum, and Technology Research Program (ACTRP) on building a database on content released by education stakeholders. This project will daily monitoring, archiving, instrument development, and database construction. It aims to aid researchers in conducting education research during the pandemic. Another contribution of the Program in light of the COVID-19 pandemic is a policy brief discussing a two-pronged strategy to solve the shortage of healthcare professionals in the country.

The Assessment, Curriculum and Technology Research Program (ACTRP) is a joint research program between the Assessment Research Centre (ARC) of the University of Melbourne (UoM) and the University of the Philippines. In 2019, the ACTRP formally became a Program under the UP Center for Integrative and Development Studies (UP CIDS). The ACTRP advises and informs the Philippine education system as major curricular reforms are being rolled out by the Department of Education (DepEd). Its present focus is the review of the K to 12 basic education curriculum.

The period from January to June 2020 was marked by major disruptions in the research activities of the Program due to work suspensions related to the eruption of the Taal Volcano and the COVID-19 pandemic. Despite this situation, the ACTRP was able to work on its research projects and continued providing technical support to DepEd. The senior management team set up regular weekly meetings and allowed staff to work from home during the community quarantine. Data collection for the K to 12 Curriculum Review and for the Language Match Study in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) proceeded, albeit with challenges and difficulties. A no-cost extension was requested for one project that was due in July 2020. Likewise, the ACTRP actively participated in planning initiatives in support of DepEd's Learning Continuity Plan.

Activities from January to June 2020

TRAINING

Training of Test Administrators for the Baseline Study on Language Match and Teacher Assignment in BARMM

21 January (Maguindanao), 22 January (Tawi-tawi), 24 January (Sulu), 27 January (Basilan), and 16 February (Lanao del Sur) 2020

The ACTRP trained a total of 45 Test Administrators (TAs) for the Baseline Study on Language Match and Teacher Assignment in the BARMM, which seeks to explore the congruence between pupils' mother tongue and the different aspects of instruction, as well as the match between teachers' preparation and their actual teaching assignment. The TA training involved personnel recommended by the ACTRP's partner educational institutions and a non-governmental organization. The TAs were trained in administering the Semantic Fluency Test to Kinder to 3 pupils and a

survey to teachers, Mother Tongue-based Multilingual Education (MTB-MLE) school coordinators, and school heads.

DATA GATHERING

Data Collection for Phases I and II of the Baseline Study on Language Match and Teacher Assignment in BARMM

22 January to 10 March 2020

In Phase 1, the trained TAs were deployed to a number of randomly selected elementary schools within the different Schools Division Offices (SDOs) of the Ministry of Basic, Higher, and Technical Education (MBHTE) particularly in Basilan, Lanao del Sur, Maguindanao, Sulu, and Tawi-tawi. Data collection for Phase 2 involved two case studies. The case schools were visited for the administration of Language Attitude Survey to K to 3 pupils, class observations, school and community tour, an FGD with parentleaders, and interviews with SDO and school personnel. The second phase provided the research team a deeper understanding of Phase 1 findings.

FOCUS GROUP DISCUSSION

Curriculum Review Project: Work Package 2 (Round 2)

11 & 13 February 2020

The second component of the Curriculum Review Project focused on the review of the

implemented curriculum. Focus group discussions (FGDs) were designed to explore how teacher training and school leadership influence the implementation of the K to 12 curriculum in different school contexts. Teachers from one DepEd division in NCR and from two divisions in Region XI participated in three FGDs. The participants represented those who teach learners in Grades 3, 6, 10, and 12.

FORUM

Mindanao: Fractured Promises, Continuing Challenges

20 February 2020

The ACTRP, together with the UP CIDS Program on Alternative Development (AltDev), Program on Social and Political Change (PSPC), Islamic Studies Program (ISP), Political Economy Program (PEP), Decolonial Studies Program (DSP), and Program on Escaping the Middle-Income Trap: Chains for Change (EMIT C4C), held the first installment of the "Mindanao: Fractured Promises, Continuing Challenges" forum series. In this installment, experts, academics, and indigenous peoples' representatives discussed issues on the political economy of Mindanao, agricultural value chains, ancestral domains and resource use, and the struggle of indigenous peoples for land and education rights.

ONLINE WORKSHOP

K to 3 Curriculum Review

27 March 2020

Another component of the Curriculum Review Project was the review of the K to 3 curriculum in the Philippines. The objective of the workshop was to identify the foundational competencies in Numeracy (Mathematics) for each target grade level. The activity was attended by specialists from the DepEd Bureau of Curriculum Development and Bureau of Learning Delivery, as well as education experts from Nanyang Technological University, the University of Melbourne, and the UP College of Education.

REVIEW ACTIVITY

K to 12 Most Essential Learning Competencies Quick Review

27 April to 05 May 2020

To ensure learning continuity despite the COVID-19 pandemic, the DepEd released the Most Essential Learning Competencies (MELCs) for use in distance learning. MELCs are characterized as learning competencies that are considered to be enduring and needed for lifelong learning. The DepEd Bureau of Curriculum Development requested for a quick review of the learning competencies for Quarters 1 and 2. Faculty from the UP Integrated School, UP College of Education, UP College of Music, and University of Melbourne were tapped to review

Orientation on Micro-credentialing

17 June 2020

An orientation on micro-credentialing was delivered by Enterprise Professor Sandra Milligan, Project Team Lead/Project Director and Technical Expert (Micro-credentialing), before the DepEd ALS and UNICEF teams. Her overview focused on what micro-credentials are and how these are used for assessment of skills for employability and for recognition of prior learning.

Upcoming Activities for July to December 2020

Data Gathering for K to 12 Curriculum Review (Round 3)

Data gathering for K to 12 Curriculum Review (Round 3) was affected by the COVID-19 pandemic. The

survey questionnaires were sent via courier last March 13, 2020, days before the implementation of community quarantine in the Philippines. This impeded the distribution of the questionnaires to participating schools. Also, school point persons had difficulty getting the forms in the office and distributing them to teachers. To cope with this situation, the team is creating an online version of the survey questionnaires as an alternative to the paper-and-pen version that was previously sent to schools. The team is also extending the deadline of submission from March 27, 2020 to July 15, 2020. No focus group discussion was done for Round 3.

Feasibility Study on Micro-certification for the Alternative Learning System (ALS)

The ACTRP will continue its collaboration with UNICEF and DepEd for the micro-certification for the ALS. Ongoing meetings are held by the research team, together with UNICEF representatives and the DepEd-ALS Task Force to determine the content of the Inception Report.

It has been agreed that a Capabilities Framework be developed to underpin the micro-credentials, building around the capabilities covered in the current ALS Life Skills modules.

Consultation with stakeholders and employer groups will be conducted on the approach to judge trust and acceptability. Possible targets to consult are local government units (LGUs), the Technical Education and Skills Development Authority (TESDA), the Department of Trade and Industry (DTI), the Department of Social Welfare and Development (DSWD), various Chambers of Commerce, non-government organization (NGO) ALS providers, and the National Literacy Council.

Exploration of existing assessments will be done in order to come up with a proof of concept. Pilot-testing with ALS learners will be conducted, and a roadmap will be co-developed for full implementation.

COVID-19 Response Support

The ACTRP will engage in capacity building activities with DepEd to support the implementation of its Learning Continuity Plan, which requires teachers to focus on MELCs and prepares for a shift to distance and blended teaching and learning modalities due to COVID-19 restrictions. It will also provide advice and support in the areas of curriculum and assessment.

Learning and assessment blueprints to increase alignment between learning activities and assessments will be produced for English, Mathematics, and Science for Grades 3, 6, 10 and 11 The blueprint production will be undertaken jointly with staff from BLD and BCD. The recruitment of subject matter experts from the University of the Philippines and the University of Melbourne is underway.

The ACTRP and Education Technology faculty of the UP College of Education will conduct a Basic Video Production Training for DepEd personnel to support DepEd's plan to use television-based instruction for distance education.

Stakeholders' Forum on Language Match and Teacher Assignment in BARMM

A stakeholders' forum will be conducted by the ACTRP to present the results of the Baseline Study on Language Match and Teacher Assignment in BARMM. To be held in December, the forum will share important findings of the study and offer recommendations for DepEd and MBHTE's policy on MTB-MLE and teacher deployment. The forum will be delivered virtually via online streaming platforms that could support the target number of invitees. The expected audience shall be composed of personnel from the regional, division, and school levels of DepEd and MBHTE, and partners in the development sector.

Associate Professor, Department of Political Science, College of Social Sciences and Philosophy, University of the Philippines Diliman The Program on Data Science for Public Policy (DSPP) has three objectives. The first is to build the capacity of University of the Philippines (UP) faculty in data science, and apply this learned skill to public policy and governance. Secondly, to engage a community of researchers within the university and encourage the pursuit of interdisciplinary problemoriented research using high-level quantitative analyses. Finally, to convene multidisciplinary teams of social scientists, humanists, and scientists to conduct research on issues in the public sector.

The Program planned to pursue a number of research and capacity-building activities on data science tools and methods during the first half of 2020. However, due to the COVID-19 pandemic, these activities did not push through as planned. Some of these activities were a roundtable discussion on data and policy research with former National Statistician Dr. Lisa Grace Bersales as primary resource speaker and a training-workshop on policy analysis using data science methods and tools.

As part of UP's effort to push forward a "One UP" brand in response to COVID-19, the DSPP, together with the UP CIDS Program on Escaping the Middle-Income Trap: Chains for Change (EMIT C4C), initiated the development of a 'data lake' with the Department of Trade and Industry (DTI)—Board of Investments (BOI) and the Department of Information and Communications Technology (DICT). The project aims

to generate useful data that will help address looming socio-economic issues due to COVID-19. Through the UP Diliman COVID-19 Task Force, the project will also contribute to local responses against the pandemic.

Escaping the Middle-Income Trap: Chains for Change (EMIT C4C) spearheaded the creation of the Advanced Information Integration Platform (AIIP). The AIIP is a multisectoral collaboration between the government, the academe, the private sector, and volunteer individuals to help plug numerous information gaps in the country's COVID-19 response. This endeavor aims to build a 'data lake' in an attempt to provide real-time data for evidence-based policymaking in addressing the effects of COVID-19 in the Philippines.



The Program plans to form collaborative linakges with discourse analysis and digital humanities experts from the UP Diliman College of Arts and Letters (CAL) to expand its disciplinal reach. A roundtable discussion (RTD) on data science tools for the humanities is slated in the latter half of the year.

Trainings and Workshops for UP CIDS Research Program Staff

Given the need for data-based policymaking in response to COVID-19, the Program is planning to hold exclusive trainings and workshops on data science tools and methods for UP CIDS Program research staff.

Through inclusive science, the Program conduct three types of research: big data analytics on manufacturing and exports; action research on agriculture value chains; and action research on business for peace in Mindanao. It provides opportunities for partners to share lessons in program and policy implementation and to engage in collaborative problem-solving efforts.

The Program intended to continue its three major projects for the first half of the year. From January to February 2020, it laid the foundations for inclusive science with its partners. However, COVID-19 changed the Program's priorities, as it shifted gears by leading a multi-stakeholder collaboration on big data to inform decisions during the pandemic. The EMIT C4C also started a policy blog that connects the themes of its research projects with the impact and implications of COVID-19.

Program Research Projects

Big Data Analytics

(In partnership with the Department of Trade and Industry–Board of Investments)

The Program conducted an on-site updating of the merged datasets from trade-transactions and establishment surveys of the Philippine Statistics Authority (PSA) done from 2013 to 2019. It regularly went to the PSA from January 2020 until the implementation of the enhanced community quarantine (ECQ) in March 2020. It also partnered with the Philippine Competition Commission (PCC) for a project on big data analysis on market competition.

The EMIT C4C also led a multi-stakeholder collaboration on big data in partnership with different government agencies, the private sector, civil society organizations, and different offices within the University of the Philippines. The collaboration, dubbed as "Data Science Para sa Bayan (DSPB)," entails the setup of a data lake that will contain real-time information to inform public policy.

Action Research on Agriculture Value Chains

With the community quarantine measures prohibiting travel and mobility for fieldwork, the Program temporarily shelved its action research plans while maintaning its engagement in agriculture, particularly in the monitoring of rice supply in the time of pandemic. This resulted in the submission of short pieces related to agriculture, which became part of the Program's policy blog. These were also presented to decisionmakers at the Department of Agriculture (DA), the Department of Trade and Industry (DTI), and other stakeholders.

Business-4-Peace

The EMIT C4C continued its Business-4-Peace initiative in Mindanao in partnership with the Hineleban Foundation, the Rotterdam School of Management, and the Netherlands Embassy in Manila. The Program submitted a final project

report in February 2020. EMIT C4C Co-convenor Dr. Annette Balaoing-Pelkmans also submitted a monograph on the Unifrutti case study to UP CIDS and a teaching case to the Rotterdam School of Management.

NETWORK-BUILDING

MOA Signing for Big Data Analysis for Monitoring Market Competition

22 January 2020

The Program signed a memorandum of agreement with the PCC, the PSA, and the Regulatory Reform Support Program for National Development (RESPOND) of the United States Agency for International Development (USAID) for a research project that uses big data on firms and transactions for monitoring market competition in the country. EMIT C4C Convenor Dr. Karl Robert Jandoc delivered a presentation at the signing and on a separate checkpoint meeting held on February 27, 2020.

ACTION RESEARCH VALIDATION

Action Research Validation on KGMC Case 22-25 January 2020

The EMIT C4C and the Peace and Equity Foundation conducted fieldwork in Kabasalan, Zamboanga

Sibugay to validate its action research findings with the fisherfolk group Kapunungan sa Gagmay'ng Mangingisda sa Concepcion (KGMC). Program researchers Tara Abrina and Jane Capacio and PEF officer Andrew Orocay discussed with KGMC leaders and members and other stakeholders the nature of their value chain, the motivations of group leaders, the role of trader-members, and other findings of the action research, which the fisherfolk group validated to be accurate. The attendees also added their insights, which, in turn, were documented by the EMIT C4C and the PEF.

TRAINING

Impact Team Training on Conducting Action Research

21 February 2020

The EMIT C4C (represented by Dr. Emmanuel De Dios, Dr. Annette Balaoing-Pelkmans, Jane Capacio, and Tara Abrina) organized the first of a series of impact team trainings aimed at equipping the Program's partners to conduct action research. Representatives from the Jollibee Group Foundation, PEF, and Unifrutti actively participated in the training, which covered topics such as validity and reliability issues and quantitative and qualitative methods in action research, among other topics. The training also included exercises in computing farmers' costs and in qualitative coding of data from interviews.

ONLINE PRESENTATION

Presentation on the Rice Industry and the COVID-19 Pandemic

30 April 2020

Based on secondary data and interviews with rice millers, traders, and farmers, the EMIT C4C, through Program researcher Jane Capacio, wrote a paper that surfaces different issues faced by the rice industry in light of the COVID-19 pandemic and offers possible ways forward. The summary of the paper was presented to attendees from the DSPB project, including professors from the UP School of Economics, Mayor Eduardo Guillen of Piddig, Ilocos Norte, government officials, and representatives from the private sector.

ONLINE BRAINSTORMING SESSION

Brainstorming on Philippine Rice Data 12 May 2020

EMIT C4C invited Dr. Roehlano Briones of the Philippine Institute for Development Studies (PIDS)

to share his expert knowledge on the state of data on rice in the Philippines with members of the with DSPB. In the presentation, Dr. Briones noted that the Rice Tariffication Law (RTL) changed the landscape of the rice industry and that there is a need for real-time data to be able to estimate the rice supply, especially during the pandemic.

MEETING

DA-DTI-UP Meeting on the BayanAnihan App 23 June 2020

During a high-level meeting attended by top officials of the DA, the DTI, and UP, EMIT C4C Co-convenor Dr. Annette Balaoing-Pelkmans presented the BayanAnihan app and explained how data on farmers and fisherfolks will be integrated to the data lake initiative of the DSPB.

Upcoming Activities and Outputs for July to December 2020

Program and Project Plans

For 2020, the EMIT C4C planned to continue the conduct of its action research on agriculture value chains with its partners. It originally purposed to have four (4) sessions of impact team trainings within the year to build the capacity of partners in undertaking action research, data gathering through fieldwork, and co-creation of knowledge products. However, with lockdowns limiting the conduct of fieldwork, the Program is now working with the JGF and the PEF in scoping the access of farmers and fisherfolk groups to gadgets, cellular signal, and internet connectivity, as well as their capacity to use online communication platforms (e.g., Facebook Messenger, Zoom). The EMIT C4C, in agreement with JGF and PEF, might reconsider the continuation of the ongoing action research and focus instead in releasing the results of the research thus far.

In partnership with JGF and their Farmer Entrepreneurship Program (FEP), the EMIT C4C will serve as an academic partner of the FEP in doing adaptive learning and collaborative monitoring and evaluation.

As planned, the Program will continue its partnership with PCC on big data and market competition. It will

also continue its engagement with the UP CIDS DSPP, particularly in ensuring the transition of the app and the data lake to the institutions that will manage public goods.

The Program's partnership with the Hineleban Foundation and the Netherlands Embassy in Manila will continue with efforts to collaborate with key leaders of the Northwestern Mindanao Front (NWMF) of the MILF in surfacing the needs of and exploring opportunities for communities. Within the period, the partners will plan on how to go about the implementation of the project given the restrictions in movement in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

The plans to launch another Executive Training Program this year was halted because of the pandemic. The first session was originally scheduled in July 2020. There are no discussions yet within the Program regarding its resumption.

Activities

The Program intends to conduct online validation of the action research cases that were nearly finished before the community quarantine. These include the case studies of Alabat, Quezon (with the JGF) and Kabasalan, Zamboanga (with the PEF). The dates of for these sessions will be scheduled with EMIT C4C's partners.

EMIT C4C will also spearhead the online pilot rollout of the BayanAnihan app together with JGF partners. Likewise, the Program, together with the DA and other partners, will also roll out the app in the province of Nueva Ecija.

The Program will also hold online discussions and presentations to resume conversations with its partners for the Business-4-Peace project.

Associate Professor, Asian Center, University of the Philippines Dilima The Political Economy Program (PEP) adopts an interdisciplinary approach to the study of development policies and praxis, focusing on research that examines the interaction between state and market as well as facilitating academegovernment-industry-civil society linkages aimed at promoting innovation-driven and equitable development. It seeks to help strengthen policy reforms aimed at advancing equitable development; promote an inclusive and innovation-driven industrial policy; and contribute to the popularization of the use of the political economy perspective in the study and resolution of development and economic problems.

Continuing its efforts to contribute to policy reforms strengthening domestic industries, the PEP started its research on the following areas for January to June 2020: (1) Philippine industrial policy; (2) health and the pharmaceutical industry; and (3) smallholder agriculture. In light of the COVID-19 pandemic, the Program expanded the scope of the research in these areas to include the impact of the pandemic on these industries and on how new challenges can be best addressed.

The PEP's activities for the year have also been adjusted in response to the pandemic. Roundtable discussions, where stakeholders from the academe, government, and industries discuss common industry concerns and objectives, will be moved to an online platform. Network-building activities that aim to

sustain partnerships forged last year in and outside of UP has been continued using online platforms. Along this line, the PEP has kept its engagement in the Philippine academic-civil society process leading up to the United Nations Conference on Trade and Development (UNCTAD) XV.

The Program on Alternative Development (AltDev) seeks to look at paradigms, policies, practices, and projects that are largely marginalized and excluded from the mainstream. As these alternatives challenge dominant modes, they do not figure prominently in the national and international discourse. The Program aims to bring these voices out of the margins and into the mainstream and to level the playing field so that they may be regarded on equal footing with dominant discourses and thus offer alternatives to the existing system.

The Program continues its focus on documenting and mainstreaming alternative practices, aiming to elicit lessons from the ground, draw intersectionalities among experiences, and build solidarity between and among the peoples of Southeast Asia. It also organizes and participates in activities and avenues that highlight participatory and people-centered development approaches, and endeavors to bring alternatives to the forefront of policymaking.

The COVID-19 pandemic affected the Program's planned activities for the past few months and prompted it to adopt vital pandemic-related activities to be implemented throughout the rest of the year. The shifted focus to the documentation of and support to laudable COVID-19 responses of communities across Southeast Asia dovetail the thrust of the Program towards building solidarity among different grassroots organizations in the region.

Program Research Projects

Project on Alternative Practices in Southeast Asia

This project aims to document cases of alternative practices by grassroots peoples and communities in Southeast Asia and to link these initiatives to form the building blocks of a peoples' alternative regional integration. Despite the COVID-19 pandemic, the Program will continue to document and shed into light examples of alternative practices in the region.

Project on Transformative Social Protection

This project aims to advance a concept of universal, comprehensive, and transformative social protection and promote development alternatives towards the fulfillment of peoples' economic and social rights and the realization of social justice. This project is undertaken together with the Network for Transformative Social Protection (NTSP) and Buhay na May Dignidad Para sa Lahat (DIGNIDAD).

UNESCO Project on Knowledge Mobilization and Intercultural Dialogue Promoting Gender Equality and Women Empowerment in Pastolan and Magbukun Ayta Villages in Bataan, Philippines

This project, which will draw learnings from the Pastolan Ayta and the Magbukun Ayta communities

in the province of Bataan, aims to contribute in the realization of sustainable, inclusive, and equitable societies through processes that work towards the institutionalization of good practices and development of appropriate policies and programs promoting gender equality, women empowerment, and active youth participation.

"Mindanao: Fractured Promises, Continuing Challenges" Forum Series

In February 2020, several research programs of the UP CIDS launched the first leg of a forum series titled "Mindanao: Fractured Promises, Continuing Challenges." The forum sought to highlight pertinent issues affecting the peoples of Mindanao. In the first installment of the forum, experts and community members discussed political and development issues in the region. The second installment of the forum, which was originally slated in March 2020, was postponed indefinitely due to health and safety measures implemented against COVID-19.

COVID-19 Watch and Documentation Activities

Seeking to provide a comprehensive picture of effective alternatives to government responses to the COVID-19 pandemic, the Program released a preliminary report on the situation of Southeast Asian peoples which was gathered through consultations and collaboration with partner organizations and communities. The AltDev and its partners will regularly

update the report based on developments on the ground. Several members of the Program contributed to "Kwentong Kwarantin," an online podcast which discusses how the lives of ordinary Filipinos were affected by the imposition of quarantine measures in light of COVID-19.

LECTURE

Contentious Migrants: Transnational Migrants and the Making of the Filipino Diaspora

14 January 2020

Dr. Sharon M. Quinsaat (Department of Sociology, Grinnell College) delivered a lecture that seeks to explain how the Filipino diaspora is formed. With Filipinos seeking employment abroad to support their families and eventually migrating to other countries, Dr. Quinsaat shows that migration alone does not create a diaspora and that they must be constructed through the formation of a collective identity, which, in one way, could be done through activism.

BOOK LAUNCH

Counterrevolution: The Rise of the Global Far Right

20 January 2020

In partnership with the Focus on the Global South, Laban ng Masa, and the International Peace Bureau, the AltDev co-sponsored the launch of the book *Counterrevolution: The Rise of the Global Far Right* by Dr. Walden Bello, Professor of Sociology at the State University of New York at Binghamton and former representative of Akbayan Partylist. In this book, Dr. Bello deconstructs the challenge from the extreme right across the globe by deploying what he calls the dialectic of revolution and counterrevolution.

LECTURE-FORUM

Market, State, and Society in North Korea 18 February 2020

In this lecture-forum, Dr. Andrew Yeo (The Catholic University of America) discussed the shifting relationship between state, society, and markets under North Korea's authoritarian regime. Dr. Yeo talked about ongoing developments in the country and how private market players and the state relate to one another and shape North Korea's economy and society.

Program and Project Plans

For the period from July to December 2020, the AltDev will continue its engagement with different civil society groups across Southeast Asia, even in light of the COVID-19 pandemic. how alternative practices of different communities work on the ground.

Aside from the Program's planned activities, the Program was also on board with other initiatives, including a conference on resettlement governance organized with the Department of the Interior and Local Government (DILG) and other relevant stakeholders. It also planned a number of occasional lectures and forums featuring various speakers.

However, due to the COVID-19 pandemic, the AltDev was forced to recalibrate its activities, including field visits, people-to-people exchanges, and the annual regional conference on alternatives in Southeast Asia.

The AltDev will focus its activites and events on COVID-19 responses, while continuing to build solidarity among Southeast Asian peoples through the projects that it will conduct this year. These projects and activities will be done with support from partners, such as 11.11.11, UNESCO Jakarta, and Rosa Luxemburg Stiftung.

COVID-19 Research

For the second half of the year, the Program will conduct research on the impact of COVID-19 on different communities and groups in the Southeast Asian region. It plans to conduct a documentation of COVID-19's impact in selected urban poor and indigenous peoples' communities. Aside from documentation, the AltDev will likewise contribute in terms of providing support to community partners in order to help in COVID-19 mitigation.

While this mission applies scientific rigor to parts of health systems, the goal is to improve the whole in terms of overall performance and outcomes. Its flagship project is the Philippine Primary Care Studies (PPCS).

The PPCS is a series of studies that aims to strengthen primary care systems and monitor the impact of health system reform in three pilot settings: urban/corporate (UP Health Service, UP Diliman), rural (Samal, Bataan rural health unit-barangay health station (RHU-BHS) network and private partners), and remote (Bulusan, Sorsogon RHU-BHS network and private partners). Its general objective is to evaluate the shift to a comprehensive universal social health insurance-funded primary care system on eight (8) main outcome areas: utilization of benefits, financial risk protection, hospitalization rate, quality of care, patient satisfaction, health care provider satisfaction, health care worker knowledge, and administrative efficiency.

The COVID-19 pandemic led to the modification of the methodologies of the Program's studies in order to ensure the safety of its research staff and its partner communities. It also provided an opportunity to explore novel strategies to help the Philippine health system adapt to the challenges brought about by the new infectious threat, including teletriage/telemedicine and task shifting in RHUs and BHSs.


Bulusan, Sorsogon Site Visit



The ISP's objectives are being accomplished through three primary research components: (1) Historical and Islamic Knowledge for the Modern Age (HIKMA), (2) research on Shari'ah, and (3) The Moro Story.

The ISP committed to continue most of its key research projects under the three research components through nine projects in 2020, five of which are continuing projects. But in light of the COVID-19 health crisis, significant adjustments have to be made to the Program's plans and activities.

Program Research Projects

Historical and Islamic Knowledge for the Modern Age (HIKMA)

The pre-COVID-19 plan for the HIKMA include the following projects: (1) "A General Survey of Cross-Cultural Pollination of Islamic Arts and Traditional Crafts in Southern Philippines and North Borneo," (2) "Peacebuilding through History Education" (Part 2), and (3) "The Moro Story" Book Project (Year 2).

For the first project, a webinar titled "Filipino Heritage, Loanwords, and Islamic Tradition" was conducted. The planned national conference on peacebuilding through history education will be replaced by a series of online focus group discussions (FGDs) in the second half of the year. The book project will continue in partnership with new publishing groups.

Research on Shari'ah

The pre-COVID-19 research projects for this component are (1) "Islamic Banking and Finance Implementation Clauses" and (2) "Amendments to PD 1083 to a Republic Act (Expanded Provisions and Recommendations)," in partnership with the research arm of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM). However, these projects have to be withheld at this time due to current restrictions in travel and contact with the target participants.

The Moro Story

The projects in this component include (1) "Philippine Muslims in Sabah, Malaysia: A Jalan-Jalan Research on Themes and Issues Affecting the Philippine Islamic Arts," (2) "An Anthology of Expositions on Sulu Archipelago Oral Literature" (Part 2), (3) "Preventing and Countering Violent Extremism (PCVE) in the Philippines: Best Practices and Challenges," and (4) "Madrasah Education Program Training of Trainers: Selected ALIVE Teachers in Jolo, Sulu." New projects under this research component are webinars on Philippine democratization and the Muslim question, a series on institutional contingencies for the "new normal," and training for Madrasah teachers. These new topics are aimed to respond to the new way of doing things in several institutions for and in the community life of Muslim Filipinos.

FORUM

Mindanao: Fractured Promises, Continuing Challenges

20 February 2020

The ISP, together with the UP CIDS Program on Alternative Development (AltDev), Political Economy Program (PEP), Program on Social and Political Change (PSPC), Decolonial Studies Program (DSP), Program on Escaping the Middle-Income Trap: Chains for Change (EMIT C4C), and the Assessment, Curriculum, and Technology Research Program (ACTRP), held the first installment of the "Mindanao: Fractured Promises, Continuing Challenges" forum series. In this installment, experts, academics, and indigenous peoples' representatives discussed issues on the political economy of Mindanao, agricultural value chains, ancestral domains and resource use, and the struggle of indigenous peoples for land and education rights.

COMMUNITY INVOLVEMENT

Relief Operation to UPD Muslim Students and Nearby Communities

17 & 25 March and 02 April 2020

The faculty, staff, and graduates of the UP Institute of Islamic Studies (UP IIS), in partnership with the ISP and volunteer individuals, conducted a series of relief operations to provide food supplies to Muslim students affected by the implementation of the enhanced community quarantine (ECQ) in Metro Manila. The project was primarily intended to help graduate and undergraduate Muslim students from Mindanao who were stranded at the UP Diliman campus. It was a first responder relief operation which lasted for three consecutive weeks, until more help came from families of the students, the government, and the private sector. The relief operation was also extended to the Muslim community at Barangay Culiat in Quezon City as more donations poured

Upcoming Activities and Outputs for July to December 2020

Projects

Three (3) of the Program's research projects will continue for the period from July to December 2020. In addition, two (2) new projects ("Filipino Heritage, Loanwords, and Islamic Tradition" and "Philippine Democratization and the Muslim Challenge") and one (1) response to the current global health crisis ("Institutional Contingencies for the New Normal") will be implemented. Activities

For the HIKMA projects, a webinar and a series of FGDs will be conducted with respondents from the BARMM and the Zamboanga, Basilan, Sulu and Tawi-Tawi (ZAMBASULTA) region. Meanwhile, a gathering of pertinent studies on Islam in the Philippines will

be the focus in the second year of the "Islam in the Philippines" book project.

The continuation of the "Mindanao: Fractured Promises, Continuing Challenges" forum series will also take place in the second half of the year.

The **Strategic Studies Program (SSP)** aims to promote interest and discourse on significant changes in Philippine foreign policy and develop capacity-building for strategic studies in the country. The Program views the Philippines' engagements with great powers and multilateral cooperation with other states in the Asia-Pacific region as a catalyst to further collaborative and multidisciplinary research between the intellectual communities within East Asia.

The Program's overarching objective is the promotion of strategic studies, an interdisciplinary academic field that deals with peace, conflict, and the relationship between international politics, geostrategy, diplomacy, international economics, and military power. Traditionally centered on military power and defense, the field has evolved to embrace human and multidimensional aspects of security.

Due to the COVID-19 pandemic, the activities slated for the first half of 2020 have been rescheduled to the latter half of the year. The first three months of the year were dedicated to finalizing the activities and research projects of the Program. However, with the implementation of the community quarantine, the second quarter was occupied with necessitated adjustments to events and re-strategizing research projects. This also involves a re-negotiation with external funders (i.e., Konrad Adenaeur Stiftung) on the implementation of the Program's projects.


Activities from January to June 2020

The Decolonial Studies Program (DSP) focuses on the different dimensions of coloniality/modernity that continue to impact institutions in the Global South in ways that often hinder them from achieving their liberating potential. It seeks to interrogate coloniality, identify aspects of Western modernity in postcolonial states, and critically engage with colonial-era texts, collective memory, and the use of both colonial and local languages.

In the beginning of the year, the Program was able to secure partnerships with institutions such as the International Studies Department of Miriam College and the Philippine International Studies Organization (PHISO) to collaborate on several activities, including an international conference set in September 2020. Aside from the institutional partners within and beyond the University of the Philippines, the DSP also envisioned being at the forefront of connecting scholars, students, policymakers, and enthusiasts interested in understanding and engaging in decolonial research. This led to the launch of the Decolonial Studies Research Network (DSRN), which aims to serve as a platform of engagement and collaborative work relevant to decolonial research.

The exciting prospects for the year, however, became fraught with the onset of the COVID-19 pandemic. Keen on remaining steadfast in pursuing the goals of the Program, while also being sensitive to the

changing contexts of the times, the Program made several adjustments and took full advantage of online platforms. With these came the decision to transition online for the rest of the year's activities. By June 2020, the Program was able to conduct a successful exploratory workshop on decolonial research. The academic workshop and conference planned by the DSP, which also yielded a number of submissions, will also be conducted online.

"Decolonize Everything!" Webinar



"Decolonizing Global Studies: Charting Trends, Mapping Trajectories" Online International Conference

The international conference "Decolonizing Global Studies: Charting Trends, Mapping Trajectories" is organized by the DSP in partnership with the Miriam College International Studies Department

and the PHISO. This conference, which will be held on September 11–12, 2020, seeks to chart trends and map the trajectories of decoloniality in the study of the global and the international. The online conference is open to scholars, researchers, students, and practitioners who are interested or engaged in decolonial studies and related fields.


Roundtable Discussions

The Program will conduct two online roundtable discussions in October and November to explore

and discuss relevant topics on decoloniality and decolonial research.

Outputs

Several papers are being prepared for publication, including the module on decolonial research that will be born out of the two exploratory workshops and finalized through another academic writeshop later in the year. The proceedings of the international conference organized by the Program will also be submitted for publication.



The Local-Regional Studies Network (LRSN) aims to create a network of research programs engaging in local and regional areas of study, involving scholars and centers based in the various UP constituent universities.

The LRSN is currently composed of two research centers: the Cordillera Studies Center (CSC) in UP Baguio and the Central Visayas Studies Center (CVSC) in UP Cebu.



The Cordillera Studies Center (CSC) initially proposed the project "Policy and Program Analysis on Cultural Festivals in the Cordillera" as a UP CIDS LRSN research project for 2020. The general objective was to identify and review issues and concerns related to cultural integrity and social justice in the conduct of selected festivals in the Cordillera. The project will also subsequently produce policy recommendations to address these issues and concerns. However, this did not push through due to change of leadership at the CSC. Thus for 2020, the program research of the LRSN–CSC has been parked. In the meantime, the LRSN–CSC study leaders who carried out the 2019 research project on landslide hazards in the Cordillera

will continue to finalize the written outputs for their respective studies. These include the following:

- Landslide Susceptibility Using Frequency Ratio and Varying Resolutions of Digital Elevation Models (DEM) (Study Leader: Dymphna Javier, Ph.D.)
- Direct Impacts of Landslides on Socioeconomic Systems: The Case of Terrace Vegetable Gardens in Bokod, Benguet (Study Leader: Corazon L. Abansi, Ph.D.)
- Assessment of Social Services for Landsliderelated Risks and Damages in Bokod (Study Leader: Ruth M. Tindaan, Ph.D.)
- Policy Analysis and Recommendations for Landslide Risk Reduction: The Case of the LGU of Bokod (Study Leader: Leah E. Abayao, Ph.D.)

Discussion papers for the studies on impacts to socio-economic systems and policy analysis and recommendations have already been completed. The delays in the production and submission of these outputs are partly due to the delayed approval of the UP CIDS 2019 budget and also partly due to the COVID-19 health emergency.

Aside from posing considerable restrictions to mobility and connectivity, dealing with the COVID-19 pandemic has also preoccupied faculty members of the University with the preparation of course

packs for courses that will be taught remotely in the upcoming academic year.

For its output, the LRSN–CSC was able to publish the discussion paper "Nurturing Nature and Culture: Policy and Customary Perspectives on the Indigenous Forest Management System *Chontog* of Barangay Ekip, Bokod, Benguet" by Roland Erwin P. Rabang in April 2020.



In 2019, the UP CIDS LRSN research project of the **Central Visayas Studies Center (CVSC)** of UP Cebu focused on Sustainable Tourism in Central Visayas. For 2020, the LRSN–CVSC initially planned to expand this project to include studies (1) on information, education, and communication efforts toward sustainable community-based ecotourism (specifically in Olango Island in Mactan, Cebu); (2) on the sociocultural and economic impacts of sustainable ecotourism on the same island; and (3) on street art in Cebu.

The Sustainable Tourism research project of LRSN–CVSC in 2019 was comprised of the following studies:

- Making Nature Tourism Sustainable: Assessing the Vulnerability, Resilience, and Limit of Acceptable Change of Nature Tourism Sites in Central Visayas (Study Leaders: Joseph Kenneth Bureros and Dexcem Pantinople; Members: Florence Evacitas, Ph.D. and Hazel Arceo, Ph.D.)
- Assessment of the Socio-cultural and Economic Impact of Tourism in Central Visayas (Study Leader: Mae Claire Jabines; Members: Belinda Espiritu, Ph.D. and Cora Jane C. Lawas)
- Mapping and Assessing Cebu's Potentials as an Art Tourism Destination (Study Leader: Jay Nathan Jose)

Most of the research work (i.e., data gathering) for these studies have already been carried out in 2019. The LRSN–CVSC initially aimed to devote a period until February 2020 for the study leaders to complete their written outputs of one discussion paper and one policy brief each. The completion and submission for publication of these outputs, however, have been affected by the onset of the COVID-19 pandemic. Aside from the immediate logistical and connectivity restrictions brought about by the pandemic, the faculty study leaders of the 2019 LRSN–CVSC project have also been burdened with additional workload as various UP units adjust their academic programs, courses,

and teaching methods to adapt to remote learning arrangements.

Considering these circumstances, no new research activity for any of the studies earlier planned by

LRSN-CVSC has been carried out. The LRSN-CVSC study leaders will continue to work on their respective outputs towards submission in 2020. Only then should the activities for the new LRSN-CVSC studies commence.

The UP Center for Integrative and Development Studies (UP CIDS) produces various publications that highlight the Center's interdisciplinary and collaborative research on key policy areas and issues. UP CIDS publications, which range from policy briefs and discussion papers to monographs and proceedings, are available online and in print. UP CIDS also publishes an annual peer-reviewed journal, the Philippine Journal of Public Policy: Interdisciplinary Development Perspectives (PJPP).

Philippine Journal of Public Policy: Interdisciplinary Development Perspectives

The Philippine Journal of Public Policy: Interdisciplinary Development Perspectives (PJPP) is the annual peer-reviewed journal of the UP CIDS released in print and online. The PJPP publishes policy research on themes including education, paradigms of development, social and political change, strategic studies, ethnicity and religion, health, and science and technology.

UP CIDS Executive Director Teresa S. Encarnacion Tadem, Ph.D. serves as the PJPP's Editor-in-Chief. Clarisse Culla and Ace Vincent Molo of the UP CIDS Publications Unit serve as the journal's managing editor and associate editor, respectively.

In February 2020, the PJPP released its 2019 volume, featuring two articles: Dr. Clement C. Camposano's "Citizenship and Civic Education: A Critical Elaboration on the Pedagogy of Rizal's La Liga Filipina" and "The Disappearance of 'Model Muslim Minority' in Xi Jinping's China: Intended Policy or Side Effect?" by Ms. Hacer Z.
