

#### The Center

Established in 1985 by the late University of the Philippines (UP) President Edgardo J. Angara to be the university's policy research unit, the **UP Center for Integrative and Development Studies (UP CIDS)** aims to:

- Develop, organize and manage research issues of national significance, which, because of their importance and inherent complexity require an integrative and collaborative approach and research methodologies and skills of greater sophistication;
- Encourage and support research and study on these issues undertaken by various units of the University and individual scholars;
- Secure funding from public and private persons and agencies; and
- Ensure that the research outputs and recommendations of the Center are published and openly disseminated.

In brief, the UP CIDS harnesses the University's expertise and resources towards addressing complex problems of national significance. The objectives of the Center are essentially in line with UP's mandate as a research and public service university according to the UP Charter of 2008 (Republic Act No. 9500).

In 2018, UP CIDS has once again aligned its research efforts according to the University of the Philippines' 2017-2023 Strategic Plan and identified areas where it could significantly contribute to.

In aiming to address national issues, the activities of UP CIDS necessarily finds most significance in accordance to the University's strategic goal of *contributing to national development*, mainly in the following areas:

#### ■ Knowledge creation

 Enhancing research, publications and creative work; and

#### Public service

- Enhancing policy research
- Popularizing UP's research findings

The manner by which UP CIDS carries out its objectives, by harnessing the university's resources and expertise, also necessarily contributes towards the goal of *promoting* access and diversity through the following:

- Enhancing structures and policies for collaboration; and
- Internationalization efforts.

# The UP CIDS Programmatic Structure

The appointment of Teresa S. Encarnacion Tadem, Ph.D. as UP CIDS Executive Director in August 2017 saw the revival of the UP CIDS' programmatic thrust. The rationale behind this structure for UP CIDS is for the Center to maintain a sizeable network of scholars who are willing to work and collaborate to freely address a wide array of critical and longstanding national issues as well as those which may arise periodically.

While the first half of 2018 saw the completion of segments of various research projects, as well as the establishment of partnerships and collaborations with various UP units and with external government and non-government entities, the end of 2018 saw the completion of these projects and the production and dissemination of research outputs through activities such as fora, lectures, and presentations, and through publications such as policy briefs, discussion papers, and monographs, among others.

Opportunities for new research programs also emerged as initial meetings were held between UP CIDS and UP faculty proponents, who will lead these programs in 2019. The newest UP CIDS research programs are the following:

- Decolonial Studies Program (DSP)
- Political Economy Program (PEP)
- Assessment, Curriculum, and Technology Research Centre (ACTRC)

Overall, the programmatic arrangement of UP CIDS has proven to be effective as each has independently—and with Program interference—pursued relatively minimal various research activities and worked on producing their own research outputs and publications. This is evidenced by the influx of research outputs submitted by the various research programs to the UP CIDS Publications Unit for processing towards the end of 2018. UP CIDS surpassing its yearly research output targets for 2017 and 2018 also point to the effectivity of this programmatic arrangement.

#### The UP CIDS Core Staff

To support its research programs and projects, the UP CIDS has core staff who are responsible for (1) the monitoring of research activities and outputs, (2) the regulation of financial disbursements and expenses, and (3) the publication and dissemination of research outputs and events. These core personnel are housed in the UP CIDS Administrative Office and are organized in four groups: (1) Administration, (2) Finance, (3) Publications, and (4) Library and Resource Center.



Following its main thrust to craft an education research agenda for the next five years (2019–2023), the **Education Research Program (ERP)** has worked with fellows and colleagues who are entrenched in education delivery and research. The objective of the agenda is to direct the work of the ERP to contribute to the deeper understanding of education issues as well as the social issues that arise from reform through the consolidation of research and creation of themes of Filipino scholarship on education topics; the understanding of current issues in the education landscape; and the nurturing, encouragement, and support of faculty researchers on education.

In 2018, the ERP engaged in activities which have helped shape its research agenda and addressed key issues in basic education. Among these activities were several roundtable discussions, presentations, conferences, and research projects that brought together various stakeholders and experts in the fields of information and communications technology (ICT), education governance, and curriculum and instruction.

#### **Program Research Projects**

The ERP is currently involved in research projects that cover a wide range of education policy areas and issues, including gender, teacher development, educational content, and evaluation of education policies.

# Formulation of the ERP Basic Education Research Agenda

Various activities were organized to gather information for the formulation of ERP's basic education research agenda. The first activity was a research on the volume and content of basic education research conducted by UP researchers from all UP campuses

for the past seventeen (17) years. The findings were then presented in roundtable discussions (RTDs) conducted together with representatives from the Department of Education (DepEd) central and field offices, non-government organizations, public and private school administrators, higher education faculty, basic education teachers, and other education practitioners. The RTDs served as venues for the identification of issues in basic education governance, and finance, school improvement, and ICT integration that the ERP will cover in its research agenda for the next five years.

# Addressing the Underachievement of Boys in Basic Education in the Philippines

By signing up to the 2030 Agenda for Sustainable Development, the Philippines renews its commitment towards gender equality in and through education. One of the challenges for the basic education sector is addressing the underachievement of boys, an issue that has persisted for years but remains unaddressed. This

project responds to the call to address the issue of academic underachievement among male learners in basic education in the Philippines by (a) examining the data pertaining to boys' underachievement from 2000 to 2015—the period during which the Millennium Development Goals (MDGs) and the Education for All (EFA) campaign are in place—in terms of enrollment, cohort survival, completion, and achievement rates, and (b) mapping out frameworks, actors, mechanisms (including the 2030 Agenda for Sustainable Development), and recommendations especially in the area of teacher education and how these can be brought to bear on boys' persistent underperformance in schools.

#### Basic Education and Federalism: Implications and Options for the National Capital Region (NCR)

The proposed shift to a federal system of government will affect the governance of basic education in the Philippines. This research project aims to review the current basic education governance structure based on prevailing laws and national policies, to

seek models of basic education governance from several countries with federal setups, to examine how the proposed regional government for the NCR will function and relate to the federal government agency for basic education in the areas of curriculum standards and supervision, teacher standards and hiring guidelines, and planning, data management, and resource provision, and to consider how the shift to federalism compares to the strengthening of the current unitary system in terms of addressing basic education inequities.

#### School Vision-Mission Statements and 21st-Century Learning: Implications for School Leadership

The study aims to present emerging themes contained in Philippine schools' vision and mission (VM) statements and to show whether these reflect 21st-century learning. It also seeks to establish the state of schools' strategic directions in the context of the world's emerging knowledge economy. VM statements were collected and validated

from 110 schools of diverse types and these were coded, tagged, and aligned using the Knowledge, Skills, and Attitudes, Values, and Ethics (KSAVE) 21st-century learning framework (Binkley 2012) and analyzed through content analysis. Findings show that at present, the strategic direction of schools does not include the explicit development of 21st-century learning among students The study endeavors to provide a way to deepen the understanding on how VM statements could be transformed in order to be more relevant today.

#### Use of School Learning Action Cells (LACs) to Improve Teaching-Learning Process in Science, Technology, Engineering, and Mathematics (STEM)

This research project aims to investigate how learning action cells (LACs) could impact the improvement of teachers' knowledge, attitudes, and competencies in teaching Grade 6 Science. It has three phases: (1) the development of LAC session materials based on a survey of training needs and

teachers' difficulty in teaching Science; (2) the conduct of workshops on establishing and implementing LAC sessions for school heads and LAC focal persons; and (3) the monitoring and evaluation of the conduct of LAC sessions to find evidence for changes in classroom practices, increased understanding and knowledge of the curriculum, and improvements in learners' participation and achievement in school. This study is being done in partnership with The HEAD Foundation, a charitable organization based in Singapore that aims to contribute to the development of Asia through support for research and social initiatives in human capital, education, leadership, and sustainability. This research study is expected to be completed by October 2019.

# What Constitutes Continuing Professional Development (CPD)?

Effective continuing professional development (CPD) programs positively affect teacher competencies and student learning outcomes (TALIS 2013, UNESCO 2015). The Department of Education (DepEd) embarked on a national training of teachers when the country shifted from a 10-year

basic education program to the 13-year K to 12 Program. A teacher training model was developed by the DepEd Central Office and was cascaded for implementation by regional offices (ROs) and schools division offices (SDOs). After six years of a centralized teacher training program, funds were downloaded to ROs and SDOs in 2017 for the development, implementation, and support of their own CPD programs. This research investigates these local CPD programs, their methods of delivery, and their monitoring and evaluation based on the allocation and utilization of Human Resource Training and Development (HRTD) funds for 2017.

# Exploring Notions of Care in Select Titles of Philippine Children's Literature

Children's literature shows much promise as a wellspring for social, moral, and ethical dilemmas that allow its readers to analyze and reflect on situations that mirror real life events. Stories shared in the classroom partly constitute the moral education of today's youth, as teachers present the texts as starting points for reflection, analysis, and discussion. The proliferation of acts of violence, both through words and deeds, leads us to wonder whether classrooms tackle materials that hold human values at its core. The study asks whether students are learning how to care through local children's literature and examines the notions of care in select titles of Philippine children's literature. A total of one hundred (100) children's books used in early grade classrooms were analyzed to determine evident notions of care. The findings from this research reaffirm the relational nature of care and show that notions of care as depicted in local children's books range from the concrete (e.g., preservation of life) to the more abstract (e.g., acceptance of diversity). The study also points out that the act of caring necessitates both the acceptance of change and the exercise of agency, and that modes of care evident in the narratives were displayed verbally, through gestures or actions made by the main characters, and through representations in storybook illustrations.

# Literature and Life: Dealing with Controversial Issues Using Children's Literature

Literature is one potent means by which people get to vicariously experience a vast and complex world. Reading about other's lives may open them up to becoming kinder, gentler, and more empathetic individuals who recognize that there are multiple realities beyond those that are personally experienced. However, while literature may mediate learning for students, it becomes more effective when teachers interrogate texts with learners. In this study, teachers were interviewed and probed into the reasons why they choose or not choose to use selected children's books that may be deemed radical or controversial. Results showed that teachers were more inclined to use children's books about controversial topics that were in line with children's experiences or those for which they have background knowledge of, as this could help their students deal with similar issues, learn how to relate to people in comparable circumstances, and thus become more compassionate human beings. They likewise recognized how certain books were only meant to be read to children who find themselves in similar situations and not the whole class, as these might expose the latter to ideas that they are not ready for. Other considerations in choosing these controversial books were also explored.

#### ALS Literacy Programs for Filipino Adult Learners: Whose Goals are Being Realized?

In the Philippines, adult education remains marginalized and a low-priority policy. While the curriculum for basic and tertiary levels are revised, there are no known initiatives taken to revise the curriculum of the Alternative Learning System-Basic Literacy Program (ALS-BLP), which provides basic education to adults and out-of-school youth. The study uses an ethnographic approach that is complemented by an analysis of the ALS curriculum and learning materials and

by interviews with key informants. Findings showed that outdated and irrelevant content, the formalization of instructional approaches, and the foreign context and language of the instructional materials both invalidate the learners' previously acquired knowledge and threaten to erode their hopes of achieving productive lives in the future.

# Re-framing Democratic Citizenship and Civic Education: Critical Reflections on the Work of the Philippine Center for Civic Education and Democracy (PCCED)

This commentary focuses on the work of the Philippine Center for Civic Education and Democracy (PCCED) and seeks to assess its use of key anthropological insights in framing projects aimed at promoting civic education and fostering civic engagement among secondary public school teachers, high school students, and members of local communities. It explores not only how PCCED's work has led to more theoretically informed approaches but also, and just as important, the limitations of these approaches and the way that these might

benefit both from further theoretical elaboration and the reflexive sensibility that anthropology advocates as an academic discipline.

#### Mother Tongue-Based Multilingual Education (MTB-MLE) and a Need for Program Evaluation

To date, the Mother Tongue-Based Multilingual Education (MTB-MLE) has been implemented in the Philippines for seven (7) years. It is an established national program that has earned the Philippines a reputation for being a trailblazer in large-scale MTB-MLE implementation.

Currently, though there are available national assessments and that can provide data to determine the effectiveness and efficiency of the MTB-MLE, there is still no formal and large-scale program evaluation that spans the program's various components and identifies elemetrs that contribute to student achievement. It is proposed that the government should craft a comprehensive policy on MTB-MLE program evaluation, which can be done both at the macro (national) and micro (school and division)

levels. Evaluation data should also be disseminated nationally and internationally to contribute to local and international MTB-MLE research and practice.

#### Assessment as a Tool for Inclusion

Philippines has worked towards making education accessible for all types of learners, but an assessment of the school system's readiness to address the learning needs of learners with disabilities show that there is a lack of facilities, training, and guidelines to support inclusive education in regular schools. Empowering local schools for inclusion means providing them access to assessments that support inclusion of learners with special education needs in the regular classroom. The study advocates the use of assessment tools for students with additional needs (SWANs), which provides schools and teachers with information about the level of proficiency their students with additional needs could demonstrate in foundational learning skills. This can complement the DepEd's existing instruments, such as the Multi-factored Assessment Tool (MFAT).

#### Focus Group Discussion on Addressing the Underachievement of Boys in Basic Education in the Philippines

Twelve (12) teachers handling junior and senior high school learners (balanced by gender) and twelve (12) homegrown SHS learners (also balanced by gender) from Quirino High School in Quezon City were selected to participate in the FGD.

#### Critical Theory, Pedagogy, and Literacy: Making Classrooms as Democratic Public Spheres and Teachers as Cultural Workers for Martial Law Conversations

30 October 2018

Dr. Jose Lalas, Professor at the School of Education and Director of the Center for Educational Justice of the University of Redlands, California, delivered a presentation on using critical theory and pedagogy in engaging teachers and students in conversations on the Philippine experience during Martial Law. 

# Program on Higher Education Research and Policy Reform

The Program on Higher Education Research and Policy Reform (HERPR) aims to chart a research agenda, systematically build an evidence base for policy analysis, and create a network of experts and researchers doing work in the Philippine higher education sector. The Program also serves as a convening body which seeks to build partnerships and working collaborative networks among key stakeholders.

Pursuant to its mandate and objectives, the Program conducted activities examining the situation of higher education in the country and other connected issues such as the supply of healthcare workers and determinants of access. It has likewise expanded its network to involve stakeholders from the health and development sectors and has hosted a number of forums, workshops, and symposia.

# Program Activities for July to December 2018

FORUM

#### Higher Education Reforms to Address the Deficits in Philippine Healthcare Workers

4 September 2018

The forum was held at the UP Institute for Small Scale Industries (UP ISSI) and featured three presentations by Dr. Clarissa David, Dr. Geoffrey Ducanes, and Mr. Karol Mark Yee. The discussion revolved around the deficits in the supply of nurses, pharmacists, dentists, and doctors in the country and how reforms in higher education could help address the problem. Representatives in higher

education and health sectors attended the forum, including Representative Angelina Tan (Chair of Committee on Health, House of Representatives), Atty. Carmelita Yadao-Sison (Unified Financial Assistance System for Tertiary Education (UniFAST) Secretariat, Commission on Higher Education (CHED)), Nymia Pimentel-Simbulan (Vice Chancellor for Academic Affairs, UP Manila). Dr. Beverly Lorraine Ho (Chief of Research Division, Health Policy Development and Planning Bureau, Department of Health), and Dr. Teodoro Herbosa (Executive Vice President, UP System).

# Who Serves the Poor in Philippine Higher Education?

Held at the UP CIDS Conference Hall, the forum discussed the access of the poor to higher education from 1999 to 2014. In particular, the discussion highlighted the nuances in the profile, context, and the variety of barriers faced by students coming from the poorest households in accessing college education. # Roundtable Discussion on Higher Education

7 December 2018

This RTD presented the findings of two papers of the Program, namely Graduate Degrees of Higher Education Faculty in the Philippines: Status and Ways Forward and Public-Private Complementarity in Philippine Higher Education: The Current Philippine Picture. The former provides an overview of the profile of higher education faculty in the Philippines in terms of highest educational attainment and recommends aggressive expansion and strategically-targeted faculty development programs. On the other hand, the latter identifies the current foci of private and public higher education institutions (HEIs) and analyzes relevant data such as enrollment and graduation figures

and performance indicators (e.g., licensure examination passing rates). The roundtable was attended by stakeholders in the higher education sector.

#### MISCELLANEOUS ACTIVITIES

#### Housing of Graduate-Level Intern

September-December 2018

The program hosted Ms. Andrea Patricia Santos, a research master's candidate at the University of Amsterdam doing fieldwork for her thesis on the Universal Access to Quality Tertiary Education Act (more popularly known as the "Free Tutition Act"). She studied the conceptualization of access in the act's policy formation process and how its implementation serves students from poor families.

# Program Outputs for July to December 2018

#### **Higher Education Datasets**

The Program was able to collect and organize data on Philippine state colleges and universities (SUCs) from the Commission on Higher Education. Data obtained from

CHED include statistics on enrollment and graduation, faculty development, and performance in licensure examinations.

The HERPR is also currently collecting and organizing information on faculty members from all units of the UP System.

# Interactive Map of Private and Public HEIs in the Philippines

Through the assistance of Mr. Johnson Damian, a researcher and instructor at the UP Department of Geography, the Program was able to create an interactive map of HEIs in the country and the programs that they offer. The map is currently undergoing beta testing.



# Proposed Activities and Outputs for 2019

#### **Policy Briefs**

The HERPR aims to publish at least ten (10) policy briefs for 2019. For January to June 2019, studies on the role of public and private HEIs in the development picture, unintended outcomes of "Universal Access to Quality" and the overall higher education landscape of health workers in the country will be pushed through. There will also be focus on comparing higher education outcomes between genders, as well as HEI profiles (e.g., profit versus non-profit private HEIs, urban versus rural HEIs). Other policy briefs include analyzing the performance of HEIs in the criminology licensure examinations, the relationship between elections and SUCs, amalgamation among HEIs, and an evaluation of the Tertiary Education Subsidy (TES) and UniFAST. Furthermore, a mapping

of HEIs in the Philippines will also be published to help identify locations with no or very few HEIs and program offerings.


#### **Discussion Papers**

The Program intends to publish at least three (3) discussion papers for 2019. For January to June 2019, the previously published policy brief on the profile of higher education faculty in the Philippines in terms of highest educational attainment will be extended to a discussion paper. Also, a study on governance of higher education institutions will be written under three topics: (1) the role of local universities and colleges (LUCs) in

the Philippine higher education space, (2) the achievement of research university status, and (3) the political economy of establishing state universities and colleges (SUCs) in the Philippines.

#### **Future Activities**

For the first half of 2019, the Program plans to continue a previously postponed forum on public-private complementarity in Philippine higher education. Various fora and roundtable discussions will be also arranged for the discussion and dissemination of the HERPR's research work on the Philippine higher education landscape.

# Program on Data Science for Public Policy

The Program on Data Science for Public Policy (DSPP) aims to build the capacity of UP faculty and researchers in data science and in applying it to their respective research interests in order to address challenges in public policy and governance. To do this, the Program endeavors to build and engage a community of faculty and to encourage them to pursue interdisciplinary problem-oriented research using high-level quantitative analyses. In accordance with the mandate of the University of the Philippines as the national university, the DSPP also pursues the production of research primarily concerned with solving social issues.

The DSPP was able to successfully carry out a series of workshops on various data science tools and platforms that aim to increase the capacity of UP scholars and researchers. Opportunities for collaboration were also explored as it participated in workshops offered by other government agencies and by private institutions. Moreover, an initial collaboration among current data science efforts within the UP System was also made possible through working group meetings that were facilitated by the Program.

A major challenge that the Program encountered was the difficulty in procuring specific software and technology (such as Coursera subscriptions and NVivo data analysis software) that are required in order for the DSPP to carry out its activities.

# Program Activities for July to December 2018

WORKSHOP

#### Practical R Workshop

17-19 September 2018

The Practical R Workshop is a three-day training course for beginners and non-

programmers that introduces the basics of R, a powerful open source data analysis environment and programming language used by academics, researchers, and scholars worldwide. DSPP research fellows Dr. Jalton Taguibao and Dr. Jan Michael Yap facilitated the workshop that was held at the UP CIDS Conference Hall.

WORKSHOP

#### Basic Machine Learning Workshop

22 & 29 October / 5 & 12 November 2018

Held at the UP Institute of Small Scale Industries (UP ISSI), this workshop is an introduction to tools and techniques in machine learning and how these can be used to analyze and solve public policy problems. Workshop participants were trained to use the programming language Python in implementing solutions to their research problems. Dr. Carlo Raquel, Assistant Professor at the Department of Computer Science of the UPD College of Engineering, served as workshop facilitator. As with the Practical R Workshop, participants were required to use what they learned in their actual research interests and are expected to produce outputs in the form of policy briefs.

# Program on Escaping the Middle-Income Trap: Chains for Change

The Program on Escaping the Middle-Income Trap: Chains for Change (EMIT C4C) aims to examine the nexus of inclusion and competitiveness in the country's efforts to achieve sustainable growth. It takes off from the Escaping the Middle-Income Trap: Pragmatic Strategies for Inclusive Growth project, which looked into reasons why only very few countries that have managed to transition from a low-income to a middle-income country status have succeeded in joining the cluster of industrialized and rich economies of the world.



In the second half of 2018, EMIT C4C continued its focus on agricultural value chains. It aims to ask the following questions: What makes value chains inclusive; what are the costs and benefits of striving for both inclusiveness and competitiveness; and what are the results? The Program's primary research interest is to understand how smallholders, indigenous peoples, and other rural poor populations are involved in and benefit from inclusive and competitive agriculture value chains. Three value chains were covered as part of the first loop of action research: The Farmer Entrepreneurship Program of the Jollibee Group Foundation, the Saradit na Kristiyanong Komunidad (SKK) Rice Processing Center of PinoyME Foundation and Caritas Diocese of Libmanan, and the Transformational Business Partnership of Unifrutti Tropical Philippines and Hineleban Foundation. After the conduct of field work and validation of initial findings in 2017, EMIT C4C's main objective for 2018 was to synthesize its key findings through synthesis papers and monographs and to present these in a public conference aimed at generating comments and contributing to the advocacy for inclusive value chains.

# Program Activities for July to December 2018

CONFERENCE

Chains-for-Change: Emerging Lessons on Inclusive Agriculture Value Chains 18 July 2018

The Program organized a public conference held on 18 July 2018 at the UP School of Economics Auditorium. The event gathered from academic attendees institutions, national and local government agencies, civil society, international organizations, financial institutions, farmers' organizations, and the business sector. Key themes and findings drawn from EMIT C4C's first loop of action research projects conducted in 2017 were presented in the conference. The event also highlighted the significance of efficient value chains, creation of inclusive institutions, value chain financing, and inclusive leadership in enabling inclusive and sustainable partnerships in Philippine agricultural value chains to effectively involve and benefit smallholders, indigenous peoples, and other rural poor populations.

#### Managing Transition: Bringing CSR to the Next Level

July and November 2018

EMIT C4C launched an executive training program titled *Managing Transition: Bringing CSR to the Next Level*. The executive training aims to help companies and corporate foundations in identifying pathways to become more sustainable and tipping points to drive strategies toward higher levels of inclusiveness and competitiveness and in making corporate social responsibility (CSR) a core and strategic activity of businesses and enterprises. Participants from seven (7) partner companies and foundations joined the executive training sessions held in July and November 2018. The training program is expected to be finished by mid-2019.

EMIT C4C also organized the launch of economist and National Scientist Dr. Raul Fabella's book *Capitalism and Inclusion under Weak Institutions*, which was published by the UP CIDS. The book launch was held

on 12 October 2018 at the UP School of Economics. UP CIDS Executive Director Dr. Teresa S. Encarnacion Tadem opened the program, which was followed by Dr. Fabella's main talk about his book. # Proposed Activities and Outputs for 2019

For 2019, EMIT C4C intends to produce publications such as teaching cases, discussion papers, and policy briefs. The Program also intends to begin the second loop of its action research on the Farmer Entrepreneurship Program and the Transformational Business Partnership.

# Farmer Entrepreneurship Program (FEP)—Action Research Loop 2

Coming from the FEP Loop 1 that documented the FEP's journey, the FEP

Loop 2 shifts its attention to the role that partners play at the intermediate level of the value chain. The findings of the FEP Loop 1 underline the fact that intermediaries have a role to play in the FEP's model. The onion farmers from KALASAG were able to form and run their own cooperative, while the vegetable farmers from Cebu and Dalaguete participate in the value chain through the intermediation of the Lamac Multipurpose Cooperative. Intermediaries bridge the smallholder producers and the institutional buyer, facilitating the value chain and freeing up the other value chain participants to focus on their core value proposition. This central position in the value chain also make them a crucial link in the information and power asymmetry that is seen as a pervasive traditional with agricultural supply chains. The challenge now lies in (1) clearly defining the role and functions that intermediaries play in an inclusive value chain, and (2) understanding the conditions that brings about the need for their services.

# Transformational Business Partnership—Action Research Loop 2

Based on the lessons from the first loop, the Loop 2 of this research is expected to cover key cooperatives in Mindanao who are partners of Unifrutti. This loop might also cover an investigation of contracts in banana plantations.

#### Other Researches

EMIT C4C will also document the following cases in 2019:

- A small fishing community in Roxas City, Capiz delivering to big restaurants in Manila
- Local government units (LGUs) as driver of inclusive growth (using the case of Piddig, Ilocos Norte)
- Yazaki Torres' rice production to support their canteen

## Survey of New FEP Farmers

(Through Lead Implementing Partners)

As a way to provide indicators on the effect of the FEP on smallholders' lives, EMIT C4C will roll out a data collection program that will be administered to new FEP sites. The collected data will help assess the situation of smallholders not only in production aspect of the value chain, but also in its entrepreneurial aspect. It will also assess the smallholders' households' health as consumers, since the

condition of poverty has adverse effects on their productivity.



# Program on Alternative Development

The **Program on Alternative Development (AltDev)** aims to look at paradigms, policies, practices, and projects that are largely marginalized and excluded from the mainstream. Because they challenge dominant modes, they do not figure prominently in the national and international discourse. AltDev aims to bring these alternatives out of the margins and into the mainstream to level the playing field so that they may be regarded on an equal footing with dominant discourses and thus offer alternatives to the existing system.

## **Program Research Projects**

Currently, there are five (5) projects under the Program on Alternative Development, as the previous *UNESCO Project on Research* and Evidence for Social Inclusion to Achieve Social Development Goals was concluded in the first half of 2018. The research projects that were continued in the second half of 2018 are as follows:

## Project on Alternative Practices in Southeast Asia

Project Leader: Asst. Prof. Venarica B. Papa • Project Consultant: Prof. Maureen C. Pagaduan

The Project on Alternative Practices in Southeast Asia aims to document the largely dispersed and localized alternative development practices by grassroots peoples and communities in Southeast Asia which serve as responses to the perceived failure of mainstream and dominant development paradigms to meaningfully address development issues and concerns.

Aside from documentation, AltDev also aims to link these alternative practices across Southeast Asia to form the building blocks of a people's alternative regional integration. These efforts will be conducted in partnership with the Department of Community Development of the UP College of Social Work and Community Development (UP CSWCD), the Asian Regional Exchange for New Alternatives (ARENA), Focus on the Global South, Freedom from Debt Coalition (FDC)–Philippines, and People's Empowerment Foundation (PEF)–Thailand.

In 2018, the Program was able to conduct field visits and documentation activities in Thailand, Indonesia, and Timor Leste. Together with its partners, AltDev was also able to organize a Conference on Alternatives in Southeast Asia in November 2018. In order to expand its international network and linkages, the Program likewise participated in various civil society platforms, including the 12th Asia-Europe People's Forum (AEPF) and the 2018 ASEAN Civil Society Conference/ASEAN People's Forum.

## Project on Transformative Social Protection

Project Leaders: Marie Stella de La Cruz Cardenas & Anabelle Visitacion

This AltDev project involves hosting the activities of two sister organizations: (1)

the Network for Transformative Social Protection (NTSP), a Southeast Asian regional platform that advances people-centered and sustainable transformative development alternatives towards the fulfillment of peoples' economic and social rights and of the agenda for a Social ASEAN; and (2) Buhay na May Dignidad para sa Lahat (DIGNIDAD), a Philippine national convergence of at least thirty-two (32) peoples' movements and formations which aims to pursue universal, comprehensive, and transformative social protection towards guaranteeing Filipinos a life of dignity.

Under this project, AltDev was able to produce a critique of the Philippine Development Plan (PDP) 2017–2022, written by Dr. Rene Ofreneo (Professor Emeritus, UP School of Labor and Industrial Relations and President, Freedom from Debt Coalition) and Raquel Castillo (Philippine Representative, ASEAN Civil Society Conference/ASEAN Peoples Forum Regional Steering Committee and Lead Convenor, Sustainability and Participation through Education and Lifelong Learning (SPELL)).

### Marx Bicentennial Lecture Series

Marx (1818-1883). German the philosopher whose ideas exercised profound influence on the world and inspired countless revolutionary movements in the twentieth century until after the end of the Cold War in the late 1980s, was considered irrelevant and consigned to the margins of popular discourse. However, the aftermath of the series of economic crises that began in East Asia in the 1990s and culminated in the US-induced global economic meltdown in 2008-2009 renewed interest and discussion on his works.

The year 2018 marked the 200th anniversary of Karl Marx's birth. Commemorative and celebratory events were organized in many parts of the world. At the same time, books and reader-friendly literature on Marx have been piling up. In the Philippines, under the auspices of the Program on Alternative

Development, a group of academics and social movement activists have gathered for a series of lectures to commemorate Marx's 200th birth anniversary. The objective of the project is to situate the works of Marx and Marxist theory and practice within the context of the Philippine political, economic, cultural, and scientific situation. The lectures will seek to:

- Interrogate the diverse intellectual, political, and historical legacies of Marx and Marxism;
- Revisit Marxist theory and practice in light of changing social, political, and economic contexts, such as technological development, the rise of social media, and the erosion of democracy across countries;
- Assess the complex relationship of Marxism with other intellectual currents and disciplines, from gender, science, and biopolitics to literature, historiography, and political practice; and
- Determine how and to what extent Marxist theory and practice can inform, impede, and enrich questions of political and economic praxis.

Several lectures covering various topics, co-sponsored with the Socialist Circle and the Last Thursday Colloquium, have already been held under the Marx Bicentennial Lecture Series, with the series continuing until May 2019.

## World Health Organization (WHO)— Bloomberg Initiative for Global Road Safety (BIGRS) Project

Despite an overall slow-paced reduction worldwide, increasing road traffic fatalities in some parts of the world have prompted the World Health Organization (WHO) to declare road traffic crashes as a public health emergency. Road safety has now been given global priority and attention as the end of the United Nations' Decade of Action for Road Safety (2011–2020) approaches.

Compared with other countries in Asia and the Pacific, the death rate from road traffic crashes in the Philippines continues to climb, with a 31% increase in fatalities in a seven-year period (2008–2015) and most of which involved vulnerable road users. It is because of this that the Philippines was included in the Bloomberg Initiative for Global Road Safety (BIGRS) along with Thailand, China, India, and Tanzania. The initiative is being conducted by a consortium of international partners together with national governments and local civil society organizations.

In the Philippines, the initiative's funding is coursed through the WHO and coordinated with the Philippine government through the Department of Transportation (DOTr) and the Department of Health (DOH). It runs two (2) fellowship programmes: the Legal Development Programme (LDP) and the Media Fellowship Programme (MFP). The BIGRS-LDP provides technical assistance to government and implementing agencies to improve and strengthen road safety policy and legislation through capacity building and training measures for its fellows. On the other hand, the BIGRS-MFP focuses on developing advocacies in the media to disseminate awareness in road safety.

The overall objective of the BIGRS in the Philippines is to contribute to the significant reduction of road traffic fatalities by 2020, particularly a target 20% reduction as agreed upon in the Philippine Road Safety Action Plan (PRSAP) 2017–2022.

The achievements of the BIGRS in the Philippines thus far includes the expansion in number and the conduct of capacity building activities for BIGRS-LDP Fellows, the conduct of a Road Safety Roundtable Discussion Series, the launch of a road safety alliance in the Philippines, the establishment of linkages and partnerships, the creation of a Philippine Road Safety Action Plan, the publication of various materials and outputs, and publicity in the press and new media platforms such as social media.

UP CIDS and DILG—NCR Project on Federalism for the National Capital Region (NCR) • Reclaiming Public Services: Giving Back Ownership and Control to Local Governments

This is a project by the Local Government of Quezon City, the Department of the Interior and Local Government–National Capital Region (DILG–NCR) and, the UP CIDS that aims to craft studies and proposals on the role and functions of the Metro Manila region under the proposed federalism setup for the Philippines. The project involves various UP CIDS Programs and other UP colleges. AltDev's involvement in the project will focus on the idea of reclaiming public services and bringing these currently privatized services back under public control and management.

In the 1980s, privatization became the preferred policy of governments economic development and even in the delivery of public services. This was meant reduce government involvement in infrastructure development, business, maintenance of services, and promotion of competition, efficiency, and productivity. It has been observed, however, that the promise of privatization remains unfulfilled. Monopolization, profit maximization. corruption frequently patronage, and accompany privatization in many developing and transitional economies. The problems engendered by privatization have spurred a movement to deprivatize, re-municipalize, and give the control and ownership of public goods back to the public.

The various ills related to privatization have seen its realization in the Philippine case. Is it now time to give back to government bodies and agencies the ownership of and control over essential services? Under the proposed federal setup, what are the conditions in which this can be effected? In particular, in the light of the global re-municipalization trend, how can the National Capital Region (NCR) initiate a similar undertaking? These are the questions which the AltDev aims to address under this project, with a focus on the provision of water and power services. In the end, the ultimate measure is to prioritize the welfare and well-being of all citizens and to ensure that essential services are available, accessible, and affordable for all.

Burning Issues in Korea, China, and Malaysia: Alternatives and Prospects for Peoples' Movements 9 July 2018

The Program organized a roundtable discussion on burning issues in Korea, China,

Ms. Ananeza Aban of AltDev, who is also an ARENA Fellow, served as moderator.

Dr. Lau and Dr. Sit Tsui shared their insights on burning issues in Hong Kong and China. Dr. Aeria shared his insights on the recent developments in Malaysia, including the election victory of the opposition coalition Pakatan Harapan and the re-election of Mahathir Mohamad as Prime Minister. Finally, Dr. Lee discussed the candlelight protest held in South Korea, the ongoing developments of the peace movement in the Korean Peninsula, and the role of women in these movements

### FIELD RESEARCH/DATA-GATHERING

## Field Research and Visit in Nusa Tenggara Timur, Indonesia and Dili, Timor Leste

10-20 July 2018

AltDev research associates Ananeza Aban and Angeli Fleur Nuque conducted field visits in Nusa Tenggara Timur (NTT), Indonesia, and in Dili and Ermera District in Timor Leste from 10–20 July 2018 to document alternative practices in these countries.

Both the Indonesian cases of sorghum farmers of the Perhimpunan Petani Sorgum untuk Kedaulatan Pangan NTT and of the Lepo Lorun Weavers Cooperative highlight alternative practices as a means for maintaining cultural and indigenous practices of communities in contemporary times. On the other hand, the cases studied in East Timor focused on local decision-making, collective enforcement of agrarian reform, and gender equality.

The fifth installment of the Marx Bicentennial Lecture Series was held on 12 July 2018. Dr. Amado M. 

During the conference, the delegates were also able to start to thresh out plans and initiatives for networking and linkaging, people-to-people exchanges, and research and documentation in the coming years.

# Program on Social and Political Change

The task of the **Program on Social and Political Change (PSPC)** is to provide a platform for understanding the varied social and political challenges facing the country today. Broadly, the aim of the Program is to allow experts from a variety of disciplines in the University to develop a better understanding of past, current, and future social and political tensions that can arise and have an impact on modern Philippine society and polity. It is designed to produce empirical studies using a variety of methods and approaches to better understand the different social and political issues, transitions, and disruptions affecting the country and the world. These studies form the basis for policy inputs and discussions at the local, national, and international levels.

The PSPC spent the second half of 2018 engaging with students, the academe, government organizations, and civil society through public lectures and discussions on a wide range of issues, including migration, food security, economic growth, and the antidrug campaign. The Program also continued its collaboration with the Department of the Interior and Local Government-National Capital Region (DILG-NCR) and the Office of the Mayor of Quezon City in the development of the research project A Study on the Implications of Federalism in the National Capital Region and Considerations for Forming the Federal Administrative Region. The study is geared to address the existing knowledge gap on the possible implications of federalism on the country's seat of government and economic center. The Program also continued the Constitutional Performance Assessment of the 1987 Philippine Constitution Project in partnership with the International Institute of Democracy and Electoral Assistance (International IDEA). This project aims to support a more informed discussion and agenda surrounding the proposed constitutional change process in the Philippines. During this period, the Program came up with opinion articles, discussion papers, and monographs to

expand the impact of its activities and efforts on contributing to public thought.

## Skype Meetings with International IDEA

July-December 2018

In relation to the Constitutional Performance Assessment of the 1987 Philippine Constitution project sponsored by the International Institute for Democracy and Electoral Assistance (International IDEA), a series of Skype meetings with project manager Amanda Cats-Baril were held. Progress reports on research outputs and administrative matters were shared and discussed with the International IDEA during these meetings.

FILM SCREENING AND PANEL DISCUSSION Filipinos in the Eyes of an Italian

Science, and the Scalabrini Migration Center, hosted a film screening and panel discussion of Italian filmmaker Francesco Conte's Filipinos in the Eyes of an Italian. Conte conducted a series of interviews with firstand second-generation Filipino migrants in Italy, which he later turned into a film that depicted the stories of overseas Filipino workers and their process of integration abroad. A panel formed by Dr. Marla Asis (Scalabrini Migration Center), Pete Chan (former Philippine Consul General in Milan), Fr. Graziano Gavioli (Scalabrini Migration Center), and Ellene Sana (Center for Migrant Advocacy) also shared their respective experiences in working with Filipino migrant communities in Italy through the decades.

MEETING WITH PARTNERS/STAKEHOLDERS

## Meetings with Quezon City Mayor Herbert Bautista for the DILG-NCR and UP CIDS Federalism Study

August-September 2018

A series of meetings for the UP CIDS and DILG-NCR Federalism Study was conducted with Quezon City Mayor Herbert Bautista, head of the NCR Federalism Study Group. The objective of the meetings was to present

the progress of the research studies earlier done by scholars from UP in order to obtain an overview of the breadth of the areas covered by the project. This year, three meetings have been conducted and more than half of the papers planned for the project have been presented.

On 6 August 2018, Dr. Rogelio Alicor Panao of the UP Department of Political Science, and Dr. Guillermo Tabios of the UP Institute of Civil Engineering presented their papers on fiscal decentralization and on water sources of Metro Manila and flood risk management, respectively.

On 14 August 2018, Mr. Dennis dela Torre of the UP National College of Public Administration and Governance–Center for Local and Regional Governance (UP NCPAG–CLRG) and Assistant Professors Kevin Mark Gomez and Jan Robert Go of the UP Department of Political Science presented their respective research papers. Mr. dela Torre presented his paper on risk transfer mechanisms in NCR, which is co-authored with UP NCPAG's Dr. Erwin Alampay. Asst. Prof. Gomez presented a proposal on reconfiguring the geospatial arrangement of

Metro Manila, while Asst. Prof. Go provided an overview of the effects of decentralization, specifically in Metro Manila.

The last meeting was held on 12 September 2018 with Dr. Maria Ela Atienza of the UP Department of Political Science and the PSPC presenting her progress report on health services in the NCR. Meanwhile, Dr. Jalton Taguibao and Dr. Maria Lourdes Rebullida, also from the UP Department of Political Science, presented their paper on solid waste management in the NCR.

The meetings with DILG-NCR will continue in 2019 as the rest of the project contributors present their respective progress reports.

### PUBLIC LECTURE

Overseas Nurses and the National Health Service (NHS): The Contribution of Filipino Nurses from the '90s to the Post-Brexit Future 28 August 2018

Dr. Nicola Gillin of the Anglia Ruskin University (Cambridge) delivered a lecture examining nursing culture and patient care between nurses from the United Kingdom (UK) and nurses from the European Union (EU) and other countries. Dr. Gillin came to the Philippines to continue her research on Filipino nurses in the UK, looking more deeply into their motivations for working in the UK and how these motivations impact family units in the Philippines. In her presentation, she shared the trends in the migration of Filipino nurses into the UK through time and how this is affected by the results of the Brexit referendum.

This event was co-organized with the UP Department of Political Science, with the participation of the Philippine Social Science Council and the Philippine Migration Research Network.

### **BOOK LAUNCH & PANEL DISCUSSION**

## Ensuring a Square Meal: Women and Food Security in Southeast Asia

19 October 2018

The PSPC, together with World Scientific Publishing (Singapore) and the UP Department of Political Science, held the Philippine launch of the book *Ensuring a*

Square Meal: Women and Food Security in Southeast Asia on 19 October 2018 at the UP CIDS Conference Hall. The volume is one of the first attempts to relate gender and food security in the Southeast Asian region. The book launch featured a panel discussion with the editor of the book herself, Dr. Theresa Devasahayam, as well as two of the chapter contributors to the book, Dr. Jorge Tigno and Dr. Thelma Paris.

The book seeks to uncover the dimensions and processes related to the women's roles in food security in the family and in agriculture and larger food production. The book also aims to show that the food provisionary role of women in the private sphere is not distinct from their role in food production as farm workers.

### **SEMINAR**

## Improvements in Governance and Economic Growth

9 November 2018

The PSPC, together with the Philippine Center for Economic Development (PCED) of the UP School of Economics (UPSE) and the UP Department of Political Science, coorganized the seminar *Improvements in Governance and Economic Growth* by Dr. Lino Briguglio, Professor of Economics from the University of Malta.

In his seminar, Dr. Briguglio challenged the commonly held assumption that bad governance leads to a country's economic growth and correlated changes in governance to changes in real GDP. In particular, he hypothesizes that countries which have lower GDP per capita will grow faster than countries with higher GDP per capita if good governance is practiced. The study hopes that governments will see the benefits of improving governance because of economic improvements that come with it.

## ROUNDTABLE DISCUSSION

## Planted Evidence: Is the Philippine War on Drugs a Sound Policy?

14 November 2018

The PSPC and the UP Department of Political Science jointly organized a roundtable

discussion on the war on drugs that aims to assess if the anti-drug policy enacted by the current administration is informed by accurate and meaningful data. Dr. Clarissa David (Professor, UP College of Mass Communication), Mr. Pacifico Talplacido (Vice President, Philippine Society of Criminology), Dr. Meiting Li (Assistant Professor, UP Department of Political Science), and Ms. Marielle Marcaida (Assistant Professor, UP Department of Political Science) served as speakers.

This RTD interrogates the basis of the government's approach to the so-called 'drug war' and asks if sound research and systematic evidence were used in justifying the administration's anti-drug policy. The RTD also looked into the direction that policy research should take to better understand the nature and extent of drug use in the Philippines and how to approach its control and eradication.



## Islamic Studies Program

As Muslim Filipino communities thrive in various parts of the country, there is a need to both celebrate their diverse cultures and traditions and confront the multifarious issues affecting them. The **Islamic Studies Program (ISP)** seeks to take the lead towards an active role for the academe in advancing the role of Islam in nation-building. It aims to encourage the wider Filipino community to know Islam deeper, and, consequently, deal with existing stereotypes against Muslims.



## **Program Research Projects**

The Program's objectives will be accomplished through three research components:

- HIKMA or Historical and Islamic Knowledge for the Modern Age, which covers topics such as Muslim responses to modernity, education, gender, and languages;
- Research on Shari'ah Courts, which focuses on the Code of Muslim Personal Laws of the Philippines (otherwise known as Presidential Decree No. 1083); and
- **The Moro Story**, which focuses on issues affecting the Philippine madrasah system, gender and migration in the Bangsamoro, and the rehabilitation of Marawi City, among others.

These research components were translated into seven (7) key projects in 2018. Out of these projects, international conferences, roundtable discussions, focus group discussions, and field researches were accomplished. These resulted to the production of manuscripts for discussion

papers, policy briefs, journal articles, and conference proceedings as research outputs of the Program.

The ISP faced challenges in having to spearhead many firsts, such as the first international conferences on madrasah education and on countering violent extremism, and on Islam in Southeast Asia, among others. These challenges mainly came in the form of logistical and administrative issues and the simultaneous increasing of the presence of the UP Institute of Islamic Studies (UP IIS) and the UP CIDS Islamic Studies Program in the said activities.

A follow-up field research on the best practices and critical needs of madrasah education in the Philippines was conducted in Cotabato City on 16–19 September 2018 by Dr. Arlyne Marasigan. She conducted various interviews with madrasah education

specialists, practitioners, and advocates from the government, private, and nongovernment sectors in the Autonomous Region of Muslim Mindanao (ARMM).

The field research on the story of the Bangsamoro women migrant workers was conducted by Dr. Cheery Orozco in two phases. The first phase was carried out on 23-27 August 2018 in Maharlika Village, Taguig City, while the second phase was done on 16-19 September 2018 in the City of Cotabato. She did interviews and focus group discussions with Muslim women overseas Filipino workers (OFWs), advocates, representatives from government agencies and non-government organizations on the conditions and experiences of female Muslim OFWs in the Middle East and on various campaigns and policies that intend to support and protect them.

### CONFERENCE

## 1st International Conference on Madrasah Education

4-5 July 2018

The ISP, the UP IIS, and the Office of the Education Attaché of the Embassy of the Republic of Indonesia organized the 1st

Conference International on Madrasah Education held on 4 and 5 July 2018 at Balay Kalinaw in UP Diliman. Carrying the theme "Exploring Best Practices in Madaris and Islamic Studies Education between Indonesia and the Philippines," the conference was attended by more than a hundred madrasah and Islamic Studies education experts, practitioners, and advocates from Indonesia and the Philippines. The conference aimed to gather experts from Indonesia and the Philippines to share best practices in madrasah education, to conduct workshops and assessments on gaps and areas for development on madrasah pedagogies, curricula, and instruction, and to strengthen linkages and collaborations between Muslim communities from the two countries.

## WORKSHOP

## International Exploratory Workshop on Publication Opportunities for Research Work on Islam in Southeast Asia

21 September 2018

The international exploratory workshop concentrated on publishing selected peer-reviewed academic and policy works which focus on theoretical, methodological,

empirical, religious, spiritual, and critical studies of Islam, including mundane praxes and day-to-day realities of Muslims (and their relations to non-Muslims) in Southeast Asia. Themes that were explored in this workshop were Muslim majority and minority states, Islam and ethnicity, Islam and influences from the Middle East, and relations between Muslim and non-Muslim populations in the region.

### CONFERENCE

## 1st International Conference on Countering Violent Extremism

22 September 2018

This international conference highlighted the role of the state, education, community outreach, responsible media, and religio-cultural dialogues in countering violent extremism (CVE), which has been at the forefront of international and domestic security policies. It seeks to understand the ontologies, epistemologies, theories, studies, narratives, motivations, causes, effects, and impacts of violent extremism. At the same time, the conference explored approaches, frameworks, solutions, and mechanisms for CVE by utilizing the state, education, sustainable community


outreaches, responsible media, and religiocultural dialogues that promote religious pluralism, multiculturalism, respect for diversity, acceptance, and tolerance.

HIKMA RESEARCH PROJECT

## Peace Building through History Education

Researcher: Darwin J. Absari

"To correct historical injustice" Muslims is one of President Rodrigo Duterte's pronouncements in his 2016 State of the Nation Address (SONA). This represents a call to renew attention to the rich history and heritage of Muslims in the Philippines and to make their narratives visible in the teaching of Philippine history. Along with the enactment of Republic Act No. 10908 that mandates the integration of Filipino-Muslim and indigenous peoples' history, culture, and identity in basic education, this initiative charges academic institutions, particularly Islamic institutions, in connecting the Filipino communities to the Philippines' rich Islamic heritage and culture. However, growing threats of violent extremism in Mindanao continue to challenge such initiatives.

Thus, in response, the UP IIS and the UP CIDS ISP will design a five-year program composed of a series of conferences and training workshops which aim to produce a standard syllabus and reference material on the history of Muslims in the Philippines. Aside from bridging widening cultural and

religious gaps, the purpose of this initiative is to promote national unity and understanding to counter violent extremism.

HIKMA RESEARCH PROJECT

## Philippine Islamic Arts: Themes and Issues

Researcher: Prof. Julkipli A. Wadi

Muslim arts in the Philippines is hardly given attention in the public sphere. The impact of Orientalism pervades as clouding Islamic art with manifold "representations," which is often defined by bland exteriority, interest, and power. Despite such Orientalizing effects, Philippine Muslim arts have been enduring while gaining popularity in mainstream culture and utilized invariably by many people and communities.

The art and art forms created by Filipino and Moro artists have gained national and international attention. They have become showcases of the country in many international competitions. With the rush of orthodoxy and fundamentalism worldwide, Islamic arts are subjected to varying perceptions among Filipinos and Muslim themselves leaving many people to question the manner or "propriety" in appreciating


them. Even as debates continue, the terrain of contentions remains. It is important to underscore the themes and issues of Muslim arts in the Philippines and how they could be of use in preserving national heritage and in promoting Islamic art as a living tradition.

## PD 1083 Education Campaign: Accessing Justice through the Shari'a Courts

Researcher: Macrina A. Morados

The focus group discussion (FGD) and interviews with personnel of Shari'a courts' and various stakeholders conducted in 2018 aim to identify key issues on the prospects and challenges in amending the Presidential Decree 1083, otherwise known as the Code of Muslim Personal Laws of the Philippines. This 2019, the thrust is to pay particular attention to accessing justice through the Shari'a courts and how various Muslim constituents and communities in the country can be empowered to harness this resource. Field researches will be done in various cities and communities in Mindanao and Sulu through FGDs and interviews with various stakeholders of Shari'a courts. Expected outputs from this research include

## 2nd International Conference on Madrasah Education

Theme: "Realizing Integrated and Holistic Madrasah Education System in the Philippines Towards a Balanced Community vis-à-vis PCVE"

Head: Jamel R. Cayamodin, Ph.D.

The 2nd International Conference Madrasah Education, with the "Realizing Integrated and Holistic Madrasah Education System in the Philippines Towards Balanced Community vis-à-vis PCVE," proposed to be held in September 2019 and is expected to be attended by various stakeholders of the government's program on preventing and countering violent extremism (PCVE). This will usher the preparation and adoption of an inclusive legal and regulatory framework for Philippine madrasah education. The objectives of the conference are (1) to convene local and international experts to discuss the feasibility of the implementation of the integrated and holistic madrasah education system (IHES) in the Philippines in producing a balanced

community vis-à-vis PCVE, (2) to conduct workshops and identify challenges and prospects of IHES implementation in terms of pedagogy, administration, curriculum, and learning content, and (3) to plan out future activities and areas for further collaboration between and among stakeholders to craft and adopt an IHES legal and regulatory framework. The conference's outputs include a conference proceeding and a discussion paper.

## Focus Group Discussion on Push Factors for Muslim Youths to Become Targets of Radical Groups

Researcher: Macrina A. Morados

The rise of extremism in the Philippines is both a phenomenon that needs to be understood in light of some precipitating factors and a subject that intensifies conflicting views among scholars and Muslim communities in the country. Extremism is often articulated through violent manifestations and as a threat to humanity, escalates conflict and disrupts the order of the society. Unfortunately, perpetrators use religion to justify violent extremism, as this is the most effective persuasive tool

that touches core ideologies and alludes to a nostalgic state of societal order under a Khalifah (caliph) or dawla (state).


How do distorted and appropriated truthclaims lure the Muslim youth to join radical groups and how do these affect their core ideologies? How have they become an easy prey for various radical groups and how does the process of persuasion look like? These are the key issues being considered in this study, particularly looking into the religious, psychological, and socio-economic contexts of this phenomenon, as well as the various motivations, inspirations, and aspirations of the Muslim youth in Mindanao that might encourage them to join these groups. Focus group discussions in several key cities and communities will be done for this study and a discussion paper will be its main output.

## From ARMM to BARMM: Plans, Challenges, and Implications

Researcher: Prof. Julkipli A. Wadi

With the ratification of the Bangsamoro Organic Law (BOL), the transition of the Autonomous Region in Muslim Mindanao (ARMM) to the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) is expected to proceed from 2019 to 2022. It is important to understand the plans of both the Philippine government and the Moro Islamic Liberation Front (MILF) as the latter undergoes a mainstreaming process into the Philippine body politic and a decommissioning of its armed forces, while setting the stage of normalization in Bangsamoro areas. It is also crucial to underscore the extent to which the administration and governance in the ARMM are properly transferred to the Bangsamoro Transition Authority (BTA) disrupting the flow of services in the region. Consequently, the BTA must be prepared in doing the task of transition and the extent to which it adopts democratic tradition in pursuing peace, security, and development goals. Expectedly, the challenge of transition until the entrenching of the BARMM is enormous as the trajectory of politics before and after 2022 would be more critical. It is important to know the challenges, factors, and forces involved in this transition, and their over-all implications. To realize this research, there is a need to hold RTDs and to conduct interviews with various parties and stakeholders involved in the transition. The deliverables for this research include a discussion paper and policy brief.

## Strategic Studies Program

The **Strategic Studies Program (SSP)** aims to promote interest and discourse on significant changes in Philippine foreign policy and develop capacity-building for strategic studies in the country. The Program views the Philippines' latest engagements with the great powers and multilateral cooperation with other states in the Asia-Pacific region as a catalyst to further collaborative and multidisciplinary research between intellectual communities within East Asia.



Strategic studies is an interdisciplinary academic field centered on the study of peace and conflict, often devoting special attention to the relationship between international politics, geo-strategy, diplomacy, international economics, and military power. While traditionally centered on the use of military power for defense and security purposes, strategic studies have now evolved to embrace the human and multidimensional aspects of security.

The activities undertaken by the SSP in 2018 illustrate its commitment to bring issues of strategic importance to a Philippine public that tends to be very inward looking in its appreciation of its immediate environment. For 2018, there was a clear focus on the strengthening of a core group of experts and researchers interested in strategic concerns within the University and on the consolidation of networks with institutions in the government and in the private sector that might be interested in developments that affect the policy options of the Philippines. Hence, the SSP organized events that tackled issues on the country's strategic situation, embarked into research that looked into the country's strategic situation, engaged in outreach activities that seek to

to institutionalize the network of experts and stakeholders on strategic studies in the Philippines.

## Program Activities from July to December 2018

PUBLIC LECTURE

## Taiwan's New Southbound Policy: Implications for the Philippines 13 July 2018

The SSP hosted a public lecture on Taiwan's New Southbound Policy last 13 July 2018. Organized together with the UP Department of Political Science, Asia Pacific Pathways for Progress Foundation, Inc. (APPFI), and the Center for Strategic and International Studies (CSIS), the lecture aims to provide a venue to discuss the relevant issues concerning the policy of Taiwan.

The public lecture focused on the merits of Taiwan's New Southbound Policy (NSP) and the benefits it could provide to relevant countries, especially the Philippines. It also explored the various kinds of strategic responses that the Philippines should adopt given the changing geopolitical realities due to the NSP. Representatives from government agencies, foreign embassies, members of the academe, and professionals from various private institutions attended the lecture.

**ROUNDTABLE DISCUSSION** 

## Bilateral Relations of Japan and the Philippines with China

29 August 2018

The SSP and APPFI organized a roundtable discussion (RTD) on the bilateral relations of Japan and the Philippines with China. Held last 29 August 2018, it hosted scholars from University of Tokyo and Keio University who shared their insights on the topic with their Filipino counterparts.

The main objective of the discussion was to understand the Japanese experience in its conduct of bilateral relations with China. The topics that were covered include the Philippine domestic politics and how this affects the country's bilateral relations with China, the economic interests of China and the relationships that it is building with countries in Southeast Asia, the role and influence of the United States in the region, and the general perceptions of Southeast Asians with regard to the recent developments in the region. The RTD was capped by a discussion of the practical steps that would contribute to the improvement of the bilateral relations between the Philippines and China.

PUBLIC LECTURE

## Change and Continuity in China's Foreign Policy

10 October 2018

The SSP, in partnership with the UP Diliman Department of Political Science, organized a public lecture on change and continuity in China's foreign policy on 10 October 2018. The lecture was attended by students, faculty, and representatives from various government agencies. It centered on the findings of the studies by SSP research fellows Dr. Meiting Li and Asst. Prof. Raisa E. Lumampao on the emerging trends in China's foreign policy.

Dr. Li's presentation tackled the theoretical basis of the rationale behind China's foreign policy and the complex interplay of its internal and external sources relative to the country's global position. On the other hand, Asst. Prof. Lumampao's presentation was a regional assessment of China's foreign policy in the strategically-and economically-important Northeast Asian region and an examination of the variations between Chinese leaders Hu Jintao and Xi Jinping's approaches to foreign policy.

## Asian Politics and Policy (APP) Conference 2018: Development and Security Crossroads for the Philippines and Asia

22 October 2018

The Asian Politics and Policy (APP) Conference, held on 22 October 2018 at the UP CIDS Conference Hall, was organized in partnership with Asian Politics and Policy, a peer-reviewed online journal by the Policy Studies Organization (PSO), and the UP Department of Political Science.

The conference was attended by more than eighty (80) participants representing the diplomatic community, government, academe, students, security sector, and other members of the Philippine strategic conference community. The featured four panels examining the Philippine domestic situation and its consequences, Southeast Asia's China dilemma, and the emerging order in the Indo-Pacific region. Speakers included academic experts on strategic studies, government officials, and representatives from the military and the private sector.

## **World Experts Lecture Series**

Featuring Dr. William Tow and Dr. Brendan Taylor 23 October 2018

The World Experts Lecture Series (WELS) was held in partnership with the UP System Office of International Linkages (UP OIL) on 23 October 2018 at the Marine Science Institute of UP Diliman. The lecture sought to provide insights on the developing geopolitical situation and strategic alliances in the Indo-Pacific and was delivered by distinguished scholars Dr. Brendan Taylor (Associate Professor of Strategic Studies) and Dr. William Tow (Professor of International Relations) of the Coral Bell School of Asia Pacific Affairs at the Australian National University (ANU).

The main focus of Dr. Taylor's lecture concentrated on 'flashpoints' of possible conflict areas in Asia and how these build a volatile situation in the region. On the other hand, Dr. Tow's presentation elaborated on the structural changes happening in international relations and their implications for the world's strategic environment and the conduct of foreign policy by major powers.

## Workshop on Strategic Studies

24 October 2018

Held last 24 October 2018, the Workshop on Strategic Studies aims to plan the components of an institutionalized research program of a proposed Strategic Studies Institute (SSI) at UP and of the training program that it will be administering. This is in view of the SSI's thrust to contribute to the expansion of the Philippine strategic studies community and the overall advancement of strategic studies in the country.

Around twenty-five (25) representatives from the academe, government institutions and agencies, and the military attended the workshop and shared their suggestions and observations on how the proposed SSI will materialize. Follow-up meetings and workshops on this matter will be held in the future.



# Program Analysis and Policy Recommendations for Payment for Environmental Services (PES) Implementation in Benguet

the Local-Regional 2018. Studies Network-Cordillera Studies Center (LRSN-CSC) collaborated with the Department of Environment and Natural Resources (DENR) in reviewing plans for the implementation of a Payment for Environmental Services (PES) scheme in the province of Benguet. The project intends to formulate and propose policy recommendations for the said scheme. Engagements with local government units (LGUs) and communities were instrumental for UP Baguio in providing scientific and timely information knowledge for communities and government agencies. These collaborative engagements are also part of the goal to sustain initiatives in building and enhancing the capacities of local communities in the Cordillera region.

The project specifically aimed to conduct an economic and socio-cultural valuation of a selected site in Mount Pulag National Park (MPNP) and to develop a scheme for the implementation of PES in the area. The MPNP, one of the most important watersheds in the country, is faced with problems, issues, and challenges not only in its protection as an environmental resource and watershed, but also in its management as a protected area. The lack of scientific baseline information and policy guidelines or procedures remains a challenge. The challenge also extends to how the culture and livelihood of indigenous communities can be valued to create an incentive for them to invest in forest protection and management.

The outputs of the project are papers that provide important insights on the different dimensions and the prospects of implementing a PES scheme in the MPNP given its cultural, economic, and historical contexts. Authored by an interdisciplinary team of researchers from UP Baguio, these emphasize the activities of the community and of the local government that may or may not be beneficial for a prospective

PES scheme. The process of creating these research papers established a connection between the LRSN-CSC and the agencies and communities that were involved in the research project. This opens more opportunities for collaboration between the LRSN-CSC and local governments and communities in Benguet in the future.

### Proposed Activities and Outputs for 2019

For 2019, the LRSN-CSC aims to explore and strengthen the role of communities and LGUs in climate change mitigation and disaster preparedness and response through:

- Conducting scientific studies on landslide susceptibility and vulnerability assessments in the Cordillera;
- Documenting and analyzing community and stakeholder knowledge and skills in dealing with extreme rainfall and landslide events through participatory, gender-sensitive, and inclusive approaches; and
- Producing policy and program recommendations on the management and reduction of risks from landslides and related natural hazards in the Cordillera.

### Sustainable Tourism in Central Visayas

The Local-Regional Studies Network-Central Studies Center (LRSN-CVSC)'s Visavas Research Project on Sustainable Tourism in Central Visayas aims to support the regional development agenda of sustainable and inclusive economic growth by mapping out and implementing a sustainable tourism research agenda for Central Visayas. The Travel & Tourism Competitiveness Report 2017 of the World Economic Forum states that "travel and tourism and its enabling ecosystems have proven to be significant drivers of economic growth." According to the report, travel and tourism (T&T) "has potential to play a key role in creating high quality employment opportunities, act as a vehicle to protect and restore the planet's biodiversity and help build bridges between people and cultures." According to another report, the Philippines ranked 79th out of 136 countries and scored high in natural resources (37th) but low in environmental sustainability (118th) and moderate in cultural resources (60th).

The LRSN-CVSC has brought in its multidisciplinary expertise to look into issues, challenges, constraints, success stories, prospects, and opportunities in the tourism industry of the region, focusing on three areas of sustainable tourism: (1) ecological balance and environmental integrity, (2) sociocultural and economic impacts of tourism, and (3) cultural tourism, with a focus on art tourism.

Due to the geographical distance between UP CIDS and the UP Cebu CVSC, there were financial and administrative challenges in the initial phases of the project. This was eventually addressed through a funding check memorandum (FCM) that was approved by the UP System, which made the transfer and access of funding to UP Cebu and the CVSC easier.

- Sociocultural and economic sustainability of tourism in Cebu (Assessing the Socio-Cultural and Economic Impacts of Tourism in Central Visayas by Asst. Prof. Mae Claire Jabines, College of Social Sciences, UP Cebu)
- Cultural tourism, specifically on art tourism (Mapping and Assessing Cebu's Potentials as an Art Tourism Destination by Asst. Prof. Jay Nathan Jore, College of Communication, Arts, and Design, UP Cebu)

The proposals will focus on Cebu and will be followed by further research on other cities and provinces in Central Visayas such as Bohol, Negros Oriental, and Siquijor beginning in the year 2020.
