## INTRODUCTION

Founded in 1985 by the late University of the Philippines (UP) President Edgardo J. Angara, the UP Center for Integrative and Development Studies (UP CIDS) is the University's policy research unit that aims to address problems of national significance by employing an integrative and collaborative approach in the conduct of studies on various aspects of public policy and harnessing the University's multidisciplinary expertise and expansive resources.

Based on then–UP President Angara's Executive Order No. 9 issued on 24 September 1985, UP CIDS has the following objectives and functions:

- Develop, organize, and manage research issues of national significance, for such issues, because of their importance and inherent complexity, require an integrative and collaborative approach and also more sophisticated research methodologies and skills;
- Encourage and support research and study on these issues by various units of the University and individual scholars;
- Secure funding from public and private persons and agencies; and
- Ensure that the research outputs and recommendations of the Center are published and openly disseminated.

UP CIDS is likewise guided by UP's Strategic Plan 2017–2023 and contributes to the University's thrust of (a) contributing to national development through knowledge creation and public service, and (b) promoting access and diversity through enhancing structures and policies for collaboration and undertaking internationalization efforts.

## **RESEARCH PROGRAMS**

UP CIDS adopts a programmatic structure wherein a sizable network of scholars is brought together and organized under Research Programs through which a shared research agenda is pursued and networks within and outside the University are built upon.

Consistent with its integrative and collaborative approach, UP CIDS also provides opportunities and venues for the various Research Programs to work on common themes and emerging international and national policy concerns.

The Center currently supports 12 Research Programs grouped into three general clusters. UP CIDS' Research Programs of UP CIDS are:

the valuable support, which OVPAA will continue to provide for UP CIDS research activities and publications.



Thus, UP CIDS has also integrated this assessment with the updated (from the 2023 UP CIDS Midyear Report) End-of-Term Report (ETR) of its Executive Director Teresa S. Encarnacion Tadem (1 August 2017–31 July 2023), together with the UP CIDS Programs and Administration, Publication, and Library units. This will be published in a separate document from the 2023 UP CIDS Midyear Report.

## **UP CIDS LIBRARY AND RESOURCES**

The UP CIDS Library and Resources office continues to operate physically and online to cater to various clients with their research needs. Since the inventory of UP CIDS publications has been updated, the UP CIDS Library started to upload them to other databases. One of UP CIDS' partnerships is with the Socioeconomic Research Portal for the Philippines (SERP-P) of the Philippine Institute for Development Studies (PIDS). The library has uploaded a total of 343 UP CIDS publications, including policy papers, journal articles, monographs, and discussion papers.

The library has also given copies of UP CIDS publications to other libraries, such as the National Library of the Philippines and the Senate of the Philippines Legislative Library. Also achieved during these past months is the uploading of older publications to the UP CIDS website database.

## **PROGRAM DESCRIPTION**

The Education Research Program (ERP) conducts research under three categories—Curriculum and Assessment, Instruction and Teacher Development and Governance, and Finance and School Improvement—based on its agenda, "Policy Investigations in Support of the Filipino Learner 2019–2024." To guide the investigations that ERP conducts, analysis is drawn from statistics, education studies, and multiple stakeholder consultations. For the current year, the particular focus of ERP is literacy, information communications technology (ICT), and disinformation studies.

Association for Reading and Writing International Conference 2023 23–24 February 2023


ERP Research Teams shared their research outputs at the 2023 Association for Reading and

#### MEETING

Collaboration meeting with UP Los Baños 15 March 2023

The team composed of Co-convenor Dr. Lorina Calingasan and Senior Research Associate Junette Gonzales met with UP Los Baños Office for Institutional Development in Higher Education Director Dr. Greg Pawilen and other researchers last 15 March 2023. They discussed a potential collaboration on a study on social sciences and basic education schools. Both parties shared research interests and explored areas for joint work.

The activity gathered inputs for developing modules on MIL for senior high school students.

FIELDWORK Piloting of tools and protocols 15, 17, and 24 May 2023

Two Language Capture and Ethnography team members, Nerissa Zara and Research Fellow Audrey Morallo, took turns in visiting the home in Barangay Loyola Heights and observing the participating four-year-old child and his mother. During the process, the team used and tried their data collection tools and protocols. The team conducted an exit phone interview with the mother at the end of the observation period. The team will then conduct a final interview with the child's mother using an interview tool. Transcripts of all interviews will be prepared.

ERP Co-convenor Dr. Dina Ocampo joined the Philippine Business for Education roundtable discussion on education reforms related to governance and teacher quality.



## UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

ERP pursues research across three categories— Curriculum and Assessment, Instruction and Teacher Development and Governance, Finance and School Improvement—guided by its "Policy Investigations in Support of the Filipino Learner 2019–2024" agenda. Investigations are informed by statistical analysis, education studies, and multistakeholder consultations.

For 2023, ERP's research focuses on language and literacy, and disinformation. Under Curriculum and Assessment, the Multiliteracy Assessments for Filipino Children (MLAF) will be administered to K–3 children in three modalities—in-person, online, and telephony.

Data gathered will be analyzed to inform literacy programs and lessons of partner communities as well as policies on early-grade learning outcomes.

Also under Curriculum and Assessment are the UsapTayo studies, which have two components. First, the Coproduction Study aims to develop a program for five-year-old children with teachers, parents, and students. Data collection through interviews, observations, and materials review will inform program development, a prototype of which will be piloted and refined. Second, the Language Capture and Ethnography Study will collect data on patterns of language use of children in low-income families.

Under Instruction and Teacher Development and Governance, ERP will conduct an extension workshop on "Skeptical Resilience and Fighting Fake News" to build teachers' skills in assessing online information. Intervention research on combating disinformation will also commence.

Lastly, the dissemination of research to stakeholders will continue through the annual Sipat Edukasyon forum online.

By concentrating research efforts on literacy and disinformation within its established categories, ERP will generate timely evidence to guide education reforms and interventions. The methodological approaches and strong emphasis on stakeholder engagement will ensure relevant, high-impact outputs to support Filipino learners.

### ACTIVITIES

#### **Disinformation Studies**

Following the application for research ethics and articulation of data findings and the submission of the journal article on how teachers assess online information, ERP shall conduct an extension workshop entitled "Skeptical Resilience and Fighting Fake News: Capacity-Building on Civic Online Reasoning for Basic Education Teachers in the Public School System" in partnership with West Mindanao State University this August 2023. In addition, the Program will develop intervention research on disinformation studies.

Multiliteracy Assessments for Filipino Children (MLAF)

Field administration of the multimodal MLAF (K-3) will be conducted at two data points (beginning and middle of the year). Data

collected at these points will be encoded, analyzed, and will inform the paper to be presented at the 7th International Conference on Language and Education from 4 to 6 October 2023 in Bangkok, Thailand. Development of literacy assessments for Grades 4–12 will begin during the latter part of the year as well.

#### **Usap Tayo Studies**

- Stakeholders' Coproduction of an a.) Oral Language Program for Five-Year-Old Children. The team will interview kindergarten teachers. parents, and incoming kindergarten students. It will also conduct classroom observations, and evaluate selected learning materials. Once these tasks are done, the team will draft guidelines, procedures, and workshop materials for Quality Circles. A pilot program will test and refine the oral language program prototype and program materials.
- b.) Language Capture and Ethnography: Patterns of Language Use of Children in Low-SES Families and Language Input from the Home Environment. For the rest of the year, the team will focus on data collection, data cleaning and transcription, data analysis, and report writing. Alongside these activities, the team will work on the publication of its journal article on the systematic review of the related literature of the study.

#### Sipat Edukasyon

The ERP will conduct its annual research dissemination forum, the Sipat Edukasyon in November 2023, via the online platform Zoom and streamed live through the UP CIDS Facebook account. Its primary aim is to share UP ERP's education research output with various stakeholders. Previous presentations include topics on teacher professional development, gender studies, and information and communications technology (ICT) in education among others. This event shall be free and open to all.



Since its inception, the ACTRP has provided evidence-based advice to the Department of Education (DepEd) and other education stakeholders.

## ACTIVITIES FROM JANUARY TO JUNE 2023

TRAINING OF TEACHERS IN BARMM

INSET for Key Stage 2 (Grades 4-6) Teachers in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) Training of Trainers (ToT) 23-28 January 2023

ACTRP was part of the five-day In-Service Training (INSET) organized by BARMM MBHTE and UP. Schools Division Office (SDO) personnel and school heads from the 11 BARMM divisions participated in the Training of Trainers for Key Stage 2 held in Zamboanga City. Topics covered in the training were delivered by MBHTE and by the following UP units: Institute of Islamic Studies, College of Education, and UP Integrated School. ACTRP delivered the session on Assessment with Louie Cagasan Jr. and Lalaine Bagui (Research Officers) as facilitators. The recorded lecture of Drs. Marie Therese Bustos, Kevin Carl Santos, and Marlene Ferido were presented during the session.

TECHNICAL ASSISTANCE TO DEPED BUREAU OF EDUCATIONAL ASSESSMENT

Measuring Learning Loss Based on 21st-Century Skills of Filipino Grade 6 and 10 Students During the COVID-19 Pandemic 20 January 2023

ACTRP continued to provide technical assistance to the DepEd Bureau of Education Assessment-Education Assessment Division (BEA-EAD) in the data analysis of its study "Measuring Learning Loss Based on 21st-Century Skills of Filipino Grade 6 and 10 Students During the COVID-19 Pandemic."

Adjustments in the statistical analyses of the NATs in 2018 and 2021 were made using the contextual variables collected from the students, parents, and school heads. The final results were presented to DepEd BEA via Zoom. DepEd presented these results in an EDCOM 2 meeting.

Participation in the Basic Education Report (BER) 2023 Forum of DepED 30 January 2023

ACTRP Convenor Dr. Marie Therese Bustos and Deputy Director Dr. Marlene Ferido attended the presentation of the Basic Education Report (BER) on 30 January 2023. Dr. Ferido reported on curriculum concerns and issues through a five-minute video clip.

### Technical Assistance to DepEd Bureau of Curriculum Development (BCD) on the K-10 Curriculum

Consultation Meetings with DepEd-BCD 2-3 February 2023

DepEd–BCD sought ACTRP's technical advice regarding the process of developing the new K–3 learning area, SiKaP (Sibika, Sining, Kultura, Kasaysayan, at Kagalingang Pangkalusugan). SiKap is a transdisciplinal course involving Araling Panlipunan and MAPEH (Music, Arts, Physical Education, and Health) which will be offered from Grades 1 to 3.

Review of the Draft K-10 Curriculum Guides and Shaping Papers 20 March-14 April 2023

DepEd–BCD requested ACTRP to give initial comments on the revised K–10 Curriculum Guides (CG) and Shaping Papers. ACTRP's comments focused on the following aspects of the documents: clarity of statements, logical flow of ideas, alignment of the CGs with the Shaping Papers, alignment of parts, spiraling of Big Ideas, and alignment with 21st-century skills. The comments also included suggestions for improvement.

ACTRP took part in the consultation workshops with stakeholders on the revised K-3 curriculum. The workshops were led by DepEd BCD, in collaboration with learning area experts from other DepEd bureaus. Representatives from DepEd Central Office Bureaus (20-22 February), DepEd Regional Directors, CLMD chiefs, and Regional Supervisors (23-24 February), government agencies (27-28 February), and private schools (1-3 March) participated in the said activities. The participants were grouped according to their learning area expertise. The workshops aimed to gather feedback on curriculum standards, content, and learning competencies from various stakeholders.

Participation in the EDCOM 2 Learning Visit to Australia 30 April to 6 May 2023

ACTRP Convenor Dr. Marie Therese Bustos is a member of the standing committee for

ECCD and Basic Education. Dr. Bustos joined the other members of EDCOM 2 in a learning visit to Australia. The visit aimed to learn more about the Australian education system. Philippine Business for Education (PBEd), with the Australian Department of Foreign Affairs and Trade (DFAT), organized the trip.

## DepEd-UNICEF ALS Microcertification Study

Development of Two Assessment Matrices and Tools for ALS Microcertification

MEETING First Advisory Board Meeting 28 February 2023

Besides ACTRP and the other members of the research team, the Advisory Board Meeting was attended by people from DepEd Bureau of Alternative Education (DepEd-BAE), United Nations Children's Fund (UNICEF), Technical Education and Skills Development Authority (TESDA), and USAID Educational Development Center (EDC). The group was convened to discuss and decide on points relevant to the finalization of the inception report which includes the project timeline, the capabilities to be assessed, the pilot study sites, and matters about stakeholder consultations.

#### **ONLINE WORKSHOPS**

AssessmentMatrixDevelopmentWorkshop for the LeadershipCapability13 April; and 9 and 16 May 2023

Assessment Matrix Development Workshop for the Problem-Solving Capability 14 April; 10 and 23 May 2023

These are workshops engaging DepEd BAE, ALS teachers, and representatives from government agencies, nongovernmental organizations (NGOs), and the business sector to codesign the assessment matrices which will be used to develop the assessment tools for leadership and problem-solving capabilities. The second phase of the microcertification study assesses these capabilities and will provide evidence on the feasibility of employing microcertification for ALS-offered life skills.

The workshops have three parts. The output of the first workshop is a draft of the assessment matrix for each capability. The

second workshop is for the initial review of the matrices. The third workshop is intended for the final review. All workshops were conducted online.

During the second Advisory Board Meeting on the ALS Microcertification Study, the team reviewed the draft assessment matrices/ instruments for the leadership and problemsolving capabilities. Additionally, activities relevant to the pilot testing of the instruments were also discussed.

### BARMM-wide Grade 6 Learning Needs Assessment Project

WORKSHOP Attribute Identification Workshop 29 April 2023

MBHTE aims to develop summative assessments for sixth-grade learners that will inform their teachers' INSET and their students' remediation programs. ACTRP suggested designing has summative assessments using the cognitive diagnosis model. In relation to this, ACTRP conducted two workshops. The first was an attribute identification workshop that reviewed the Most Essential Learning Competencies (MELCs) in five learning areas-English, Filipino, Mathematics, Science, and Araling Panlipunan (Social Studies). It identified the skills/attributes Grade 6 learners should master to be deemed proficient. DepED BCD Curriculum specialists and DepEd teachers from the identified learning areas participated in the workshop.

#### WORKSHOP Item Writing Workshop 6 May 2023

The second workshop for the BARMM-wide Grade 6 Learning Needs Assessment project involved teachers from UP Integrated School (UPIS) as test item writers for the Grade 6 attributes identified in the first workshop.

#### **PILOT TESTING**

Grade 6 Learning Needs Assessment 31 May-2 June 2023

The English, Filipino, Araling Panlipunan, Mathematics, and Science test items were piloted in five schools in the Division of Maguindanao II, BARMM. The ACTRP team administered the tests to a total of 685 Grade 6 learners in 20 Grade 6 sections.

#### WORKSHOP

Preparations for the Actual Test Administration 19 June 2023

Officers and staff from the MBHTE– Curriculum and Instruction Division, the Field Operations Division, and the Quality Assurance Division–Regional Student Assessment Office attended the planning workshop for the BARMM Grade 6 Assessment from 2–7 July 2023 in BARMM's 11 school divisions. The test design, test development processes, and the pilot test results were discussed during the workshop.

Presentation of the Initial Findings of the International Comparison of Senior High Schools (SHS) at the EDCOM 2 8 June 2023

Drs. Pam Robertson, Stanley Koh, and Sundance Sun of the University of Melbourne presented the comparison of SHS in Indonesia, Vietnam, Peru, Colombia, Malaysia, and Poland to explore possible SHS pathways for the Philippines. They recommended that the pathways to SHS should cater to a range of abilities and aspirations. Technical Assistance to DepEd BEA-EAD 15 June 2023

BEA-EAD sought the technical assistance of ACTRP in designing the sampling procedure for selecting Grade 10 students who will take the NAT. Dr. Kevin Santos, ACTRP's co-convenor, proposed the sample size allocation per school and guidelines for randomly selecting 500,000 Grade 10 learners who will take the NAT.

## UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

For the second half of 2023, ACTRP intends to complete the Grade 6 BARMM assessment analysis and reporting, as well as the two assessment frameworks for ALS Microcertification. Work on the SHS curriculum framework will commence in August. ACTRP also plans to convene its Advisory Board in September for direction-setting and exploration of research opportunities to strengthen the mandate of the Program. Research focusing on the technology component of the program as well as mother tongue-based multilingual education are also being targeted.

## ACTIVITIES FROM JANUARY TO JUNE 2023

**CONSULTATIVE MEETINGS Data Science Working Group Meetings** 8 February, 24 March, and 3 May 2023

The Data Science Working Group serves as the Program's primary platform for convening experts across disciplines in discussing initiatives and efforts in the field of Data Science across CUs. Members of the Working Group include data scientists and faculty members from various departments of UP Diliman, UP Manila, UP Los Baños, UP Visayas, and UP Mindanao. The Working Group provided a precurricular critique of the different degree program proposals in Data Science, as well as harmonizing data science efforts during the height of COVID-19 pandemic.

One of the major accomplishments of the Data Science Working Group is providing a curricular critique to the proposed Bachelor of Science (BSc) in Data Science, which will be offered in UP Mindanao beginning AY 2023-24. This is a program proposal spearheaded by DSPPP Fellow Dr. Vladimer Kobayashi.

AD HOC PROJECT MEETING **UP Open Data Policy** 5 January and 28 February 2023

In support of the Open Government Partnership, the Program initiated projects that will lay the prospects of mirroring data of the different government agencies. The Program's Open Data Project prompted the creation of the Open Data Policy for research projects of UP Diliman. DSPPP assisted and took part in the discussions of the UP Open Data Policy Ad Hoc Committee in drafting the Implementing Rules and Regulations (IRR) of UP's Open Data Policy.

The new program offerings in Data Science, as well as the UP Open Data Policy, will be supported by the UP Data Commons, a computing facility that includes several units of high-performance computing (HPC) machines that can be utilized for research such as HPC tasks, programming applications/software, systems and web application development and deployment, data repositories and database systems development, and many others.

#### PROJECT MEETINGS Culture Data Science Project 12, 16, 19, 31 January, 17–18 February, and 11–14 March 2023

A collaboration among UPDEPPO and UP Mindanao faculty members, the project aims to look at the relevance of the pakikipagkapwa model in modern Philippine societal interactions. This project aims to understand interactions in social media platforms through scraped data. The project has commenced and has applied for ethics clearance before data gathering. The project meetings discussed the preparations for the writeshop of the project as well as team updates regarding the progress of team members.

The project will also come up with a discussion paper, which is being revised by the project team. Meanwhile, DSSPP Fellow Dr. Lavides is finalizing a draft policy brief.

#### WRITESHOP

Culture Data Science Project Writeshop 11-15 April 2023

The writeshop focused on finalizing the written research outputs of the Culture Data Science Project in partnership with UP DEPPO. Continuation of the Culture Data Science

The Program shall continue the data analysis and drafting of the manuscripts for the Culture Data Science Project, which will be led by DSPPP Program Research Fellows, Dr. Maria Margarita Lavides and Associate Professor Vladimer Kobayashi, together with the faculty members of UP DEPPO. A webinar is being planned to present the research findings of the project.

 Serve as a support platform for the UP Intelligent Systems Institute (UP ISI)

The Program will serve as a potential platform in operationalizing the new UP ISI stemming from the early work on convening the Data Science Working Group—and concurrently be the secretariat of the working group. DSPPP will be involved in present and future projects and plans in developing the said Institute.

### Convene the Data Science Working Group

The Program shall continue convening the Data Science Working Group, which will hold meetings across the year 2023. Precurricular discussions on new program offerings in other units shall form part of most of the discussions. Specifically, the graduate degree programs proposed by the UP Open University on Data Science, and the Digital Humanities degree proposal in UP Visayas are going to continue receiving critiques and proposed revisions from the Working Group.

 Capacity- Building Program on the Sustainable Development Goals at the Local Level

New capacity-building activities are being planned in line with the Program's research agenda. The possible capacity-building will capacitate LGUs in data-driven monitoring and evaluation (M&E), particularly of the performance of LGUs in achieving the targets and subtargets in the United Nations Sustainable Development Goals (UN SDGs). The capacity-building activity is expected to yield a training module, and several manuscripts on the experience of LGUs in monitoring SDGs.

## ACTIVITIES FROM JANUARY TO JUNE 2023

CONFERENCE End-Conference of the Business-for-Peace Project 17 February 2023

The end-conference, which was held in Cagayan de Oro City, harvested and communicated the lessons after three years of project implementation. These included the context and prospects in Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), the wishes of communities and former combatants, the issues that they face, and the scale and types of livelihood projects that worked. The conference also provided a venue for representatives of the NWMF communities to present their vision and proposals and connect with more stakeholders. A total of 46 participants composed of officials and representatives of the BARMM, private sector, nongovernment organizations, and financial institutions participated in the end-conference.

PRESENTATION OF THE DRAFT PAPER ON SECTORAL REVIEW AND VALUE-CHAIN STUDY IN THE BARMM STED Workshop of the ILO 27-28 April 2023

STED is ILO's methodology to assist partner countries in meeting the skills needs of tradable

sectors. The workshop aimed to elicit ideas on how to bridge education and training to meet the skills needs for export growth, economic diversification, and for creating more and better jobs. EMIT C4C presented its findings to trigger workshop conversations. In essence, EMIT C4C noted that in the BARMM, skills are principally linked to agri-fisheries. However, the binding constraint is not so much the lack of skills but the lack of investor interest given the persistent perception of the region being unsafe and high-risk.

## UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

For the upcoming period, EMIT C4C plans to submit for publication the GlowCorp action research report and the anonymized paper on Frameworks. The Program will also continue its study of agriculture technology projects to see how yield-enhancing, labor-saving, and timesaving initiatives could become acceptable to smallholders who tend to avoid costs and risks.

EMIT C4C will finalize the end-conference proceedings now that it was vetted by the organizers of the event. EMIT C4C will also document case studies on innovation in partnership with key programs of UP CIDS. These case studies will provide the initial write up of these start up and innovative efforts.

# ACTIVITIES FROM JANUARY TO JUNE 2023

### **ROUNDTABLE DISCUSSION**

Local Assembly and Manufacturing of Single Cylinder Engines for Agri-fisheries Machinery 23 March 2023

Led by researchers from the UP Los Baños-Center for Agri-fisheries and Biosystems Mechanization (BIOMECH), this roundtable discussion focused on the challenges to and prospects for local agri-fisheries manufacturing. The activity involved representatives from government agencies such as the Department of Agriculture (DA), Department of Trade and Industry (DTI), and Department of Science and Technology (DOST), as well as industry groups such as the Agricultural Machinery Manufacturers and Distributors Association, and Philippine Metalcasting Association.

As an offshoot of the RTD, BIOMECH is working on a policy brief on single-cylinder engines to power small farm machines and marine vessels for use of small producers and operators. With PEP and domestic manufacturers, it is also working on a position paper to be submitted to President and DA Secretary Ferdinand Marcos Jr., calling for support for the manufacture of these engines and procurement by the government of machineries powered by these engines.

### **ROUNDTABLE DISCUSSION**

Meeting with the Regional Executive Committee of the Consortium for Southeast Asian Studies in Asia (SEASIA) for the 2024 SEASIA Conference 22 June 2023

On 22 June 2023, the UP Conference Committee met with the regional SEASIA Executive Committee to discuss the proposed theme, program, logistics, and preparations for the conference. This committee is composed of members from the Kyoto University's Center for Southeast Asian Studies, Academia Sinica (Taiwan), the National Research and Innovation Agency or BRIN (Indonesia), and the Asian Center of UP Diliman.

### MEETING

Meeting with the Office of Sen. Juan Edgardo Angara (OSJEA) on the *Tatak Pinoy* Program

As a follow-through to the UP Diliman Governance Agenda for a Sustainable and Inclusive Development released in 2022, the OSJEA initiated discussions with the PEP on

ways to better incorporate recommendations on (1) industrial policy, and (2) economic recovery and transformation into its *Tatak Pinoy* Program. In turn, PEP provided recommendations focusing on (1) promoting and strengthening MSME manufacturing, (2) human capital development; (3) enhancing the productivity and efficiency of local firms, and (4) promoting an innovation-driven industrial policy. The OSJEA is currently holding consultations with various stakeholders to gather further comments on the finalization of the *Tatak Pinoy* bill, with PEP still participating in the process.

### UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

For July to December 2023, PEP will be continuing its research projects on developing local agri-fisheries machinery, as well as micro, small, and medium-sized enterprises (MSMEs). Further, the Program will be undertaking a project on inclusive and sustainable science and technology.

The PEP will also be continuing its collaboration with the UP Diliman Asian Center in preparing for the SEASIA Conference in July 2024, as well as its work with industry groups in the shipbuilding industry to develop a prototype for a hybrid engine for small marine vessels. Lastly, the Program will continue its engagements with the Office of Senator Angara as it finalizes the Senate Bill on the *Tatak Pinoy* Program.

### **ACTIVITIES**

In connection with the upcoming research project on inclusive and sustainable science and technology, PEP will have a roundtable discussion on the subject to be led by former DOST Secretary Fortunato de la Peña.

The activity aims to gather inputs from experts and practitioners on the developments, existing programs, and remaining challenges in the sector.



With the theme, *De/Centering Southeast Asia: Agency and Knowledge Production in Southeast Asian Studies*, UP Diliman will be hosting the biennial SEASIA Conference in July 2024. The University follows in the footsteps of premier academic and research institutions in the region that served as conference hosts in previous years.

Their participation served as the representation of both AltDev and the Movement for Alternatives and Solidarities in Southeast Asia (MASSA). By engaging in these meetings, AltDev aims to strengthen its ties with alternative development practitioners from various regions worldwide, going beyond the boundaries of Southeast Asia.

### FACE-TO-FACE WORKSHOPS

Workshop with Informal Vendors on Post-Pandemic Recovery and Urban Rights of the Urban Poor 7, 8, 15, and 21 January 2023

AltDev Junior Research Analyst Rafael Dimalanta facilitated workshops with grassroots organizations, such as PISTON, Kadamay, Metro Manila Vendors Alliance (MMVA), Pinagkaisang Lakas ng Mamamayan (PLM), and Kariton Coalition. These workshops provided valuable insights into the experiences of small-capacity informal transport workers, informal settlers, informal vendors, and the homeless or street dwellers during the pandemic. The knowledge gained from these engagements was utilized to develop a policy brief on pandemic recovery and urban rights, specifically focused on the needs and rights of the urban poor sector. Through these efforts, AltDev aims to forward inclusive policy insights that can address the challenges faced by marginalized communities in urban areas during times of crisis.

#### HYBRID WORKSHOP

Vikalp Sangam and People-to-People (P2P) Exchange

11 January 2023

MASSA and Vikalp Sangam (VS), in collaboration with GTA and the 11.11.11 Coalition Flemish North-South Movement, of the successfully organized the Second P<sub>2</sub>P Exchange. This event adopted a hybrid format to accommodate participants from diverse regions. The P2P's primary goal was to foster the expansion of networks comprising various alternative initiatives, laying the foundation for future solidarity-building and cross-regional collaborations. AltDev staff played a crucial role in facilitating this activity, ensuring meaningful engagement and knowledge exchange among participants. This exchange represents a significant step towards strengthening alternative movements and promoting global cooperation.

PADATA, an indigenous people's (Lumad) organization based in Bukidnon, sought to map out their historical journey and identify the persistent challenges they face. The workshops enabled PADATA to share their stories, knowledge, and experiences. Meanwhile, AltDev contributed by facilitating the participatory process and learning from the community. This is part of the program's efforts in documenting and actively participating in various alternative practices of grassroots organizations.

#### **ONLINE MEETINGS**

Round Table Discussion on the MASSA and AltDev

17 and 27 February 2023

As the interim secretariat of MASSA, a network of grassroots organizations engaging in various alternatives across the Southeast Asia region, AltDev participated in a roundtable discussion with GTA to discuss MASSA's work. This is part of collaborative research to document the networks that are part of GTA: the other being networks from South Asia (VS) and Latin America (Crianza Mutua México and Crianza Mutua Colombia).

### FACE-TO-FACE FIELDWORK

AltDev actively participated in the transport strike from 6–7 March 2023, aligning with its objective of capturing narratives and firsthand experiences from the ground. AltDev Project Leader Mon Sy guided participants in applying an alternative and intersectional approach in their advocacy work. # UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

Since 2017, AltDev has pursued its aims along three contiguous albeit distinct program thrusts: documentation of alternative practices; building linkages, partnerships, and solidarity; and strengthening exchanges between grassroots organizations.

Beyond being a program of a university policy research center, AltDev has repositioned both as a repository of research and case studies of alternative practices, and a platform for the exchange of stories, experiences, and sustainable practices of marginalized communities in Southeast Asia. Despite the COVID-19 pandemic that drastically affected peoples' lives including their physical mobility, AltDev initiated cross-border interactions through online or hybrid platforms. This way, the connections would be maintained and the call for alternative regionalism is bolstered. These interactions also span beyond the Southeast Asian region through the GTA AltDev's commitment for alternatives and direct connections with communities and social movements has somehow led to partnership with other academic institutions for future research collaboration. In 2022, AltDev was welcomed as a new partner of the Governance in Conflict Network, which is being coordinated by the University of Ghent Conflict Research Group. This year, the London School of Economics (LSE) Center for Public Authority and International Development (CPAID) has invited AltDev as a project co-investigator for Southeast Asia. AltDev will bring in the collective knowledge from and about Southeast Asia generated from its many years of research and network building.

### ACTIVITIES

Further Documentation of Case Studies and Co-Production of Extensive Policy Proposals

With the orientation of engaging new people's alternatives into the network, AltDev aims to substantially document and coproduce case studies that are emblematic of the systemic faults in the current model of regionalism for the third volume of its Monograph on Alternatives series. Out of the documented case studies, AltDev aims to co-construct policy-oriented solutions and concrete actions of solidarity among partner organizations.

Expanding Linkages and Participation in Regional and Global Gatherings

With the continuing support from the 11.11.11 Coalition of the Flemish North-South Movement and the emerging GTA, AltDev looks forward to meaningful exchanges with alternative development networks and practitioners from Latin America, North America, Europe and Africa in the upcoming first physical GTA Assembly in Kenya. Moreover, AltDev's continuing commitment in the ASEAN Civil Society Conference remains a constant platform for raising intersectionalities with regional and transnational networks calling for ASEAN response to the challenges affecting the region, highlighted by the ongoing repression in Burma/ Myanmar under the Burmese military junta.

Reconsolidation of the MASSA and Fourth Regional Conference on Alternatives

In preparation for the Fourth Regional Conference on Alternatives in 2023, the MASSA Steering Committee aims to strengthen collective leadership and promote collaborative actions that demonstrate MASSA's alternative regional model. AltDev, serving as the committee's Secretariat, will facilitate the consolidation process and preparatory meetings. The upcoming conference will serve as the committee's significant project, aligning with the goal of establishing a regional network of Alternatives in Southeast Asia.

# ACTIVITIES FROM JANUARY TO JUNE 2023

### ONLINE MEETING WITH STAKEHOLDERS

Presentation of Year 3 Report to the Department of Health (DOH) and Philippine Council for Health Research and Development (PCHRD)

24 January 2023

Dr. Antonio Dans presented the PPCS Terminal Report to DOH and the PCHRD officials. Preliminary results of the surveys that were done for years 1–3 were shown during the meeting. Problems encountered during the course of the study and their resolutions were discussed. The PCHRD project coordinator also talked about the administrative processes that need to be completed at the end of the study. This meeting showed the importance of the PPCS study data in contributing to the policy recommendations that will be used for Konsulta.

### FACE-TO-FACE MEETING

UP National Institutes of Health (NIH) 25th Anniversary 27 February 2023

Dr. Antonio Dans presented the PPCS Results during the 25th anniversary of the UP NIH entitled "Transforming Philippine Health Systems Towards Universal Health Care through Research Partnerships." Former Officer-in-Charge (OIC) of DOH Dr. Maria Rosario Vergeire and other DOH officials attended the said event. Other attendees were UP President Angelo Jimenez, UP Manila Chancellor Carmencita Padilla, and other UP Manila officials and faculty. The sharing of the PPCS results showed that primary care is possible with the proper mechanisms on hand.

CONVENTION Bataan Health Summit 8 March 2023

Dr. Leonila Dans, Dr. Antonio Dans, and Dr. Raffy Marfori, together with the Samal PPCS staff were invited to attend the Bataan Health Summit entitled "Bridging People through Universal Health Care (UHC) in Building a Healthier Bataan." They were invited to attend as advisors to the implementation of Bataan UHC. Bataan local government officials, as well as the different stakeholders from the health sector, attended the event. Showing support to local government units (LGUs) and giving them advice based on experience give them more courage to move forward with the Konsulta program.

### **ONLINE MEETING**

PPCS Meeting with Samal Municipal Health Officer (MHO) 16 March 2023

Dr. Leonila Dans, together with Dr. Antonio Dans and the PPCS team, met with the newly appointed Samal Municipal Health Officer Dr. Ryan Suguitan and the other RHU doctors. The agenda of the said meeting was the electronic health record (EHR) transition from the Open MRS system to the approved system for UHC implementation. Having this meeting gave the MHO more information on the EHR system to be used for Konsulta and made them more confident to use it.

#### ONLINE MEETING

PPCS Meeting with Wolters Kluwer 22 March 2023

The PPCS team, headed by Dr. Leonila Dans and Dr. Antonio Dans, had a meeting with the Wolters Kluwer team, headed by Douglas Benjamin. The teams discussed the enrollment procedure for the UpToDate App. This meeting was held in preparation for the upcoming study that is being commissioned by DOH. Other topics discussed were localization of UpToDate guidelines and updates on the process of applying for continuing medical education (CME) credits in the Professional Regulations Commission (PRC). This meeting will help facilitate the roll-out of UpToDate in DOH-identified municipalities. The roll-out of UpToDate will help improve health care, especially in remote areas in our country

### CONVENTION

Philippine College of Physicians (PCP) Convention "UHC Real World Experience in Pilot LGUs"

25 March 2023

During the PCP Convention, Dr. Antonio Dans gave a lecture showing the study results obtained from the PPCS. He described the interventions that were developed by PPCS to strengthen primary care at the three study sites (UPHS, Samal, and Bulusan). He discussed workforce development through motivation, training, continuing professional development through the use of UpToDate, and task shifting to the barangay health workers. At the end of his lecture, he shared the lessons learned from the study. Knowing all these pieces of information, the stakeholders will be more equipped to make policy recommendations.

### ONLINE MEETING

PPCS Meeting with Bulusan Officer in Charge of the RHU

29 March 2023

Dr. Antonio Dans and the PPCS team met with the Bulusan RHU Doctor and the Officer-in-Charge Ms. Arlene Ragasa. The agenda of the said meeting was the EHR transition from the Open MRS system to the approved system for UHC implementation. Having this meeting gave the MHO more information on the EHR system to be used and made them more confident to shift to the new system.

### ONLINE MEETING PPCS Meeting with DOH HPDPB 12 April 2023

Dr. Antonio Dans and Dr. Leonila Dans met with Undersecretary Beverly Ho of the DOH and the DOH Health Policy Division and Planning Bureau (HPDPB) team to discuss PPCS thoughts on financing for the next five years. They were requested to give inputs on the Health Care Financing Strategy (HCFS) that will be used for their policy planning. Dr. Dans explained how the PPCS study budget was used and what improvements were done at the three sites to be able to maximize them. This meeting will help DOH to come up with its policy recommendations for the next five years.

### ONLINE MEETING

PPCS Meeting with PhilHealth 21 April 2023

Dr. Antonio Dans had a meeting with PHIC officer Clem Bautista and her staff to present PPCS suggestions on the implementation of the Konsulta package. Suggestions on how to do the registration of the patients and what data to put in the EHR were laid out. It was also suggested to remove the unnecessary coding of data and to unify the processes of DOH and PhilHealth for a successful Konsulta program. Having this meeting will help with the roll-out of the Konsulta program and will also help with policy planning.

ONLINE MEETING PPCS Meeting with PhilHealth 8 May 2023

Dr. Antonio Dans had a meeting with PhilHealth VP Renet Limciaco to give the PPCS's suggestions for the implementation of Konsulta. PPCS results were presented, and Dr. Dans gave his recommendations based on the given study data. He gave inputs to improve the Konsulta processes and to streamline them to make it easier for the LGUs and the healthcare providers as well. **ONLINE MEETING** 

**PPCS** Meeting with Health Futures Foundations Inc.

12 May 2023

Dr. Antonio Dans had a meeting with Secretary Jimmy Galvez Tan and Director Johnny Nanagas of Health Futures Foundation Inc. The discussion centered on the cost of primary care in the Philippines. The costing data that was used as a basis of their discussion was from the PPCS results. This meeting will help with the policy recommendations that will be presented to the Senate and the House of Representatives.

**ONLINE TRAINING** 

UpToDate Club 19 January, 9 February, 2 and 16 March, 13 and 27 April, 11 and 25 May, and 15 June 2023

Josephine Sanchez facilitated the UpToDate Club, which was held at least once a month. At the start of the second quarter of 2023, it was done twice a month since more barangay health workers were attending the training. The following topics were discussed from January to June: scabies, leptospirosis, otitis media, tinnitus, heat stroke, rubella, poliomyelitis, angioedema, and urinary tract infection (UTI) in adults. At the end of the lecture, Dr. Antonio Dans and Dr. Leonila Dans gave their feedback and recommendations. These training sessions will help the healthcare workers to be better equipped in handling illnesses at their respective barangays.

## UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

The PPCS officially ended at the three study sites last 15 December 2022. A cleanup of the data obtained from the three-year study was done and is being analyzed. PPCS has a lot of data on hand and we are currently in the planning stage of writing the papers. Meetings with possible writers to discuss the outline of the papers are to be calendared in the next six months. The planned papers for writeup this year are:

- 1.) "Patients Satisfaction Years 2 and 3";
- 2.) "Electronic Medical Records Satisfaction Years 1, 2, and 3";
- 3.) "Utilization Paper for Years 2 and 3";
- 4.) "Healthcare Worker Satisfaction for Years 2 and 3"; and
- 5.) "Public-Private Partnership"

Other plans include post hoc analyses/studies, annual surveys in pilot sites to assess the Konsulta program of DOH (still looking for funding), support of EHR transition in UP Health Service and to continue the PPCS website development.

### ACTIVITIES

- The Program will continue to conduct 1.) monthly primary care training among health-care workers through the UpToDate Club. PHSD will continue to support the manpower/workforce development of the rural and remote sites. The Program is also planning to expand the reach of the UpToDate club to the other municipalities that were given access to UpToDate by DOH. Volunteer health-care workers from each barangay in Samal and Bulusan will be encouraged to discuss the topics (illnesses) that they have encountered in the barangay health stations in the past few months. After these discussions, a guest doctor will give their recommendations on each topic.
- 2. PHSD will provide continuous support to the primary care clinics at the three sites through telephone correspondence and online meetings. The Program will continue to give technical assistance to the transition of the electronic medical records once DOH finalizes the program that will be used for E-Konsulta. PHSD will also continue the PPCS website development so that many policymakers will be able to see the study's results, which they can use for policy development.
- 3. The Program plans to conduct two studies this year. Preparations are



project of UP CIDS, the Department of the Interior and Local Government–National Capital Region (DILG–NCR), and the Office of the Quezon City Mayor. The collaboration produced a report entitled "Federalism and the National Capital Region: Specific Governance Concerns," which ran from 2018 to 2019. The various outputs were then compiled, reviewed, and revised into a book manuscript. The book was released online and in print in March and April 2023 respectively.

BOOK MANUSCRIPTS FOR PUBLICATION THROUGH UP PRESS

UP CIDS Interdisciplinary Development Perspectives on Public Policy (InDePPP) Reference Book Series

In light of the ever-growing interest in public policy studies, articles from UP CIDS's former journal, *Public Policy*, were selected into planned book volumes that would further contribute to the discourse of public policy. These volumes can be used as supplementary readings for courses in political science.

The first volume is *Public Policy and Statistics*, edited by Francis A. Dee. The book aims to

provide an overview of research on how statistics can be used effectively for public policy decisions as well as for monitoring changes over time within different contexts such as health care or education systems among others. The second volume is Public Policy and Exploring Feminist Research and Gender Studies, edited by Professor Jean Encinas-Franco. It focuses on issues related to gender inequality in society while providing insights into how feminist research can inform effective public policies aimed at addressing these disparities through various methods, including data collection techniques like surveys or interviews with stakeholders involved in decision-making processes amongst other strategies. Finally, Associate Professor Dennis V. Blanco's edited volume, Public Policy and Philippine National and Local Administration: Concerns Challenges and Capacities from Governing to Governance, explores topics relevant to Filipino governance structures from both top-down perspectives (national) but also bottom-up approaches (local).

#### PUBLICATION

Policy Studies for Political and Administrative Research (PSPAR) Discussion Series Publication

January–June 2023

The Policy Studies for Political and Administrative Reform (PSPAR) research project produced five discussion papers that were published during the first half of 2023. The articles focused on Philippine politics and administration, barriers preventing Filipino women from participating in the election, the Philippine judiciary, decentralization and local governance, the party system, and compliance with the United Nations Sustainable Development Goals. These papers aimed to inform policy reforms in the country. Detailed topics are as follows:

Professor Encinas-Franco and Associate Professor Elma Laguna's discussion paper, *Barriers to Filipino Women's Political Participation* (published on 19 January 2023), is an in-depth look at the various obstacles that prevent women from participating in the political process. The authors analyzed different aspects of Filipino culture, such as gender roles and stereotypes that hinder female representation. They also discussed current policies related to women's rights, as well as potential solutions for increasing participation among females in politics. Prof. Atienza's discussion paper, *The Philippine Judiciary: Strengthening the Third Branch of Government* (published on 10 March 2023), takes a closer look at several issues related to the Philippine judiciary: the changing nature of the structure and power in the judiciary as specified by the 1987 Constitution; the administration and delivery of justice; people's access to the courts; positive and negative perceptions of the judiciary and justice issues; judicial independence; and the manner of appointments. The focus is on the changing role of the judiciary in Philippine politics and reforms to strengthen it.

The third discussion paper is Professor Atienza and Associate Professor Jan Robert R. Go's Assessing Local Governance and Autonomy in the Philippines: Three Decades of 1991 Local Government Code (published on 13 March 2023). This policy study looks at the issues and concerns decentralization, democratization, of and development vis-à-vis local governments in the Philippines. It assesses the different suggested changes or reforms in central-local relations and local governments, including proposed amendments to the Local Government Code and the 1987 Constitution.

The fourth discussion paper is Professor Tigno's *The Party Is Dead! Long Live the Party! Reforming The Party System in the Philippines* (published on 13 March 2023). It suggests reforming party system dynamics currently present today by proposing changes in legislative elections and campaign finance proposals. It also investigates voting behavior and electoral campaigns conducted during election seasons and its impacts on Filipinos.

Finally, Dr. Maria Lourdes G. Rebullida and Assistant Professor Matthew Manuelito Miranda's *Sustaining and Enhancing Monitoring*  of Development Goals: Policy Coherence and Multi-Level Governance in Philippine Bureaucracy (published on 23 March 2023) looks into what needs to be done to ensure that the development goals set forth are met accordingly over time through using multilevel governance structures implemented throughout the Philippine bureaucracy.



democratic process regardless of the outcome. What is voter education? Voter education means providing citizens with the relevant information about elections. This includes information on the mechanics of the electoral process, who can participate, and how qualified citizens can exercise their right to ete. Voter education provides information about elective positions that need to be filled up in the different levels and branches of government (e.g., local and national, as well as executive and legislative bodies), including the responsibilities, duties, and powers with voter education initiatives. Firstly, it underscores the benefits of having a sustained and effective voter education program that can give rise to an informed and intelligent electorate. Secondly, it provides an overview description of selected voter education initiatives in the Philippines. Lastly, citing a few best practices in other countries, it discusses some steps that can be taken towards institutionalizing an effective voter education campaign.

The Benefits of Voter Education

Voter education offers a psychological and political advantage to the electorate. With the information they provide, effective voter education programs can raise the confidence



## UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

PSPC plans to host a webinar that aims to present the research findings of the experts involved in the PSPAR research project with various sectors of society. PSPC also plans a book launch or other promotional activities related to the book entitled A Better Metro Manila? Towards Responsible Local Governance, Decentralization and Equitable Development in the Philippines. Finally, a State of the Nation Address (SONA) 2023 roundtable discussion is set on 17 July 2023. The discussion aims to engage stakeholders and policy experts, civil society organization representatives, and other stakeholders to discuss current issues surrounding President Ferdinand Marcos Jr/s upcoming State of the Nation Address (SONA) this July 2023.

In terms of publications, PSPC plans to release several publications from several projects. These

are (1) a series of Policy Briefs on Constitutional Performance Assessment of the 1987 Philippine Constitution from the International IDEA research projects; and (2) the proceedings of two PSPCorganized #PILIPiLUNAS2022 webinars. The Program will also plan the PSPAR book project that will include the research outputs of the PSPAR project as chapters and submit the draft manuscript to an international publisher. Apart from these, PSPC is also finishing the research project commissioned by the National Research Council of the Philippines (NRCP), focusing on the latter's research and policy outputs. NRCP plans to publish the findings of the project. All these publication projects aim to provide readers with a comprehensive understanding of different social and political issues in the Philippines and possible policy options.

Lastly, podcasts are another medium where PSPC disseminates valuable information among larger public audiences, especially those who access information through audio broadcasts and are unable to attend live events like seminars and conferences. The Program will continue producing *Ugnayang Migrante*, a podcast series that focuses on exploring stories of Filipino migrant workers. PSPC's webinars and roundtable discussions will also be converted into podcasts.

### ACTIVITIES

 "Reality Versus Expectation: BBM's 2023 SONA"

The roundtable discussion "Reality Versus Expectation: BBM's 2023 SONA" tackles the first year of the current administration, providing a platform for experts, analysts, and citizens to critically evaluate the government's performance. As the administration completes its initial year in power, it becomes crucial to assess whether it has lived up to the expectations set during its campaign and inauguration.



ISP Team Meeting via Zoom and in the Office of the Dean, Institute of Islamic Studies, Virata Hall, UP Diliman

January 20, 2023

ISP conducted a meeting to discuss the progress of 2022 project outputs and plan activities

1083 for barangay captains. The importance of identifying the impacts of these projects on UP constituent units and public policy was also emphasized in preparation for the ISP reports.

#### MEETING

Orientation Meeting with Project Partners of the Cesar Adib Majul Book Project Phase 2 and Policy Paper Collection 4 July 2023

On 4 July 2023, a project briefing was conducted HyFlex, with Project Leader Nefertari Arsad and writers meeting face-to-face in Zamboanga City, and ISP Convenor Asst. Prof. Absari, ISP project staff, and other writers joining online.

The meeting enabled project participants to level off with regard to pertinent project information and expected outputs. One project writer submitted a Policy Brief in July 2023 for initial review, while one Policy Insight is pending submission in the same month after clarifications on paper guidelines have been completed.

Indicating best practice, the project built networks and expanded linkages with various stakeholders from the Bangsamoro Autonomous Region of Muslim Mindanao (BARMM) and the Zamboanga-Basilan-Sulu-Tawi-Tawi (ZAMBASULTA) area. These networks enabled them to contribute insights grounded in lived realities of the Muslims in Mindanao. What was found challenging, however, was the coordination of schedules given the HyFlex nature of meetings and the different places of residence and work of participants.

# COLLECTION OF JAWI MANUSCRIPTS Jawi Studies

The ISP team accessed a (digitized) Jawi manuscript at the Princeton University Library through Ms. Anne Christine Ensomo, who is writing her PhD dissertation on Sulu spirituality at Frankfurt University in Germany. The said manuscript was taken from Sulu by Major Hugh L. Scott, who became American Military Governor of Sulu in 1903. The manuscript is Sayr al-sālikīn ilá 'ibādat rabb al-'ālamīn ( ريس ) Journey of ; نيملاعلا بر قدابع علا نيكاسلا the Travelers to the Worship of the Lord of the Universe) by 'Abd al-Samad al-Falimbānī. It is a translation of the fourth volume of Imam Al-Ghazali's (c. 1058–1111) Ihya' Ulum al-Din (Revival of Religious Sciences). It was the last book he wrote.

The 552-page manuscript was heavily damaged by water, but the source, which is the Ihya, is available online. The ISP team was also lucky to have accessed the English translation from Arabic of the particular section of the book. Imam Al-Ghazali was a renowned theologian and mystic. He was given the title "Proof of Islam" for his immense contribution to both Islam and the West. The book outlines the various hurdles on the path to God that one will encounter and how these obstacles will be overcome.

Another important document found by the ISP team through a network of friends in Sulu is the Sirajud Deen (Lamp of Religion), written by Ustadz Yahya Radjae in 1949. The centuries of war against colonialism resulted in the decline of Sulu's political, economic, and educational systems. The beginning of the revival of madrasah (Islamic) education in Sulu is attributed to the missionary work of Ustadz, who studied Islam at Madrasah Junaydi in Singapore. Upon his return, he established his own school and trained students to teach Islam. Later, he sent his students to various islands of Sulu, Basilan, and Tawi-Tawi to teach. His book fills the gap in Islam's intellectual tradition in postcolonialism before the influence of Salafism (strict orthodoxy), which began in the early 1980s.

The capacity-building of Philippine Muslim history teachers, as well as the CMPL education campaign at the grassroots level in Basilan, Sulu, and Tawi-Tawi, will take place in the fourth quarter of 2023. The capacitybuilding will map out the appropriate content, methodology, and strategies for teaching Philippine Muslim History (PMH). The CMPL education campaign aims to increase Muslims' awareness of *Sharī* ah (Islamic Law), its accessibility, and its significance in the lives of modern Muslims. Barangay captains and other selected barangay officials will be involved in this education effort.



### UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

SSP will continue to advocate for and generate interest in significant shifts and developments in Philippine foreign policy and strategic studies. In the last six months, the Program has commenced and worked on projects that it deems adequate in contributing to ongoing discussions and debates in the field of security and strategic studies. SSP aims to keep and even accelerate the momentum in staying relevant by closely monitoring international and regional developments, and investigating their implications on the country's foreign and security policies and strategic posture. Consistent thereto, SSP's projects include research, podcasts, and other informationsharing and dissemination activities. In addition to serving the strategic studies community, SSP endeavors to reach a broader audience, including young professionals, and expand its networks both locally and internationally. By extending its influence on diverse age groups and geographic regions, SSP will stay relevant and effectively disseminate knowledge in this domain.

The plans and tasks mentioned previously shall then be maintained. The *Katipunan Dialogue Podcast* remains SSP's flagship program. The project is now in its third year and will feature six new episodes, particularly on the following topics: the European Union Indo-Pacific Strategy, Korea's Indo-Pacific policy, the ASEAN outlook in the Indo-Pacific, the Japan Free and Open Indo-Pacific Vision, issues and trends in regional maritime security, and the one-China policy. SSP has already recorded three episodes and will record three more in the coming months. Meanwhile, the relaunch of the podcast is set for this July. From then on, SSP targets to release two episodes per month on top of promoting the previous episodes from the last two years with the help of CIDS and Konrad-Adenauer-Stiftung (KAS) Philippines.

On top of the podcast, another principal task for this year is to work on the unfinished and planned publications of SSP. The Program has deliverables from last year that must be finished, particularly the proceedings for the Katipunan Dialogue Podcast 2022 Series and the policy brief, "Foreign Policy Directions for the New Administration." The Program shall prioritize the release of these papers because they remain timely to developments in the country's foreign and external relations and policies. The Program has likewise hired two UP faculty as research fellows and one paper writer from outside the university to write about systemic risks in the region, gray zone operations in the South China Sea, and the bilateral relations between China and the Philippines in the context of settling territorial disputes. These three topics are very relevant especially as external security issues continue to grow and gain attention in Philippine policymaking under the Marcos administration.

### ACTIVITIES

- 1.) Katipunan Dialogue Podcast 2022 series proceedings. The proceedings for the 2022 Katipunan Dialogue Podcast will be released this year. It will include 12 episodes released last year. The draft has been submitted for review and editing by the convenor and will be submitted for publication in the coming months.
- Foreign Policy Directions for the 2.) Marcos Administration: Analysis and **Projections**. This white paper/policy brief aims to evaluate present patterns and changes in the regional strategic landscape, encompassing aspects like economic integration, diplomacy, and regional security. It seeks to examine the implications of these developments on the strategic posture of the Philippines under the Marcos administration. The document will offer recommendations to aid the new administration in assessing its strategic choices for the upcoming years and enhancing its capacity for future strategic analysis concerning Philippine foreign policy. SSP intends to produce

the white paper during the latter half of 2023.

- Katipunan Dialogue Podcast 2023 3.) series. The Katipunan Dialogue **Podcast** series builds on the legacy of its predecessor, the annual Katipunan Conference. It discusses issues and trends in the international and regional environment as well as its impacts on the country's strategic posture and its foreign policy. The 2023 series presents six new episodes featuring academics experts from various fields. and The episodes tackle traditional and nontraditional security issues, including the Indo-Pacific strategies of key players in the region, regional maritime security, diplomacy, minilateralism multilateralism, and and security cooperation. The official relaunch is planned for this July. Episodes will be made available on Spotify, Anchor FM, and Google Podcasts. Proceedings will also be produced after the conclusion of the podcast.
- Roundtable Discussion (RTD) on 4.) Strategic Philippine Foreign Policy in the Marcos Administration in the West Philippine Sea Dispute. An RTD will be conducted within the year in partnership with SSP networks to discuss issues of foreign policy and external security, especially in relation to the West Philippine Sea conflict. Experts and academics will be invited to discuss and exchange ideas on how best to approach prevailing issues and challenges and how best to approach the development of possible policy approaches for the country's decisionmakers.
- 5.) "Systemic Risks from A Regionalist Perspective" discussion paper. This discussion paper discusses one of the dominant pressures besetting multilateral governance today: systemic risks. The transboundary nature of systemic risk means that it is susceptible to the territorial politics of risk management. Systemic risks, thus, both widen and constrain the space for rising powers keen to assert their authority and define the extent of their accountability

in global and regional platforms. The proposed policy paper will examine how systemic risk has shaped ASEAN's approach toward multilateral governance and the challenges it poses for East Asian regional cooperation.

- 6.) "Philippines-China Bilateralism on the South China Sea Disputes" (Discussion Paper) -The paper evolution investigates the of Philippines-China bilateralism on the South China Sea disputes since the Mischief Reef incident in 1995. There is evidence suggesting that the degree of institutionalization of bilateral diplomatic mechanisms influences the likelihood of success in reducing tensions between parties in a conflict. Insofar as this effect holds true, the Philippines may be well advised to pursue denser relations with China to handle the South China Sea disputes. Lessons can also be learned from the Philippines' experience with bilateralism to guide relations with China moving forward.
- "Europe's Evolving Engagement in 7.) Asia" policy brief. The paper examines Europe's expanding cooperation and evolving engagement in the Indo-Pacific and asks the following questions: (1) Why is Europe deepening its relations with Indo-Pacific states? (2) How can the European Union and European states contribute to the emerging dynamics in the Indo-Pacific? (3) What are the strengths and limitations of Europe's involvement strategies in the Indo-Pacific? (4) What are the perceived implications of Europe's increased involvement in the Indo-Pacific?

# UPCOMING ACTIVITIES AND OUTPUTS FOR JULY TO DECEMBER 2023

For the last six months of 2023, DSP will focus on decolonizing legal studies and policy in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), decolonial research approaches, and further exploration into decolonial perspectives in language studies. DSP has decided to dedicate time and resources to aim for a Philippine legislative government arm that is sensitive to indigenous issues and is more knowledgeable about decolonial theory and practice in policymaking. DSP shall also hold seminars and collaborate with other institutions in events concerning minorities and identity representation in digital archives, as well as the use of "affect" in English language studies as an analytical category within a decolonizing perspective.

To fulfill these major directives and goals for the second half of the year, DSP currently plans to hold four major activities to facilitate these goals: two roundtable discussions on decolonizing policymaking and legal studies; another roundtable exploring decolonial approaches in English studies; and a seminar-workshop on digital research on humanities and identities.



### ACTIVITIES

 Roundtable Discussion on Decolonizing Policymaking Proponent, led by Dr. Nassef Manabilang Adiong.

> This roundtable discussion aims to identify the colonial structures still present in policy research and leaislation. Some details alreadv discussed in the previous "Decolonial Approaches to Legislation" seminarworkshop may be mentioned in this roundtable discussion as well, namely the lack of representation of the people being governed, the lack of participation of the common folk, the influence of foreign legal systems despite its incongruence with the local people, etc. After, how one can dismantle these colonial structures shall be discussed.

 Roundtable Discussion on Decolonizing Legal Studies Proponent, led by Dr. Nassef Manabilang Adiong.

> This roundtable discussion aims to identify the colonial structures still present in the fields of legal studies. Some topics already discussed in the previous "Decolonial Approaches to Legislation" seminar-workshop may be mentioned in this roundtable discussion as well. These topics include developing critical thinking according to the lens of decoloniality; identifying the aspects of the law that do not apply to the local, the thinkers and authors that are cited and studied, the origins of the teachers and students; and others. After, how one can dismantle these colonial structures shall also be discussed.

3. Seminar on Identities and Digital Humanities Research Proponent, led by Assistant Professor Frances Antoinette Cruz.

> A two-day workshop split over two weeks aims to introduce researchers to computer-aided research in digitized archives, with a special focus on minority identities in the Philippines. Attendees will first learn about developments in the digital humanities and corpusassisted discourse studies before using digital archives, repositories, and openaccess tools to explore various minority

identities in the Philippines. Individuals and/or groups will then present their research and talk about the implications of minority representation on social dynamics, policy, and their vision of community in the Philippines and beyond.

4. Decolonizing English Studies Through Affect: Challenges and Possibilities Proponent, led by Dr. Aileen Salonga

> Studies of English in the country have mostly focused on English language teaching and learning with the goal of turning learners into good speakers of English, the spread and use of English in the Philippines from a World Englishes paradigm, and a discourse and stylistic approach to the study of texts written in English. While there is a body of critical work that challenges the notion of "English" and "English Studies" as deployed in mainstream work and proposes alternative ways of studying English, the use of "affect" as an analytical category within a

decolonizing perspective has not been explored. This project aims to respond to this gap by demonstrating the usefulness and relevance of affect in making sense of interrogating and refiguring English Studies. This specifically considers the burden and trauma of the country's colonial past and neocolonial present, the complexities and promise of a diverse multilingual reality, continuing linguistic and social inequalities, and a strong Western bias in knowledge production and consumption. The project hopes to foreground three possible areas of affective inquiry in a roundtable discussion: (1) the learners' lived realities of English vis-à-vis other languages in the Philippines; (2) the anxiety surrounding English; and (3) methodological challenges in the study of affect and English.






# WEBSITE AND SOCIAL MEDIA

#### WEBSITE

As part of its mandate to disseminate the activities and publications of UP CIDS programs, the UP CIDS website was relaunched in April 2022. Since then, it has featured several upgrades and new features, many of which were implemented between January 2023 and June 2023, including:

- Fresh, cleaner home page, which foregrounds the links to the UP CIDS database, while the slideshows therein showcase the Programs' different outputs, such as podcasts. The home page also invites stakeholders to subscribe to the mailing list.
- Cleaner layout for the Program pages, which highlight the publications and the research staff, not just the Convenors and Co-convenors
- Uploading of pre-2018 UP CIDS Publications
- Updated layout of Collection Database
- Links to the UP CIDS podcasts
- Provisional catalog
- Improved footer, news, and webinar pages
- Link to UP CIDS Mailing list
- · List of core staff and other edits





Updated Layout of the Collections Database

Occasionally, UP CIDS has featured the compilation of its publications according to theme, such as labor, which came out on Labor Day 2023. Apart from posting announcements from the Programs, UP CIDS has also created a write-up summarizing the findings of the book, A Better Metro Manila: Towards Responsible Local Governance, Decentralization, and Equitable Development? This is an attempt to disseminate the policy insights that are otherwise inaccessible due to the book's rather expensive cost.

UP CIDS has also created a page that contains compilations of its various publications according to theme or topic. To advance interdisciplinarity and promote thinking beyond particular disciplines, the UP CIDS website has some publications appearing in multiple categories or compilations.

Most of these compilations feature UP CIDS publications published before 2017, but they are being uploaded to the Collection Database that includes publications after 2017. The compilations currently point to Google Drive folders, but those whose publications have been uploaded to the Collections Database should be recreated so that the titles link not to Google Drive folders but to a page in the website. This way, the number of downloads can be tracked.




